Supreme Court Seeks Response on Plea for Biometric Verification in Elections

New Delhi: The Supreme Court of India has issued notices to the Election Commission of India, the Centre, and various state governments on a Public Interest Litigation (PIL) seeking the implementation of biometric identification systems at polling stations.



indicating the significance of the issue in ensuring free and fair elections.

The petition calls for the use of fingerprint and iris-based verification to curb electoral malpractices such as duplicate voting, impersonation, and ghost voting. The plea argues that integrating biometric authentication could enhance transparency and strengthen the integrity of the electoral process.

Legal experts note that while biometric systems could improve voter verification, the proposal may also raise important considerations around data privacy, infrastructure readiness, and implementation feasibility across diverse regions of the country.

Taking cognizance of the matter, the apex court has asked the concerned authorities to respond,

National Cadet Corps Launches Nationwide Cyber Security Capacity Building Programme for Cadets

New Delhi: In a major step towards empowering cadets with structured training in cyber awareness, digital hygiene and practical cyber defence skills, National Cadet Corps (NCC), in collaboration with the National Institute of Electronics and Information Technology (NIELIT) has launched a comprehensive Cyber Security Capacity Building Programme. A Memorandum of Understanding (MoU) has been signed between NCC and NIELIT in the presence of DG NCC, Lt Gen Virendra Vats and DG NIELIT, Dr Madan Mohan Tripathi.

enrolled NCC cadets across the country and will be delivered through the NIELIT Digital University platform.

The second stage, Cyber Defender Programme, is an intensive 60-hour offline training designed for selected cadets who qualify through a merit-based screening process. This stage will focus on hands-on training, real-life simulations, and practical exposure to cyber security tools and techniques, enabling cadets to identify and respond to cyber threats effectively.

The programme will be implemented in two stages. The first stage, Cyber Security Awareness Programme, is a 15-hour online training module designed to provide foundational knowledge of digital literacy, safe internet practices, cyber hygiene, and awareness of cyber threats. This stage will be open to all

The initiative aims to create a pool of trained NCC Cyber Cadets who can contribute to spreading cyber awareness, promoting safe digital practices, and supporting cyber security initiatives at the grassroots level. The programme also seeks to align with national priorities under Digital India and the National Skills Qualification Framework (NSQF).

Foreign Secretary Vikram Misri visits Paris and Berlin from 12th April

New Delhi: Foreign Secretary Vikram Misri will be on an official visit to Paris and Berlin from 12th April to 14th April. In Paris, the Foreign Secretary will co-chair the India-France Foreign Office Consultations along with the Secretary General of the French Ministry of Foreign Affairs, Martin Briens. The discussions will be held on a wide range of issues, including defence, space, cyber and digital, AI, innovation, and initiatives fostering people-to-people exchanges and cultural ties. The External Affairs Ministry said that the latest global and regional developments will also be discussed.

In Berlin, the Foreign Secretary will co-chair the India-Germany Foreign Office Consultations with State Secretary of the German Foreign Office, Dr Géza Andreas von Geyr. The discussions would cover diverse domains of bilateral co-operation, including trade and investments, defence and security, technology, green energy, and education, as well as global and regional matters of mutual interest. The Foreign Secretary is also expected to meet other dignitaries and senior government officials in both places. The visit will provide an opportunity to review the full spectrum of the country's bilateral relations with France and Germany and advance ongoing cooperation across key priority areas.

PM to visit Uttarakhand and UP on 14 April

New Delhi: Prime Minister Shri Narendra Modi, will visit Uttarakhand and Uttar Pradesh on 14 April 2026. At around 11:15 AM, the Prime Minister will visit Saharanpur in Uttar Pradesh to undertake a review of the Wildlife Corridor on the elevated section of the Delhi-Dehradun Economic Corridor. At around 11:40 AM, the Prime Minister will perform Darshan and Pooja at Jai Maa Daat Kali Temple near Dehradun. Thereafter, at around 12:30 PM, Prime Minister will inaugurate the Delhi-Dehradun Economic Corridor at a public function in Dehradun and will also address the gathering on the occasion. The 213 km long six-lane access-controlled Delhi-Dehradun Economic

Corridor has been developed at a cost of over ₹12,000 crore. The corridor traverses through the states of Delhi, Uttar Pradesh and Uttarakhand, and will reduce travel time between Delhi and Dehradun from over six hours at present to around two and a half hours.

Implementation of the project also includes the construction of 10 interchanges, three Railway Over Bridges (ROBs), four major bridges and 12 wayside amenities to enable seamless high-speed connectivity. The corridor is equipped with an Advanced Traffic Management System (ATMS) to provide a safer and more efficient travel experience for commuters.

Keeping in view the



ecological sensitivity, rich biodiversity and wildlife in the region, the corridor has been designed with several features aimed at significantly reducing man-animal conflict. To ensure the free movement

of wild animals, the project incorporates several dedicated wildlife protection features. These include a 12 km long wildlife elevated corridor, which is one of the longest in Asia. The corridor

also includes eight animal passes, two elephant underpasses of 200 metres each, and a 370 metre long tunnel near the Daat Kali temple.

The Delhi-Dehradun Economic Corridor will play a pivotal role in strengthening regional economic growth by enhancing connectivity between major tourism and economic centres as well as opening new avenues for trade and development across the region. The project reflects the vision of the Prime Minister to develop next-generation infrastructure that combines high-speed connectivity with environmental sustainability and improved quality of life for citizens.

9th India Pharma Highlights Policy Push and Innovation Driving Sectoral Growth

The 9th edition of India Pharma 2026, the flagship event of the Department of Pharmaceuticals (DoP), Ministry of Chemicals & Fertilizers, Government of India, commenced today in New Delhi. Organized in collaboration with the Federation of Indian Chambers of Commerce and Industry (FICCI) and the Indian Pharmaceutical Alliance (IPA), the two-day conference (April 13-14) brings together key stakeholders from across the global pharmaceutical and healthcare ecosystem, with a strong focus on innovation, self-reliance, and global leadership.

Addressing the inaugural session virtually Union Minister of Health & Family Welfare and Chemicals & Fertilizers, J.P. Nadda, emphasized that the platform reflects both the strength and growing global relevance of India's pharmaceutical sector. He noted that while India has long been recognized as the "pharmacy of the world" due to its leadership in affordable generic medicines, the global landscape is now rapidly shifting towards biologics, biosimilars, and specialty medicines. "In this evolving environment, India is well positioned not only to adapt but to emerge as a global leader," he stated. Reaffirming the Government's

commitment to fostering innovation and strengthening research capabilities, he highlighted the recently launched Biopharma Shakti Initiative with an outlay of ₹10,000 crore, aimed at advancing capabilities in biopharmaceutical innovation under the leadership of Prime Minister Narendra Modi.

He further underscored complementary initiatives such as the PRIP scheme for promoting research in pharmaceuticals and medical technology, which seek to deepen industry-academia collaboration and accelerate the development of innovative therapies. Strengthening domestic manufacturing remains a key priority, supported by schemes like the Production Linked Incentive (PLI) schemes and the development of bulk drug parks to enhance self-reliance and resilient supply chains. He also reiterated the Government's commitment to affordable healthcare through initiatives such as the Pradhan Mantri Bharatiya Jan Aushadhi Pariyojana, which continues to expand access to quality medicines at affordable prices across the country.

He added that India Pharma 2026 provides a vital platform to foster dialogue, partnerships, and a

forward-looking roadmap for the sector.

Minister of State for Health & Family Welfare and Chemicals & Fertilizers, Smt. Anupriya Patel, highlighted that India is undergoing a significant transition from being a global generics leader to an emerging biopharma innovation hub. She noted that India currently contributes nearly 20% of global generic medicines and meets around 70% of global vaccine demand, underscoring the country's robust manufacturing capabilities.

Emphasizing future opportunities, she stated that the global demand for biologics and biosimilars is expanding rapidly, with the biosimilars market projected to reach \$75 billion by 2030. She further pointed out that innovative drugs account for nearly 87% of the global pharmaceutical market value, underlining the need for India to intensify its focus on innovation-driven segments.

Smt. Patel also outlined the integration of artificial intelligence in drug discovery and development. She emphasized the importance of strengthening human capital through premier institutions such as NIPERs and IITs to support advanced research and innovation.



High Courts in South India Lead Digital Transformation with 81.95 Lakh Online Hearings

New Delhi: The Ministry of Law and Justice has highlighted a significant milestone in the digital transformation of India's judicial system, noting that High Courts across South India have processed over 81.95 lakh cases through online hearings.

The online hearings that courts such as the Madras High Court and the Karnataka High Court have demonstrated high adoption rates of virtual proceedings, reflecting a strong shift towards technology-enabled litigation.

According to officials, the growing reliance on virtual hearings has streamlined judicial processes, enabling faster case management while maintaining procedural efficiency. The integration of digital tools has also significantly reduced the need for physical travel by litigants and legal professionals, making access to justice more convenient and cost-effective.

The ministry noted that such advancements are a key step toward modernizing the judiciary, ensuring that the adjudication process remains resilient, accessible, and aligned with evolving technological standards.

FUNDATION STONE LAID FOR THE BARBIL BYPASS RING ROAD PROJECT

CM Inaugurates 24 projects worth Rs. 29.41 crore and laid the foundation for 51 projects worth Rs. 326.43 crore

Keonjhar: On the third day of his visit to Keonjhar, Odisha Chief Minister Mohan Charan Majhi laid the foundation stone for the long-awaited 18 km 326 meters long Barbil Bypass Ring Road project in Barbil with an investment of Rs. 1581.21 crore to complete this project. Besides that he inaugurated 24 projects worth Rs. 29.41 crore and laid foundation stones for 51 projects worth Rs. 326.43 crore for Keonjhar district. On this occasion, the Chief Minister announced that a power substation will soon be built for the Joda, Basudevpur, and Barbil areas at a cost of Rs. 298 crore, and he instructed the district administration to expedite the construction of the 8-lane Barbil-Paradip road. Addressing the gathering, the Chief Minister said that this government stands by the people in their joys and sorrows and fulfills its promises. Out of many promises made to the people, today one more has been fulfilled. He said that he is fully aware of the traffic and heavy vehicle movement problems in cities like Keonjhar and Barbil, which he has personally experienced. Therefore, the government had decided from the

beginning to address these issues. Today, that decision has been implemented with the laying of the foundation stone for an over 18 km-long bypass and ring road for Barbil.

The stretch includes 3.7 km from Bhadra Sahi to Serenda, 6.3 km from Serenda to Balani, and 8.3 km from Serenda to Nalda. This bypass will solve long-standing problems. It will have a high-quality modern design capable of handling heavy traffic. According to modern standards, roads should handle up to 40,000 passenger cars per day, and this ring road will have that capacity. Currently, about 15,375 passenger cars pass daily. After completion, it will accommodate up to 40,000 cars. This will expand Barbil city, lead to more housing colonies along the road, and boost economic activity. It will also reduce operating costs for vehicles and contribute to the economy. Overall, the project will bring prosperity to the region. Additionally, several important infrastructure projects were launched. A 10 km road from Bamwari-Palasa-Guruda-Koida will be constructed with an investment of ₹95 crore. A 7.5 km road from Suakati-Dubuna-



Kalimati will be built at a cost of ₹30 crore. The KIDCO road from Palaspanga to Bamwari will also be upgraded, costing ₹30 crore for its 5.5 km length. Development of sports infrastructure at Barbil Utsav Ground and upgrading of the bus stand were also inaugurated at a cost of ₹9.27 crore. Projects like ITI staff quarters, a new sub-registrar office, improvement of playgrounds near the town hall, and park development were also undertaken. These projects will accelerate development in Barbil and the entire Keonjhar district and improve the quality of life of

Congress Fact-Finding Team Highlights Serious Irregularities in Gram Sabha Process and Violations of Tribal Rights in Sijimali Area

Rayagada : A fact-finding team constituted by the Odisha PCC President, Bhakta Charan Das, under the leadership of Saptagiri Sankar Ulaka, visited Kantamal, Sagabari and other affected areas in the Sijimali region. The team also met the District Collector to present its findings and concerns.

Based on extensive interactions with residents, the team has found serious irregularities and violations of due process. There are strong allegations that the eight Gram Sabhas held in December 2023 were false and fabricated, with the Sarpanch allegedly signing resolutions for all 8 gram sabhas on the same day, raising serious questions about the credibility of the consent process.

Community Forest Rights (CFR) and Individual Forest Rights (IFR) claims have reportedly been pending for the last three years and have not been resolved prior to project-related actions. There are multiple allegations of arbitrary arrests, including the detention of individuals not involved in any violence. "While we unequivocally condemn any form of violence and believe that those

responsible must face the law, innocent villagers must not be harassed. We vehemently condemn the events of 6 April 2026 night, when police entered the village around 3 AM, cut the electricity, broke open doors, and detained residents opposing the project. Such actions constitute a grave misuse of state machinery and have escalated tensions, leading to avoidable violence", mentioned a press statement released by Ulaka.

The District Magistrate, as the custodian of law and constitutional safeguards, must act in the interest of the people, not as a facilitator of mining, said the press release.

Key demands included a fair and transparent Gram Sabha process,

monitored under judicial supervision on the lines of the Niyangiri Gram Sabha process, must be conducted in Sijimali, recognition of all pending Community and Individual Forest Rights and settlement before any further project activity, withdrawal of all false police cases against innocent villagers, action against those involved in violence,

constitution of a joint committee of local representatives, MP, MLAs, etc., to initiate dialogue with stakeholders and determine the future course of action, ensuring that all decisions are fully compliant with constitutional provisions.

District Administration examining immediately and independently these allegations, including concerns regarding fabricated Gram Sabhas, pending forest rights, and excessive use of force, and ensuring that all actions are strictly in compliance with legal and constitutional provisions.

"The Congress Party, under the leadership of Rahul Gandhi, stands firmly with our tribal brothers and sisters. We will not allow any project to proceed without free, prior, and informed consent, as guaranteed under the Constitution and relevant laws" mentioned the press statement.

Odisha Public Universities Teachers' Reservation Act Comes into Force After Governor's Assent



Bhubaneswar, 13 April (H.S.): The Odisha State Public Universities (Reservation in Teachers' Cadre) Act, 2026 has come into force across the state following the assent of Governor Hari Babu Kambhampati.

The legislation was enacted after the Bill was passed in the Odisha Assembly on March 31 following extensive deliberations. With the Governor's approval, the Act has now been implemented statewide, marking a key reform in Odisha's higher education framework.

Welcoming the development, Higher Education Minister Suryabanshi Suraj described the Act as a landmark step aimed at ensuring adequate representation of Scheduled Tribes (ST), Scheduled Castes (SC), and Socially and Educationally Backward Classes (SEBC) in faculty positions across public universities.

The Minister said the Act introduces a significant shift by treating each university as a single unit for implementing reservation in teaching posts, replacing the earlier department-wise system. Under the new provisions,

reservation will apply to direct recruitment for positions such as Professors, Associate Professors, and Assistant Professors, ensuring more balanced representation across institutions.

He further informed that several long-pending vacancies in Vice-Chancellor positions have also been addressed, with appointments made in 14 state public universities. According to him, the appointment of academicians from Odisha to these leadership roles is expected to strengthen the academic environment and governance of universities.

Expressing confidence in the new leadership, the Minister said universities are now better positioned to focus on quality education and research-driven growth.

He added that with the implementation of both the Odisha Universities (Amendment) Act, 2024 and the Odisha State Public Universities (Reservation in Teachers' Cadre) Act, 2026, the process of filling vacant teaching positions in state public universities is expected to gain momentum in the coming months.

Bhubaneswar Celebrates 78th Capital Foundation Day with Grandeur

Bhubaneswar, 13 April (H.S.): The 78th Capital Foundation Day of Bhubaneswar was celebrated with great enthusiasm and dignity on Monday. Odisha Assembly Speaker Surama Padhy attended the programme as the chief guest.

Several dignitaries, including MP Aparajita Sarangi, MLAs Ananta Narayan Jena and Sushant Kumar Rout, Mayor Sulochana Das, and former minister Suresh Kumar Routray were present.

A grand torch procession was taken out from Lingaraj Temple to PMG Square, led by Olympian Dutee Chand and other sportspersons.

The chief guest unfurled the national flag and took the salute at a combined civic parade, in which 51 contingents participated. In the parade

One Killed, 15 Injured in Truck-College Bus Collision in Jajpur

Bhubaneswar, 13 April (H.S.): At least one person was killed and 15 others injured after a Hyva truck collided with a private college bus near Oupada Chhak under Korei police limits in Jajpur district on Sunday night. The driver of the Hyva truck succumbed to injuries while undergoing treatment at a hospital.



The accident occurred when the college bus, carrying students, was en route to Jajpur Road. Near Oupada Chhak, the Hyva truck allegedly approached from the wrong direction and rammed into the bus, triggering the collision.

Local residents immediately rushed to the spot and began rescue

operations while informing the police. Personnel from Korei and Panikoi police stations arrived shortly and shifted the injured to Jajpur Road Medical using ambulances.

Several critically injured persons were later referred to hospitals in

Cuttack and the District Headquarters Hospital in Jajpur for advanced treatment.

Officials said 11 injured students were shifted to Tata Hospital for further care, while one student recovered and was discharged.

Manas Mangaraj Appointed BJD Leader in Rajya Sabha; Sulata Deo Named Deputy Leader and Chief Whip

Bhubaneswar, 13 April (H.S.): Naveen Patnaik, president of the Biju Janata Dal (BJD), has appointed senior leader Manas Ranjan Mangaraj as the Leader of the party in the Rajya Sabha.

US-Iran Impasse

THE collapse of the US-Iran peace talks in Islamabad had an air of inevitability about it. After 21 hours of marathon negotiations, delegations led by US Vice President JD Vance and Iranian Parliament Speaker Mohammad Bagher Ghalibaf left Islamabad without an agreement, casting a long shadow over an already



fragile ceasefire. Iran has rightly observed that a deal should not have been expected after just one round of talks. This indicates that the window for further deliberations remains open. However, mutual mistrust continues to outweigh the urgency of ending the war which has destabilised global energy markets and aggravated regional tensions.

The impasse is rooted in a deeply entrenched divide. The US, under President Donald Trump, wants Iran to abandon its

The path forward demands not just new proposals but also a recalibration of expectations, prioritising gradual rebuilding of trust over maximalist positions. With thousands of lives lost and the global economy at stake, the US, Israel and Iran must give diplomacy a chance in order to find middle ground.

Talent Flight

A study by a digital education portal on JEE toppers from 1990 to 2020, cited recently, is a telling lens on what happens to India's brightest minds. It shows that 23 out of 31 toppers are settled abroad. And strikingly, none of them pursued a master's degree in India. This is a quiet verdict on the credibility of India's research ecosystem.

These are not average students. JEE toppers represent the highest-performing slice of the country's engineering talent pipeline. They had access to premier institutions. Their decision to move abroad for higher studies and careers signals a deeper concern: India may be producing talent efficiently, but it is failing to retain and nurture it.

The implications are serious. A country that consistently loses its academic young elite is losing its potential future professors, researchers, innovators and institution-builders. The absence of toppers in Indian master's programmes, as highlighted in the study, becomes an indictment of domestic research infrastructure, where funding constraints, limited global collaboration and weaker lab ecosystems deter advanced study. This trend also reflects global asymmetry. Universities in the US, Europe and increasingly East Asia offer structured research pathways, mentorship, interdisciplinary freedom and clearer links between education and industry. Indian institutions, despite pockets of excellence, struggle to match this consistency at scale. When the best-trained minds leave, innovation ecosystems thin out, academic leadership weakens and the cycle of institutional improvement slows further.

India's demographic dividend will only translate into real knowledge capital if its top talent sees credible futures at home. Otherwise, the message from its brightest young brains points to the fact that while excellence begins in India, too often, it is completed elsewhere.

On March 31, 2026, employees across regions received a uniform communication without any prior discussion or transition. The message stated that their roles had been eliminated with immediate effect. The decision formed part of a restructuring by Oracle Corporation affecting approximately 30,000 employees globally, including nearly 12,000 in India. The logic was more instructive. The layoffs were not driven by revenue stress, but by a reallocation of capital towards artificial intelligence infrastructure (an estimated shift of \$8–10 billion). Work was not withdrawn under constraint; it was displaced by priority. Employment is no longer concluded through negotiation but executed as a system decision: simultaneous and final. The phrase "your job is eliminated" is no longer delivered; it is processed.

For over two decades, India's global role rested on labour arbitrage: large-scale, cost-efficient human execution sustained by entry-level absorption. That foundation is now being restructured. Estimates suggest that 60–65% of tasks in traditional IT services are automatable, even as demand rises for advanced digital capabilities. Entry-level hiring across major firms has declined by 15–20%, though roles in AI, cloud, and data expand. Employment, in aggregate, is not collapsing; the structure of participation is changing, more rapidly than in earlier transitions where technology displaced labour but created new entry. The current shift compresses entry itself: fewer initiate work while systems scale it. The result is not a visible job loss, but a thinning at the base: delayed absorption and narrower

beginnings. The system is not eliminating work: it is reducing the need to begin with it.

In *The Time Machine*, H. G. Wells described not a jobless future, but one where economic organisation produces separation in participation. That distinction sharpens in the present. The transition is not uniform displacement, but divergence: one segment designs and augments intelligent systems, while another sees routine execution steadily lose relevance. This shift is gradual but structurally decisive. Earlier transitions redistributed labour across sectors; this one reorganises access within sectors. Employment persists, but participation becomes uneven, being defined less by work availability than by the kind accessible. The system continues to generate value while narrowing entry into it. The future Wells anticipated was not jobless; it was divided by the nature of work

itself.

Aggregate indicators continue to suggest stability. India's unemployment rate remains between 3–5% per the Periodic Labour Force Survey. Yet beneath this, divergence is visible. Graduate unemployment is higher, at 13–15%, indicating stress at entry. Hiring adjustments occur through slowdown rather than separation. Entry-level recruitment moderates while informal and contractual engagements expand, diluting employment quality without altering headline numbers. The shift is statistical as much as structural: fewer visible exits, but increasing difficulty in entering and stabilising within the workforce. The labour market is not weakening; it is tightening at the point where careers begin.

The compression of entry-level employment directly into demand formation. Early-stage

income initiates consumption, enables first-time credit, and anchors savings; when this layer thins, demand weakens at its source. Survey evidence from the Reserve Bank of India shows that households facing employment-related stress report weaker spending sentiment and lower discretionary consumption. When repeated across households, this restraint aggregates into a structural imbalance: output can expand, but without proportional growth in first-time earners, demand formation lags.

Labour metrics continue to measure employment status rather than the nature of work, limiting visibility into task transformation, skill shifts, and compressed entry pathways. Assessments by NITI Aayog acknowledge the need for reskilling, yet frameworks remain aligned to execution-driven roles. Programmes such as Pradhan Mantri Kaushal Vikas Yojana have expanded access, but have yet to adapt meaningfully to AI-exposed transitions. The challenge is not the absence of policy, but the absence of a quicker adaptation. Policy continues to measure how many work, not what work is becoming.

"Your job is eliminated" is no longer just a firm-level decision; it signals a system-level transition. The task ahead is to restore entry, not merely expand employment. As *The Time Machine* suggests, such shifts do not arrive as rupture, but as gradual separation in participation. The costs are dual: economically, the compression of entry weakens demand and participation; structurally, it narrows pathways through which work begins and sustains, weakening the expectation of mobility. A nation may continue to grow within this structure. But if entry continues to contract, growth will rest on a progressively thinner base, where work endures, but the path to it quietly disappears.

Monday, Rahul Gandhi branded Sarma as India's most corrupt chief minister, accusing him of weaponizing official authority to harass political adversaries and critics—a blatant affront to constitutional ethos. He insisted that Khera's claims warrant impartial scrutiny, advocating transparency, governmental accountability, and rule of law as bedrock constitutional tenets. Reiterating solidarity,



Gandhi declared: "We shall not cower. Congress stands resolutely with Pawan Khera." The imbroglio ignited on April 5, 2026, during Khera's press briefing at Congress headquarters, where he alleged Rinki Bhuiyan held active passports from the United Arab Emirates, Antigua-Bermuda, and Egypt, alongside undisclosed multimillion-rupee assets in Wyoming (USA) and UAE—

omitted from Election Commission disclosures. Sarma dismissed these as malicious fabrications, pledging legal recourse within 48 hours; consequently, an FIR ensued, prompting Assam Police's raid on Khera's Delhi residence on April 7. Absent at the time, Khera later saw police seize his mobile, iPad, laptop, and pen drives. This standoff exemplifies intensifying pre-

poll skirmishes, with Congress decrying "state machinery misuse" while BJP counters with defamation charges. Khera secured interim relief from Telangana High Court against coercive action, underscoring judicial checks on partisan overreach. Gandhi's intervention galvanizes party morale, framing the episode as a democratic litmus test amid Sarma's governance scrutiny.

Trump's Personal Praise for Pakistan's PM and Army Chief Shadows US-Iran Diplomatic Failure



Washington, 13/4 (H.S.):US President Donald Trump has publicly praised Pakistan's Prime Minister Shehbaz Sharif and Army Chief Field Marshal Asim Munir as "very extraordinary men" for their role in hosting high-level US-Iran peace talks in Islamabad aimed at ending the six-week war in the Middle East.Though the negotiations concluded without a formal agreement, Trump framed the dialogue itself as a diplomatic success brokered by Pakistan's leadership.Trump's wording and toneIn a detailed post on Truth Social, Trump said he had been "fully debriefed" by Vice President JD Vance, Special Envoy Steve Witkoff, and Jared Kushner on the Islamabad meeting, which he attributed to the "kind and very competent leadership" of Sharif and Munir.He described both leaders

as "very extraordinary men" and claimed they "continuously thank" him for having averted what he calls a "horrendous war with India," even though Indian officials have repeatedly denied any third-party mediation in last year's ceasefire.Trump has also repeatedly referred to Munir as his "favourite field marshal," underscoring unusually warm personal regard for Pakistan's top military commander.Pakistan's role in the US-Iran talksPakistan facilitated the first face-to-face, high-level negotiations between Washington and Tehran in decades, positioning Islamabad as a key mediator in the crisis.Prime Minister Sharif stated that Field Marshal Munir played a "key and historic" role in "extinguishing the flames of war" and in bringing both sides to the table.Munir also personally received and saw off the US and Iranian delegations at

Islamabad's airport, signalling the centrality of the military-civilian tandem in the diplomatic effort.The war erupted on February 28, 2026, when US and Israeli forces launched airstrikes that killed Iran's Supreme Leader Ali Khamenei and several senior commanders, triggering a chain of retaliatory attacks on Israel and US bases in the Gulf.After weeks of escalating violence, President Trump announced a two-week ceasefire last week and pushed for the talks in Islamabad as a last-ditch effort to secure a broader settlement.The marathon negotiations ended with Vance stating he was leaving without a deal; Trump blamed Iran's refusal to scale back its nuclear ambitions, while Tehran denounced American demands as "unreasonable."Thousands of people have been killed across the region since the conflict began.

Trump's Papal Firestorm: Rebukes Vatican Pontiff Leo XIV Over Iran War Stance and Nuclear Peril

Washington, 13/4 (H.S.):President Donald Trump launched a scathing critique against Vatican prelate Pope Leo XIV, castigating his position on the Iran conflict. Trump decried the Pope's foreign policy as deplorable, telling journalists Sunday evening: "We don't want a Pope who says it's fine to have nuclear weapons. He doesn't think Iran would blow up the world if they get nukes."According to CNN, the first American Pope has grown vociferous against US-Israel hostilities toward Iran. Last week, Leo XIV condemned Trump's threat to Iran—"Tonight, all civilization ends"—uttered hours before a two-week ceasefire accord, deeming it utterly unacceptable.Trump and Defense Secretary Pete Hegseth have invoked divinity in war rhetoric; Hegseth framed the fray as divinely sanctioned, adducing sacred texts. Pope Leo XIV repudiated this vehemently on Palm Sunday: "Jesus is the King



of Peace. He rejects war. No one may invoke Him to justify conflict."Trump riposted on Truth Social, averring: "We don't need a Pope who thinks Iran should have nukes, or America's Venezuela strike was terrible. I don't want a Pope criticizing the US President." He impugned Leo's papal



worthiness, claiming the Church enthroned him solely for American provenance.Vatican spokesman Father Antonio Spadaro retorted that Trump seeks to muzzle moral suasion: "Leo outclasses Trump in debate. The Pope's words resonate profoundly, unsettling him."Leo has long inveighed against nuclear

proliferation; last June, amid Trump's mooted strikes on Iranian sites, he urged: "Advance a nuclear-free world through mutual respect and candid dialogue, forging enduring peace rooted in justice, fraternity, and common weal." The White House demurred comment.

Netanyahu's Defiant Stand in Lebanon's Shadows: Flak Vest Proclamation Amid Ceaseless Conflict

Lebanon, 13/4 (H.S.):In a bold assertion of unyielding resolve, Israeli Prime Minister Benjamin Netanyahu ventured into southern Lebanon on Sunday, clad in a flak vest—a robust garment engineered to deflect low-velocity projectiles—and addressed troops entrenched within a newly established security zone.Accompanied by Defence Minister Israel Katz and masked soldiers, he proclaimed that Israeli forces had decisively neutralized the peril of a Hezbollah incursion, crediting ground maneuvers with curtailing rocket barrages that imperiled northern Israeli enclaves. Netanyahu underscored the persistence of hostilities,



declaring, "The war continues, including within the security zone in Lebanon," while affirming that substantial endeavors remain underway to safeguard the realm.This visit, unprecedented in its proximity to the fray, unfolded against a tapestry of intensified Israeli Defense Forces (IDF)

operations, encompassing strikes on Hezbollah launch pads and infrastructure, even as Lebanon's Health Ministry tallied over 2,000 fatalities from assaults since early March.Paradoxically, this martial posturing coincides with diplomatic overtures: mere days prior, Netanyahu greenlit direct

negotiations with Lebanon, spurred by Lebanese entreaties and U.S. facilitation, slated for Washington.These parleys prioritize Hezbollah's disarmament and the forging of an enduring peace pact, potentially spanning generations, though Netanyahu has repudiated any ceasefire, vowing unrelenting blows until northern Israeli security is irrevocably restored.As IDF incursions expand buffer territories and rocket interceptions persist—logging at least 10 such incidents that day without casualties—the specter of escalation looms, intertwining saberrattling with slender hopes for reconciliation in a region scarred by decades of enmity since Israel's 1948 inception.

U.S. Warships Set to Seal Iranian Ports at Dawn; Iran Vows Strait of Hormuz Stays Open to Civilian Shipping

Washington/Tehran, 13/4(H.S.): The United States Central Command (CENTCOM) announced on Sunday that it is prepared to enforce a naval blockade of Iranian ports, which will take effect on the morning of 13 April at 10:00 a.m. Eastern Time. In the wake of CENTCOM's announcement, Iran's Islamic Revolutionary Guard Corps (IRGC) claimed that the Strait of Hormuz remains open for civilian vessels and warned that any foreign warship attempting to pass through the waterway will be treated as a violation of the ceasefire and met with "strict action."According to reports from Al Jazeera, CBS News and

Fox News, U.S. Central Command stated on the social-media platform X that, acting on the orders of President Donald Trump, its forces will begin implementing a blockade of all maritime traffic entering and exiting Iranian ports on 13 April at 10:00 a.m. Eastern Time. This blockade will apply equally to ships of all nations that attempt to enter or leave Iranian ports and coastal areas. The order covers Iranian ports along the Arabian Gulf and the Gulf of Oman.CENTCOM has emphasized that it will not obstruct the free passage of vessels transiting the Strait of Hormuz to and from non-Iranian ports.

"Deadly Vortex in the Gulf"— US-Iran Standoff Escalates as US Navy Prepares Hormuz Blockade on Monday

Washington, 13/4(H.S.):Tension has risen over the Strait of Hormuz as the United States prepares to impose a naval blockade on Iranian ports, raising fears of a wider war in the Middle East.After peace talks between the US and Iran in Pakistan ended without an agreement, US President Donald Trump ordered the US Navy to stop all ships entering or leaving Iranian-controlled waters in the strait. Washington says non-Iranian ships will still be allowed to pass through the Hormuz corridor, but the move is widely seen as a direct pressure tactic against Tehran.Iran has responded with strong warnings. The Iranian Revolutionary Guards Navy says the Strait is under full Iranian control and has threatened that any enemy forces entering the area will be trapped in a "deadly vortex." Iran's navy chief, Admiral

Shahram Irani, called Trump's blockade threat "ridiculous," insisting that Iran's forces are closely watching every move by US and allied warships in the region. This language reflects Iran's determination to keep its leverage over one of the world's most important oil routes. Oil prices have already jumped in reaction to the crisis. Global crude benchmarks have climbed above 100 dollars a barrel as tanker companies change their routes to avoid the Strait of Hormuz.Analysts say a full closure of the Hormuz choke point could sharply reduce global oil supply and push inflation higher, especially in countries that depend heavily on imported energy.The current crisis grew out of long negotiations between the US and Iran in Pakistan, held amid weeks of US- and Israeli-led air strikes on Iranian sites. Reports



suggested that both sides were close to a fragile ceasefire, including a partial reopening of the Strait and a temporary halt to attacks.However, Tehran reportedly refused to accept the

final terms on its nuclear programme, and Washington changed its stance at the last minute, causing talks to collapse.Iran's Foreign Minister Seyed Abbas Araghchi

has claimed that a private phone call between Israeli Prime Minister Benjamin Netanyahu and US Vice President JD Vance, made during the talks, shifted the focus toward Israel's

security demands and killed the deal. The US has not confirmed the call, but the allegation has added fresh tension to already strained relations between Washington, Tehran, and Jerusalem. Israeli officials argue that Iran often uses diplomacy to buy time while keeping its military options open, and they see the failed talks as a sign that tougher pressure is needed.Neighbouring countries and regional allies are increasingly worried that Trump's unilateral blockade order could push Iran into a strong military response it might otherwise have avoided.As the evening of Monday, approaches, legal and maritime experts are questioning the lawfulness of such a one-sided naval blockade in one of the world's busiest sea lanes. The Strait of Hormuz carries about one-fifth of all global oil exports, and past

disruptions there have caused recessions and serious economic shocks.Experts warn that if the US-backed blockade sparks a major Iranian retaliation, the conflict could quickly spread beyond the Gulf, pulling in other regional powers and further destabilising the international system. In response, diplomats from neutral and non-aligned states have urged emergency meetings at the United Nations and regional organisations, calling on all sides to step back from the edge. Yet with hostile rhetoric rising and warships already moving into position, Monday's blockade threat may not be a temporary pause, but the start of a new and far more dangerous phase in the US-Iran-Israel confrontation—one that will reshape energy flows and security alliances across the Middle East and the wider world.

Indian Markets Claw Back from Lows but Close Lower Amid Global Jitters

New Delhi, 13/4 (H.S.): Domestic equities staged a valiant recovery from intraday troughs on April 13, 2026, yet succumbed to late selling pressure, erasing gains and inflicting ₹2.10 lakh crore losses on investors. Benchmark indices opened sharply lower—Sensex down -2% at 75,937 amid -2% Nifty plunge to 23,590—before aggressive buying propelled Sensex 1,195 points higher to 77,063 and Nifty 352 points to 23,907 by 3 PM. Intra-day settlement triggered reversals, closing Sensex 702 points (0.91%) lower at 76,848 and Nifty 208 points (0.86%) down at 23,843. West Asia's ceasefire talks collapse fueled global unease, though buyers mitigated steeper declines. Sectoral Bloodbath and Selective Resilience Auto sector bled heavily (Nifty Auto -2.09%), trailed by IT, FMCG, and Oil & Gas (>1% falls); Banking, Capital Goods, Consumer Durables, Healthcare, Metal,



PSE, and Tech also closed red. Power and Telecom bucked the trend with buying support. Broader markets wavered: Nifty Midcap -0.57%, Smallcap -0.46% despite rebounds. BSE market cap shrank to ₹449.13 lakh crore from

Friday's ₹451.23 lakh crore. NSE saw 2,984 active stocks: 1,140 gainers, 1,844 decliners. Sensex: 3 up, 27 down; Nifty 50: 12 up, 38 down. Top Gainers: HDFC Life (+2.47%), ICICI Bank (+2.21%), Adani Enterprises

Emiac Technologies Ignites Bourse Debut: Stellar Premium Listing Delights IPO Aces

New Delhi, 13/3 (H.S.): Shares of Emiac Technologies Limited, a vanguard in digital market solutions, marked a triumphant premium ingress into the stock market today, gladdening its IPO subscribers with immediate gains. Issued at ₹98 per share through the IPO, the stock premiered on the BSE SME platform at a 10% premium, touching ₹107.80, and surged further to ₹109 amid robust buying momentum post-listing.

Profit-taking ensued thereafter, tempering the ascent modestly; by 10:23 AM, the scrip traded at 109, conferring an 11.22% bounty on IPO investors thus far.

The 31.75 crore IPO, unfurled for subscription from March 27 to April 8, garnered a respectable average response, achieving 3.22 times oversubscription overall. Qualified Institutional Buyers (QIBs) portion (ex-anchors) subscribed 1.02 times; Non-Institutional Investors (NIIs) at 4.96 times; and Retail Investors at 3.74 times. It comprised a fresh issue of 32.40 lakh equity shares at ₹10 face value, proceeds earmarked for procuring computers and laptops, branding and marketing, augmenting working capital, and general corporate objectives.

Emiac's financial trajectory evinces robust fortification, per its SEBI-filed Draft Red Herring Prospectus (DRHP). Net profit escalated from ₹39 lakh in FY23 to ₹84 lakh in FY24, vaulting to ₹4.22 crore in FY25; H1 FY26 (April-September 2025) yielded ₹4.55 crore. Revenue burgeoned from ₹2.95 crore (FY23) to ₹5.38 crore (FY24), ₹20.06 crore (FY25), and ₹14.49 crore in H1 FY26. Debt, erstwhile negligible—nil in FY23-24, ₹1 lakh by FY25 end—swelled to ₹1.30 crore in H1 FY26. Net worth ascended from ₹47 lakh (FY23) to ₹1.31 crore (FY24), ₹9.03 crore (FY25), and ₹13.57 crore (H1 FY26). Crude Returns to India After Seven-Year Hiatus Amid Port Blockade Tensions



New Delhi, 13/4 (H.S.): Two massive tankers laden with Iranian crude oil have docked at major Indian ports on the eastern and western coasts—the first such deliveries in nearly seven years—arriving amidst West Asian volatility and Iran's port blockade declaration, as per ship-tracking data. Monday's tracking revealed one tanker reaching Paradip port in Odisha, followed by another anchoring off Gujarat's Sikka port, carrying approximately 2

million barrels loaded mid-March from Kharg Island. Operated by National Iranian Tanker Company, the VLCC Felicity dropped anchor late Sunday near Sikka, while Jaya—also bearing ~2 million barrels from late February Kharg loading—halted off Paradip. These consignments mark the inaugural Iranian crude influx since sanctions halted imports post-2019, enabled by a U.S.-granted one-month waiver last month permitting en-route

cargoes' sale. Aimed at easing global supply snarls and stabilizing prices, the waiver preceded Washington's weekend announcement blockading Iranian ports post-failed Pakistan peace talks—to throttle Tehran's oil revenue streams. This timely replenishment underscores India's pragmatic energy diplomacy amid geopolitical flux, bolstering reserves against Hormuz disruptions.

Geopolitical Jitters Eclipse Global Bourses: Failed US-Iran Truce Ignites Sell-Off Cascade



New Delhi, 13/4 (H.S.): Weakness permeates global markets today, precipitated by the collapse of US-Iran peace negotiations in Pakistan, amid protracted West Asian tensions. Friday's American and European sessions concluded on a mixed note, yet the truce's unraveling has engendered pervasive pressure; Dow Jones futures plummet conspicuously, with Asian counterparts succumbing to broad-based selling. US markets navigated

Friday's trading in straitened confines amid suspense over Islamabad parleys; S&P 500 dipped 0.11% to 6,816.89, while Nasdaq ascended 0.35% to 22,902.89. Post-failure, Dow futures cascade 344.57 points (0.72%) to 47,570. European indices mirrored ambivalence Friday: FTSE shed 0.03% to 10,600.53; DAX a nominal 0.01% to 23,803.95; CAC gained 0.17% to 8,259.60. The diplomatic débâcle has afflicted Asia, where

seven of nine indices languish in red; Thailand's SET idles on holiday. Solely Taiwan Weighted edges 0.03% higher to 35,428.05. GIFT Nifty tumbles 442.50 points (1.84%) to 23,649; Kospi slumps 74.50 points (1.27%) to 5,784.37; Nikkei dives 594.11 points (1.04%) to 56,330; Hang Seng sheds 261.54 points (1.01%) to 25,632; Straits Times -0.39% to 4,969.78; Shanghai Composite -0.17% to 3,979.26; Jakarta Composite -0.07% to 7,453.13.

NCLAT Defers Vedanta's Challenge to Adani's Jaiprakash Associates Acquisition

New Delhi, 13/4 (H.S.): The National Company Law Appellate Tribunal (NCLAT) on April 13, 2026, postponed hearings on two appeals by Vedanta Group contesting the selection of Adani Enterprises' bid for debt-saddled Jaiprakash Associates Limited (JAL). Proceedings halted due to reconfiguration of the bench hearing Vedanta's pleas, triggered by a member's unavailability; NCLAT will soon schedule the next date.

Genesis of the Corporate Insolvency Dispute Allahabad NCLT approved Adani's ₹14,535 crore resolution plan on March 17, 2026, for JAL's cement, infrastructure, and real estate assets. Anil Agarwal-led Vedanta impugned this, alleging flawed



bidder selection despite its superior ₹17,926 crore offer. NCLAT denied interim stays earlier, with Supreme Court upholding—yet subjecting

implementation to appeal outcomes. Markets and investors await appellate verdict on this high-stakes mining sector showdown.

Gilded Lustre Fades: Marginal Dip in Domestic Bullion Bazaar Tempers Gold and Silver's Sheen

New Delhi, 13/4 (H.S.): The domestic bullion market witnessed a modest softening in gold and silver prices during early trading today. This decline has positioned 24-carat gold across most Indian bullion markets between ₹1,52,830 and ₹1,53,810 per 10 grams, while 22-carat gold trades from ₹1,40,090 to ₹1,40,990 per 10 grams. Silver, similarly subdued, commands ₹2,59,900 per kilogram in the Delhi bullion mart. In Delhi, 24-carat gold quotes at ₹1,52,980 per 10 grams, with 22-carat at ₹1,40,240. Mumbai mirrors this at ₹1,52,830 (24-carat) and ₹1,40,090 (22-carat) per 10 grams; Ahmedabad at ₹1,52,880 and ₹1,40,140 respectively. Chennai records 24-carat at ₹1,53,810 and



22-carat at ₹1,40,990 per 10 grams; Kolkata aligns with Mumbai at ₹1,52,830 and ₹1,40,090. Bhopal stands at ₹1,52,880 (24-carat) and ₹1,40,140 (22-carat). Lucknow trades 24-carat gold at ₹1,52,980 and 22-carat at ₹1,40,240 per 10 grams; Patna and Jaipur echo

Crude Cataclysm Looms: Oil Surges Past \$104/Barrel on Imminent Hormuz Blockade Brink

New Delhi, 13/4 (H.S.): The protracted West Asian crisis and the acrimonious denouement of US-Iran peace parleys without accord have profoundly reverberated through crude oil benchmarks. On Monday, prices breached \$104 per barrel as President Donald Trump signaled naval measures to interdict access to the Strait of Hormuz. In early international trading, Brent crude catapulted nearly 8% above \$104, while US West Texas Intermediate (WTI) benchmark rocketed 8.61%. Currently, Brent trades at \$102.3—up \$7.07 or 7.43%—and WTI at \$104.2, ascending \$8.32 or



8.62%. Market savants posit the oil arena has reverted to pre-ceasefire volatility, albeit with escalated stakes: the US contemplates curtailing Iranian exports, compounding Gulf exporters'

paralysis from Hormuz strictures. Deemed the gravest petroleum exigency since the 1970s, Iran's erstwhile 2 million barrels daily outflow faces obliteration, portending acute global supply constriction.

Khan, for whom she sang the much-loved song 'Zara Sa Jhoom Loon Main' from the classic Dilwale Dulhania Le Jayenge, remembered her as a timeless voice of Indian cinema. In his message, Shah Rukh Khan wrote, "It's truly sad to learn about Asha Tai's passing. Her voice has been one of the pillars of Indian cinema and will continue to resonate across the world for centuries to come."

hole drive veered into trees, but a bunker recovery and two-putt bogey sealed victory. Tyrrell Hatton, Justin Rose, Russell

Henley, and Cameron Young tied third at 278. McIlroy's embrace with wife and daughter marked a career pinnacle.
