Suvendu Adhikari becomes first BJP CM of West Bengal; Takes oath along with five Cabinet Ministers

Kolkata: BJP legislature party leader Suvendu Adhikari took the oath as the Chief Minister of West Bengal today, heading the first BJP government in the state.

Governor RN Ravi administered the oath of office and secrecy to Mr. Adhikari at a grand ceremony held at the Brigade Parade Grounds, Kolkata.

Five Cabinet Ministers also took the oath along with the Chief Minister. The Governor R N Ravi administered the oath of office and secrecy to the Ministers. The Cabinet Ministers are Dilip Ghosh, Agnimitra Paul, Ashok Kirtania, Nisith Pramanik and Kshudiram Tudu.

Suvendu Adhikari was sworn in as the new Chief Minister of West Bengal today in a programme at the Brigade Parade Ground in Kolkata. Suvendu Adhikari won from the Bhabanipur and Nandigram assembly constituencies.

BJP MLA from Kharagpur Sadar Dilip Ghosh, Agnimitra Paul, MLA from Asansol Dakshin, MLA from Bongaon Uttar Ashok Kirtaniya, Khudiram Tudu, MLA from Ranibandh seat, Nisith Pramanik from Matha Bhanga assembly, took oath as Ministers-designate of the new Council of Ministers of the Government of West Bengal Today is Pochishhe

Boishak -an auspicious day - the birth anniversary of Kabiguru Rabindranath Tagore, which is celebrated across the state. This day has been selected for the swearing-in ceremony of the new BJP government in West Bengal.

Prime Minister Narendra Modi, Union Home Minister Amit Shah, Defense Minister Rajnath Singh, Chief Ministers of other NDA and BJP-ruled states, BJP president Nitin Nabin and other leaders of the Bharatiya Janata Party were present in the swearing-in ceremony.

The programme started with floral tribute to Kabiguru Rabindranath Tagore. Prime Minister Narendra Modi and



Chief Minister Suvendu Adhikari and other dignitaries paid respect to Kabiguru. Kalyan Laha reporting from Kolkata.

Prime Minister Narendra Modi took the blessing of 97-year-old Makhan Lal Sarkar, one of the senior-most state leaders during the BJP's initial days at the swearing-in ceremony.

In a grand gesture, PM Modi hugged and touched his feet. Sarkar was the aide of Shyama Prasad Mookerjee, founder of Bharatiya Jan Sangh.

BJP has won 207 seats in the 2026 West Bengal 2026 Assembly elections, while the Trinamool Congress secured 80 seats after ruling the State for 15 years.

PM Narendra Modi to embark on 2-day visit to Gujarat



New Delhi: Prime Minister Narendra Modi will embark on a two-day visit to Gujarat starting tomorrow.

The Prime Minister's Office said that during the 2nd day of his visit, Mr Modi will participate in Somnath Amrut Mahotsav, marking the 75th anniversary of the Somnath temple's restoration.

As part of the celebrations, the Prime Minister will participate in a series of auspicious religious and cultural events.

He will take part in the Vishesh Maha Puja, followed by the Kumbhabhishekam and Dhvajarohan ceremonies, marking the consecration rituals and hoisting of the temple flag. The Prime Minister will

also release a commemorative stamp and coin on the occasion, commemorating the rich legacy and spiritual significance of Somnath.

On his visit, the Prime Minister will also travel to Vadodara, where he will inaugurate the Sardardham Hostel and address the gathering.

The project includes hostel facilities for over one thousand boys and girls each, along with amenities like a central dining hall, library and auditorium.

The Prime Minister will also visit various facilities at the Sardardham complex, including the reception area, civil amenities, dining area and e-Library during the visit.

Delhi HC grants interim protection to Shashi Tharoor against alleged AI deepfakes, orders takedown of posts

New Delhi: The Delhi High Court on Saturday granted interim protection to Congress MP Shashi Tharoor in his plea against alleged AI-generated deepfake videos, observing that he enjoys enforceable personality and publicity rights over all facets of his persona.

Justice Mini Pushkarna, while hearing Tharoor's suit seeking protection of his personality rights and reputation, held that a prima facie case was made out in his favour and restrained unknown persons from creating or circulating synthetic media using his identity through artificial intelligence and related technologies.

The Court directed X Corp to take down specified links containing the alleged deepfake content and asked Meta to ensure that identified Instagram URLs,

which had already been blocked, continue to remain inaccessible.

The Court also directed the platforms to disclose the identity and subscriber details of the uploaders and creators of the allegedly infringing content within three weeks.

The order came on a civil suit filed by Tharoor seeking a permanent injunction against alleged misuse of his personality, voice, likeness and public image through AI-generated deepfake videos.

Senior Advocate Amit Sibal, appearing for Tharoor, argued that fabricated videos generated using artificial intelligence had allegedly cloned the Congress leader's face, voice, vocabulary and speaking style. According to the plea, the manipulated videos falsely depicted Tharoor making politically sensitive



remarks, including statements allegedly praising Pakistan's diplomatic strategy. The suit claimed that the content caused serious damage to his credibility and public standing.

The Court recorded submissions that Tharoor, a former Under-Secretary-General of the United Nations and former Minister of State for External Affairs,

had built immense goodwill and public trust over decades of public life. The suit stated that the alleged deepfakes surfaced around March 2026 and continued circulating despite fact-checks by media organisations and independent agencies.

Sibal argued before the Court that the matter involved the protection of an individual's personality

rights and reputation, submitting that identical videos kept resurfacing through different URLs even after takedowns. Counsel for Meta informed the Court that the Instagram URLs identified in the plea had been made inaccessible on Friday morning.

In its interim findings, the Court observed that Tharoor's "reputation, goodwill, name, physical appearance/image/likeness, voice, mannerisms, styles, signature oratorical style, and other attributes are uniquely identifiable and associated" with him, and therefore form part of his protected personality.

The High Court further noted that personality and publicity rights are protectable under Articles 19 and 21 of the Constitution.

Pending further hearing, the Court restrained

Defendant No. 1, described as Ashok Kumar/John Doe and associated persons, from reproducing or imitating any aspect of Tharoor's persona, including his name, image, voice and speaking style for creation or dissemination of deepfakes, voice-cloned audio or morphed videos through AI, generative AI or machine learning technologies.

The Court also granted liberty to Tharoor to approach social media platforms for the removal of any additional similar content discovered during the pendency of the suit.

The High Court issued a summons in the suit and directed the defendants to file written statements within 30 days. The matter has been listed before the Joint Registrar on July 13 and before the Court on October 13, 2026.

PM Modi bows before people of Bengal while attending Suvendu Adhikari's oath ceremony

New Delhi: Prime Minister Narendra Modi on Saturday bowed to the people of West Bengal while attending the swearing-in ceremony of Suvendu Adhikari as the Chief Minister of West Bengal. PM Modi arrived in Kolkata to attend the event.

After entering the Brigade Parade Grounds, PM Modi, accompanied by Chief Minister designate Suvendu Adhikari and state BJP president Samik Bhattacharya, took a ride in an open-air jeep and waved at the thousands of BJP workers and supporters who were present at the venue.

The entire Brigade Parade Grounds was decked in saffron colours. A large number of artists were performing to the tune of traditional drums.

After taking a ride in the vehicle, PM Modi went to the stage and met all the dignitaries, including Union Home Minister Amit



Shah, Defence Minister Rajnath Singh, Union Ministers, Chief Ministers of BJP-ruled states and other leaders.

However, PM Modi then greeted Makhanlal Sarkar, one of the most senior workers of the BJP in the state, presented him with a shawl and took his blessings.

Later, the Prime Minister waved to the supporters and workers from the stage and bowed

before them, thanking them for giving the BJP such a huge mandate in the West Bengal Assembly elections. In a social media post, PM Modi said, "I bow to the Jana Shakti of West Bengal!" He also shared a video clip of the moment. Following this, Suvendu Adhikari took oath as the ninth Chief Minister of West Bengal in Brigade Parade Grounds in the presence of PM Modi

and a host of other dignitaries.

After a decade and a half, there has been another political change in the state. After the West Bengal Assembly elections, the BJP has come to power by bringing down the Trinamool Congress government. The party won 207 seats in the 294-seat West Bengal Assembly. Trinamool's seats have come down to 80 from 215 it won in 2021.

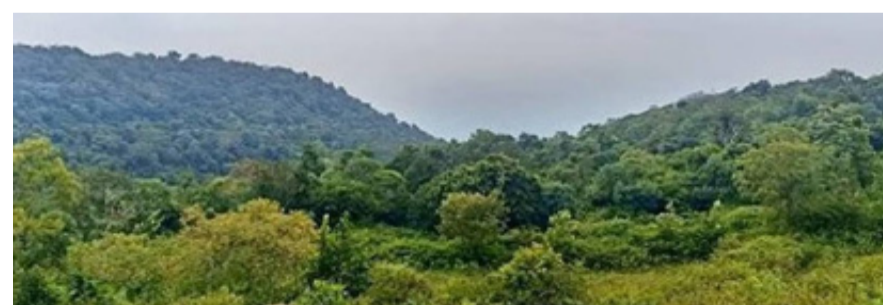
Delhi govt grants Reserved Forest status to 673 hectares of Central Ridge

New Delhi: The Delhi government has granted Reserved Forest status to over 670 hectares of the Central Ridge area under the Indian Forest Act, to strengthen environmental protection, biodiversity conservation and pollution control in the national capital.

According to an official statement issued on Saturday, the notified area falls under the Western Forest Division and covers parts around Sardar Patel Marg and the President's Estate.

Chief Minister Rekha Gupta said the decision marked a major step towards protecting Delhi's ecologically sensitive Ridge areas, often described as the "green lungs" of the city.

"With commitment and determination, our government has declared nearly 673.32 hectares of the Central Ridge area as Reserved Forest," Gupta said. The notification would provide stronger statutory protection to the area and help prevent



encroachments, illegal activities and ecological degradation, she added.

The Reserved Forest status has been granted under Section 20 of the Indian Forest Act, 1927. In the Reserved areas, activities including hunting, grazing, etc, are banned unless specific orders are issued.

This decision reflects our commitment towards environmental conservation, expansion of green cover, and securing a safe and balanced future for the coming generations.

The process of granting final legal protection to the Ridge areas had remained pending despite their initial

notification in 1994 under Section 4 of the Act, she said, adding that the declaration completed an important process that had been pending for more than three decades.

The Central Ridge stretches along both sides of Upper Ridge Road and forms part of the ancient Aravalli hill system, the statement said.

Gupta said the Ridge plays a key role in improving air quality, conserving biodiversity, strengthening groundwater levels and mitigating the impact of climate change and urban pollution.

Around 4,080.82 hectares of the Southern Ridge area had been declared a Reserved

Forest on October 24 last year, Gupta said, adding that the government is expediting the process of notifying the remaining Ridge areas in Delhi as Reserved Forests.

With the latest notification, a total of 4,754.14 hectares of Ridge areas in Delhi have now been granted Reserved Forest status, she added.

According to the statement, the government also plans large-scale plantation of native tree species, including neem, peepal, shisham, jamun, tamarind and mango, in suitable areas across the Ridge.

Women's Participation in India's Maritime Sector Surges 340% Since 2020: Sarbananda Sonowal

New Delhi/Paradip - Women's participation in India's maritime sector has increased by 340% since 2020, Union Minister of Ports, Shipping and Waterways (MoPSW), Sarbananda Sonowal said, underscoring the government's push to build a more inclusive, future-ready maritime workforce.

Delivering the keynote address at the 10th Indian Ocean Dialogue in New Delhi, Sonowal highlighted "Nari Shakti" as a central pillar of India's maritime growth story. Union Minister Sarbananda Sonowal was joined by His Excellency, Dhananjay Ramful, Foreign Minister of Mauritius, and His Excellency, Waleed Mohammed Al-Qadimi, Minister of State of Yemen.

"Through initiatives like 'Sagar Mein Samman', we are advancing dignity, inclusion and leadership opportunities for women in the maritime sector, which has seen a remarkable rise of about 340% since 2020," Sarbananda Sonowal said. "Under the dynamic leadership of Prime Minister Shri Narendra Modi ji, this transformation in the maritime sector is helping shape a more inclusive, resilient and future-



ready workforce for the Indian Ocean Region."

The Union Minister positioned the surge in women's participation within India's broader maritime vision, combining economic growth with social empowerment. He noted that the "human element" remains central to India's maritime strategy, alongside efforts to enhance security, connectivity and sustainability.

"The Indian Ocean is not just a geographic space, but a global lifeline," Sonowal said. "Its importance to global energy flows,

trade and supply chains calls for stronger cooperation, resilience and inclusivity."

Sonowal emphasized that India's maritime initiatives are aligned with the vision of Prime Minister Narendra Modi, including frameworks such as SAGAR (Security and Growth for All in the Region) and MAHASAGAR, aimed at strengthening regional cooperation and ensuring equitable growth.

The 10th Indian Ocean Dialogue, hosted by India as Chair of the Indian Ocean Rim Association (IORA) for 2025-27,

is themed "Indian Ocean Region in a Transforming World." The forum brings together ministers, policymakers, academics and industry leaders to deliberate on key regional issues. IORA comprises 23 member states and 12 dialogue partners, focusing on economic cooperation and sustainable development in the Indian Ocean Region, with women's economic empowerment identified as a key cross-cutting priority area.

IORA comprises 23 member states and 12 dialogue partners, focusing on economic cooperation and sustainable development in the Indian Ocean Region, with women's economic empowerment identified as a key cross-cutting priority alongside the blue economy. The 10th edition of the Dialogue, being held on May 7-8, 2026 in New Delhi, features dedicated sessions on maritime security, blue economy, disaster risk management, climate change and women's empowerment.

Two arrested for kidnaping and ransoming



Keonjhar : Keonjhar police arrested two persons from Salapada over bridge (NH20) Ghasipura police station while kidnaping a businessman and taking him in a car to Cuttack.

According to the police they intercepted the car (OD 22Y 4999) at Salapada bridge after getting a tip on Friday at 9.30 pm. On being verification police learnt that one Lunagariya Jaman Bhai (47) is doing tiles bussiness with Bajarang Lal (accused) of Keonjhar Town. Jaman Bhai belongs to Gujarat and Bajarang Lal basically from Rajasthan.

Yesterday Jaman Bhai had been to keonjhar to get Rs 9 Lakh which was due. But the accused

Bajarang Lal confined him in his house, brutally assaulted, threatened for dire consequences. The accd Bajarang has taken Rs 14,50,000/- from him. The accd kidnaped the victim from keonjhar and was proceeding to cuttack.

Bajarang Lal was threatening unless he pays Rs 33 lakhs to him, he will kill him at any time, police said.

"After receiving written complaint the the accused Bajarang and his driver Muniram were arrested. Further investigation in this connection ongoing going" said SDPO Anandapur, Kamal Kumar Panda. (EOM)

Mahanadi Water Dispute: End of the Deadlock or a Statistical Maze ?

Sambalpur-09/05(DMS) The long-standing water dispute between Odisha and Chhattisgarh over the waters of the Mahanadi River appears to have entered a decisive phase, but questions are now being raised over what critics describe as a "statistical and mathematical trap" behind the newly accepted data.

The debate intensified after the Mahanadi Water Disputes Tribunal officially recorded a joint technical report prepared by both states regarding water flow and water availability in the Mahanadi basin. The report marks the first major consensus between the two governments after years of disagreement over hydrological data and river flow assessments.

According to the report, based on data collected between 1980-81 and 2018-19, the average annual water flow reaching the Hirakud Dam has been estimated at 32.83 million acre-feet (MAF). Out of this, nearly 85 percent — around 27.76 MAF — originates from the Chhattisgarh region, while Odisha's contribution up to Hirakud is estimated at only 4.82 MAF.



The report further states that during drought or low-rainfall years, water inflow into Hirakud may decline to 21.82 MAF under 90 percent dependability conditions. Both states have also reportedly agreed that the total average water availability across the entire Mahanadi basin, from Naraj to the sea, stands at 62.36 MAF.

The tribunal, during its May 2 hearing, granted both states time until May 30 to resolve the remaining contentious issues. While the initial disagreement over measurement of water availability appears to have been addressed, crucial matters such as water sharing between the states and

ensuring continuous river flow during non-monsoon seasons are yet to be settled.

Questions are also being raised over the actual utilisation of the large volume of water claimed to be flowing through Odisha. Odisha Chief Minister Mohan Charan Majhi had earlier informed the Assembly on August 29, 2024, that reduced inflow into Hirakud during summer months has adversely affected the ability of the multipurpose project to achieve its intended objectives in recent years.

The Chief Minister had also informed the Assembly that comparative assessments of river flow between 1991-92 to 2004-

05 and 2005-06 to 2015-16 had been submitted before the tribunal, highlighting the declining non-monsoon water flow in the river.

At the same time, the Odisha government has pointed out that Chhattisgarh has constructed 41 major and medium irrigation projects and nearly 1,874 irrigation structures, along with several barrages and anicuts in the upper reaches of the river basin. Questions continue to remain over the exact number of water-control structures built since 2010 across the Mahanadi and its tributaries including the Seonath, Hasdeo, Ib, and Jonk rivers.

Observers believe that

securing a permanent water security guarantee for Hirakud during non-monsoon periods has now become Odisha's biggest challenge. The state government is under pressure to ensure uninterrupted river flow throughout the year.

Meanwhile, the Mahanadi Banchao Andolan has sharply criticised the statistical framework used in the report. The organisation's convener Sudarshan Das alleged that "mathematical manipulation" has weakened Odisha's rightful claim over the river waters.

He claimed that the data submitted before the tribunal is misleading and creates an impression that Odisha has virtually surrendered its position before Chhattisgarh. Das further stated that the organisation would soon hold a press conference to expose what it calls discrepancies in the report.

With the tribunal's next deadline set for May 30, attention across Odisha is now focused on the future course of the Mahanadi water dispute and whether the latest developments will lead to a final settlement or deepen the controversy further.

Two arrested in Chips smuggling

Keonjhar : Keonjhar police have taken arrested two accused from different places in connection with the smuggling of a huge quantity of metal chips in Bandha village under Dhokotha GP of Ghasipura police station. The arrested accused are Surendra Patra and Sushanta Patra from Bandha village, under the Ghasipura block.

According to sources, Gayatri Company left about 40,000 cubic meters of chips at the NH 20 construction site about eight years ago. The Revenue Department seized the chips on 13 October 2018 and left them there. However, during the investigation the Mining Department found only 3,965 cubic meters of chips at that location.

Deputy Superintendent of Police Cyber and Economic Offence Police Station, Keonjhar, Bijay Kumar Bihari said that after receiving a complaint from Ghasipura tahasil, a case (12/2026) was registered, and the two accused were arrested and produced in



court on Thursday. Further investigation is ongoing.

According to sources from a few years ago, the administration seized huge quantities of chips dumped in a ground in Bandha village. In April, 2026 the chips were stolen without the knowledge of the administration.

After this, the Sub Collector Anandapur Nilamadhab Suna ordered the tahasil and mining departments to inquire. On the 2nd, the official from the Tahsil and Mining Department, along with the police personnel visited the place and conducted a preliminary investigation.

During the investigation found huge quantities of chips were found to have been stolen and shifted from the location.

After receiving a complaint, the Revenue and Mining Department visited the site. While verifying the ground, they found that huge quantities of chips had been stolen and dumped there. Later after receiving the complaint, the Keonjhar Cyber and Economic offence police station regarding the theft. After this, the Keonjhar police formed a special squad and on the 7th, after investigation arrested the accused from the Thakurmunda

area of Mayurbhanj district and another from Puri while they were trying to escape.

Sources alleged that they sold the chips without obtaining any permission from the mining department. Later they joined the BJP party to escape arrest in the presence of senior BJP leaders and people's representatives. But the local BJP workers opposed their merger.

The police also seized more than 10 vehicles including a Hyva, many costly four wheel vehicles, and Machines. Because huge quantities of chips were smuggled from the site, the government is losing revenue worth many crores. Hence local people urged the government to conduct a high-level inquiry into this matter, including the buyers of the stolen chips and any political or other influential persons providing protection. Meanwhile, as the police crackdown continues, it remains unclear who is involved and how many people the police can reach.

Nine arrested involved in illegal sand mining

Legal Frameworks Must Evolve with Changing Demography: Law Minister

Bhubaneswar : In a significant initiative aligned with the vision of Viksit Odisha 2036 and 2047, the Department of Law, Government of Odisha, in collaboration with the United Nations Population Fund (UNFPA), today organised a high-level multi-sectoral consultation on "Demographic Change and Legal Systems: Preparing for Emerging Human Futures" at Mayfair Convention, Bhubaneswar. The consultation focused on how emerging demographic realities—including ageing, changing family structures, declining fertility, adolescent transitions, migration and reproductive technologies—are reshaping governance systems, public institutions and legal frameworks in the state. The consultation is among the first such initiatives in the country to examine how demographic transition is influencing legal systems, governance institutions and public policy frameworks. It

sought to initiate a forward-looking dialogue on preparing legal and institutional systems for emerging social realities arising from demographic change.

Inaugurating the consultation, Hon'ble Law Minister Prithviraj Harichandan emphasised that governance systems must increasingly anticipate social change rather than merely respond to it. "As Odisha moves towards Viksit Odisha 2036 and 2047, our legal and institutional systems must remain responsive to changing demographic and social realities. Law cannot remain static when society itself is evolving," the Minister stated. He appreciated the collaboration between the Department of Law and UNFPA, describing it as a visionary initiative that brings together demographic evidence and legal analysis to support future-ready governance. The Law

Minister also emphasized that the Odisha Government is set to establish five new cyber courts to ensure speedy justice in cybercrime cases and seven Fast Track Courts for women will be established to ensure the swift disposal of cases related to crimes against women.

Advocate General, Government of Odisha, Pitambar Acharya, highlighted the growing complexity of legal interpretation in a rapidly changing society. "Courts today are increasingly engaging with issues arising out of changing family structures, care responsibilities and emerging social realities. Discussions during the inaugural session highlighted that demographic transition is not merely altering population structures, but is also influencing how institutions respond to issues relating to ageing, adolescents, caregiving, migration and



reproductive choices. Odisha is currently undergoing a rapid demographic transition characterised by declining fertility, increasing life expectancy and a steadily rising elderly population. With fertility levels declining to around 1.7 and family structures changing significantly, the state is witnessing important shifts in age composition and social relationships. These trends have been highlighted in

various demographic analyses and projections of the United Nations Population Fund (UNFPA), the only United Nations agency mandated to work on population and demographic issues globally. Chief Secretary, Odisha, Anu Garg emphasised that demographic transition would play a defining role in shaping the future trajectory of economic, health and social capital under Odisha Vision 2036 and 2047. "Demographic change is not

merely about population numbers. It influences families, labour participation, care systems, social protection frameworks and access to justice. Preparing for demographic transition and preparing for Viksit Odisha must go hand in hand," she stated.

The consultation also underscored the importance of anticipatory governance and evidence based institutional responses as Odisha prepares for long-term social transformation arising from demographic shifts. Chairperson, Odisha Law Commission, Justice Biswanath Rath underlined the importance of continuously examining whether legal systems remain aligned with evolving societal realities and emerging vulnerabilities. Principal Secretary to Government, Law Department, Pabitra Mohan Samal noted that the initiative marked an

important institutional dialogue between law, governance and demographic evidence, and highlighted the need for greater integration between demographic insights and public policy frameworks.

Speaking on the occasion, Nadeem Noor, Head of Office, UNFPA Odisha, highlighted the uniqueness of the partnership between the Department of Law and UNFPA in bringing demographic perspectives into legal discourse. "This initiative recognises that demographic transition is fundamentally reshaping how societies function. The analysis of several judicial decisions demonstrates that these shifts are already visible within legal systems and institutional responses," he stated. A key highlight of the consultation was the release of the reflective compendium titled "Law in a Changing Society: Demographic Transition and Legal Frameworks in

Odisha", which analyses several judicial decisions to examine the intersection between demographic change, governance and legal systems in Odisha.

At this programme, Principal Secretary of the Law Department, Dr. Pabitra Mohan Samal delivered the welcome address. At the end, UNFPA representative Surya Prakash proposed the vote of thanks.

The consultation also featured thematic panel discussions involving senior administrators, legal experts, academics and development practitioners on issues relating to ageing, changing family systems, adolescent realities, assisted reproductive technologies, care responsibilities and emerging institutional responses. The event concluded with a shared recognition that demographic transition is not a distant future concern, but a present governance reality that requires continuous dialogue between law, policy and demographic evidence.

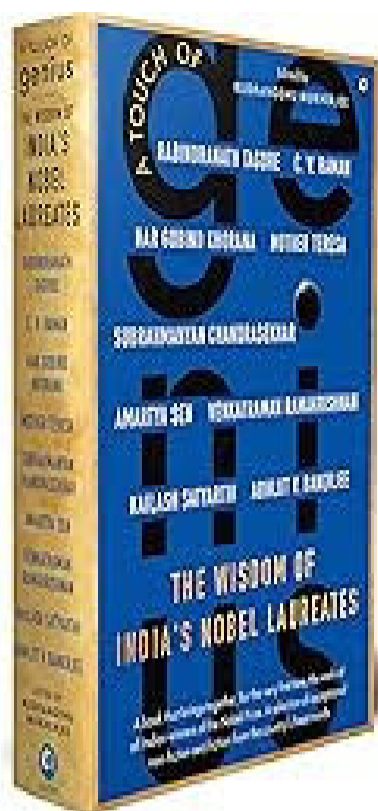
An Amazing Cerebral Feat

By bringing together Indian citizens, naturalized Indians, and those historically connected to India, he subtly expands the idea of "Indian intellectual heritage" beyond rigid boundaries. This is particularly significant in a globalized intellectual landscape, where ideas transcend geography even as they

remain rooted in lived experiences.

The voluminous book - it has more than 800 pages - offers considerable variety. Some pieces are dense and academic, especially in the sections on science and economics, while others-particularly in literature and memoir-are lyrical and deeply reflective. This unevenness in tone may challenge some readers, but it also reflects the diversity of the contributors themselves. The anthology does not aim for uniformity; instead, it celebrates difference.

A Touch of Genius is a remarkable intellectual achievement. It is not a book to be read hurriedly but one to be revisited, contemplated, and engaged with over time. For readers interested in the intersections of literature, science, ethics, and public life, this anthology offers both depth and inspiration. It stands as a testament to the enduring power of ideas and to the diverse ways in which Indian minds have shaped the global intellectual tradition.

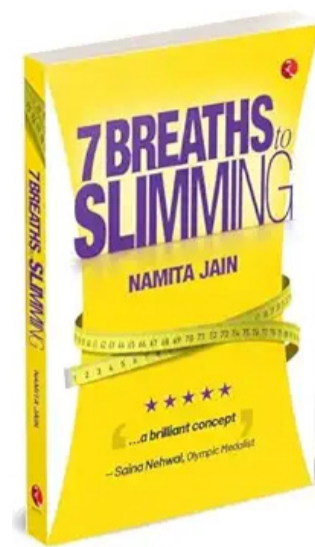

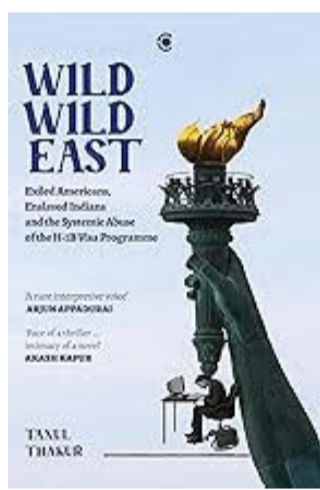
A Searing Exposé of H-1B Visa

Trauma & Cultural Specificity

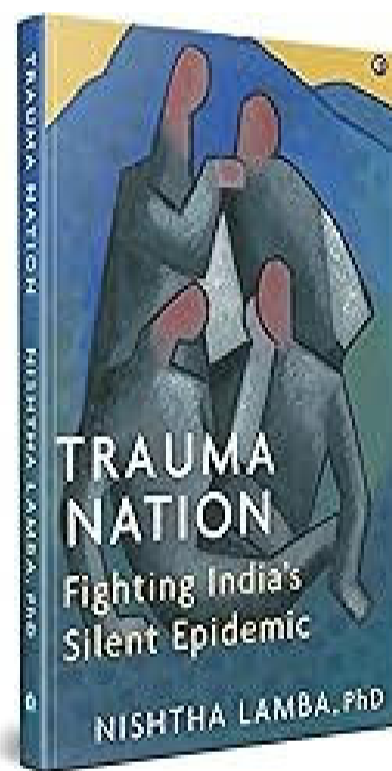

It was his on-ground strategy and involvement in the Nandigram agitation against the then Left Front government's land acquisition for industrialisation that helped catapult Mamata Banerjee to head the state government in 2011. The last Chief Minister from outside Kolkata was Ajoy Kumar Mukherjee, also from Purba Medinipur, whose term ended in June 1971. He led the United Front government. Since then, Jyoti Basu, Buddhadeb Bhattacharjee, and Mamata Banerjee have all been residents of the state capital. For Dilip Ghosh, it was a recognition of the work he has done even under incriminating conditions and hostility. As an organiser with the Rashtriya



Swayamsevak Sangh, he helped build the Bharatiya Janata Party's network across West Bengal, resulting in significant electoral gains for the party. He paved the way to his maiden Assembly victory in 2016 and led his party to a record 18-seat win in the 2019 Lok Sabha elections in West Bengal. He again won, this time from the Medinipur Parliamentary constituency. The 61-year-old leader is known for his regular morning walks, and he launched a political campaign, "Chai Pe Charcha", where he spoke to people while sipping tea. For some time, it appeared he was drifting away from the current state party leadership.

However, the current Bharatiya Janata Party President, Samik Bhattacharya, has successfully brought all leaders together. If it was recognition of his successful leadership in challenging political conditions for Ghosh, inducting Agnimitra Paul into the first Bharatiya Janata Party cabinet was the party's salute to women's power, which has been instrumental in the win. The 51-year-old is a fashion designer who went on to defend the Asansol Dakshin seat this time with a wider margin. She had served as the President of the West Bengal unit of the Bharatiya Janata Party Mahila Morcha and as the party's

General Secretary. By including Nisith Pramanik and Ashok Kirtania, the Bharatiya Janata Party has recognized West Bengal's two largest Scheduled Caste communities. While the two groupings have been delivering fractured mandates of late, this time their choice has largely been consolidated. Pramanik, representing the Rajbanshis, who comprise over 18 per cent, is West Bengal's largest Scheduled Caste group. The total population is estimated at around half a crore, spread across Cooch Behar, Jalpaiguri, Darjeeling, Malda, and Murshidabad districts, making them an

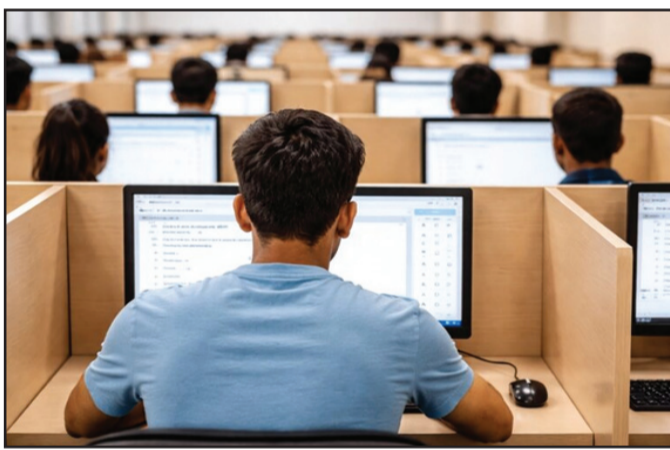
important vote bank. The 40-year-old was Union Minister of State for Home Affairs and Youth Affairs between 2021 and 2024. He lost the subsequent Parliamentary election. In 2021, he represented the Dinhatia Assembly constituency. This time, he won from the Mathabhanga constituency in the Cooch Behar district. Kirtania belongs to the socio-religious group, Matua, whose roots can be traced back to the Namasudra movement led by Harichand Thakur in the 19th century. Originally formed to challenge caste-based discrimination and promote social equality, the Matuas became a significant voice for marginalised Hindus, particularly those who migrated from then East Pakistan, later Bangladesh, during Partition. In West Bengal, they are concentrated in districts like North 24 Parganas and Nadia, where their numbers make them a decisive electoral bloc. He retained the Bongaon Uttar seat in North 24 Parganas district in the crucial Matua belt bordering Bangladesh. Meanwhile, the Bharatiya Janata Party also did well in the tribal areas, particularly in the western parts of the state, hoisting the saffron flag across large tracts of largely forested land bordering Bihar, Jharkhand, and Odisha.

Public Will Take Real Action Against AAP Govt: BJP On ED Raids Against Punjab Minister

New Delhi, 9/5: The Bharatiya Janata Party (BJP) on Saturday lashed out at the Aam Aadmi Party (AAP) government in Punjab, saying that the real action against its leaders, in cases of alleged corruption, would be taken by the people of the state in the next year's Assembly polls. The BJP's response came after extensive search operations were conducted by the Enforcement Directorate (ED) against Punjab Industry Minister Sanjeev Arora under the Prevention of Money Laundering Act (PMLA) of 2002. Arora was reportedly arrested following the ED raids. Raja Sabha MP Raghav Chadha alleged that the AAP has betrayed with the people's mandate in Punjab. "As much as Rs 21 lakh cash was thrown in a bag from a balcony during the ED raid, and round-tripping of funds were done through companies in the UAE, Canada and Australia," he told reporters. Chadha also claimed that the AAP government in Punjab has Rs 5 lakh crore debt on itself. He also said: "Apart from the central probe agencies, the real action against the AAP-led Punjab government will be taken by the people during the next year's Assembly polls." Likening the AAP's reign in Punjab to that of a prisoner counting his days in prison, Punjab BJP Vice-President Fatehjung Singh Bajwa said: "The people of Punjab are marking each day under AAP's regime. Their (AAP) government is filled with corruption." Punjab Leader of the Opposition (LoP) and Congress leader Partap Singh Bajwa said: "I want to ask the Central government that this issue has been going on for the past several years. So why did you wait for four years to act? And now, will this case go into a so-called 'political washing machine'? Will you ever reach a final conclusion?" The Punjab LoP claimed that around Rs 25 to 30 crore have been siphoned off. However, AAP MLA Chetan Singh Jouramajra came in defence of Punjab Minister Sanjeev Arora. He claimed that since the AAP is doing "good work" in Punjab, that is why the BJP-led Central leadership is unable to "tolerate it". "They don't want the AAP to return to power again (in Punjab) that is why our leaders are being arrested. It seems as if all the BJP leaders are innocent," Jouramajra said. The AAP MLA asserted: "Whatever may happen, the AAP leaders will stand firm and not bow down to anyone." Meanwhile, Congress leader Bhupesh Baghel called Punjab's AAP government and the BJP-led Central government as "two sides of the same coin". "In Punjab, the Bhagwant Mann government misuses the Vigilance Department and files cases against everyone. Similarly, in Delhi, the government misuses central agencies like the ED, IT department, and CBI," he said.

Centre Fully Operationalises Four Labour Codes After Over 5 Years

New Delhi, 9/5: The Centre has completed the implementation of the four labour codes by notifying the corresponding rules in the official gazette, more than five years after the reforms were first introduced to overhaul India's labour law framework. The four labour codes — the Code on Wages, 2019, the Industrial Relations Code, 2020, the Code on Social Security, 2020, and the Occupational Safety, Health and Working Conditions Code, 2020 — had come into force on November 21, 2025. With the publication of the rules, the new labour regime has now become fully operational across the country. Notably, the labour codes were brought in to replace and consolidate 29 existing labour laws into a simplified structure. However, according to officials, some operational aspects of the codes could not be implemented earlier due to the absence of notified rules. Earlier in May, Labour Minister Dr Mansukh



Mandaviya launched a nationwide annual health check-up initiative for all workers aged 40 and above under new Labour Codes. The free health check-ups for all workers above 40 years of age will now be conducted across the country every year. Mandaviya said the implementation of the four Labour Codes reflects Prime Minister Narendra Modi's guarantee of ensuring dignity, welfare and social security for workers across the

country. Highlighting key labour reforms, the minister stated that provisions for equal wages for men and women workers have been ensured, maternity leave has been increased from 12 weeks to 26 weeks and work-from-home provisions for women have also been incorporated. In addition, the framework provides for setting up a National Reskilling Fund to support workers who lose employment and require fresh training for new opportunities.

'Dishonestly Occupying Parts Of Country': Kejriwal Likens PM Modi To Aurangzeb

New Delhi, 9/5: Aam Aadmi Party (AAP) National Convener Arvind Kejriwal on Saturday likened Prime Minister Narendra Modi to tyrant Mughal emperor Aurangzeb and accused him of dishonestly occupying large parts of the country and now reached Punjab. Addressing a press conference in the backdrop of Enforcement Directorate (ED) action against Punjab Minister Sanjeev Arora, Kejriwal said, "Punjab is the land of the Gurus. Several hundred years ago, Aurangzeb seized control of many parts of the country through crime and oppression. Modi ji too has deceitfully seized control of many parts of the country. After that, Aurangzeb arrived in Punjab. Modi ji has now arrived in Punjab as well." Invoking the issue of Punjabi identity and the sacrifices of Sikh Gurus, Kejriwal said, "Aurangzeb perpetrated great atrocities on the Gurus. Modi ji is also perpetrating atrocities on Punjabis. But the Gurus



confronted Aurangzeb through sacrifice and saved the people. Today, drawing inspiration from the Gurus' sacrifice, Punjab will confront Modi ji's atrocities and save the entire country from his oppression." Kejriwal referred to the now-withdrawn farm laws and said, "A few years ago, Modi ji had challenged Punjab's farmers, and he had to bow before them. Today, Modi ji has challenged the entire Punjab." Insinuating political motives behind ED raids in Punjab, Kejriwal said, "As soon

as the Bengal elections ended, Modi ji started conducting daily ED raids in Punjab. In the past few years, Modi ji has dealt Punjab a heavy blow. Punjabis have been harassed in every possible way." He said attacks were launched on Punjab's water, attempts were made to take over Panjab University, funds for rural development were withheld, and now, relentless ED raids have been unleashed. Referring to ED action against a former AAP Rajya Sabha MP, Ashok Mittal, he said,

"A raid was carried out at Ashok Mittal's place, and the very next day, he was brought into the BJP. This means the purpose of the ED raid wasn't to uncover stolen money. It was solely to break Ashok Mittal and get him to join the BJP. "Just a few days ago, a raid was also conducted at Sanjeev Arora's place. When he didn't join the BJP, another raid was carried out at his premises," he said. The ED on Saturday arrested Arora, one of the powerful Cabinet ministers in the Bhagwant Mann-led Punjab government, from his official residence in Sector 2 in Chandigarh. The action came after the ED carried out extensive search operations on Sanjeev Arora's residences and offices under the Prevention of Money Laundering Act (PMLA) of 2002. However, there is no official statement from the ED on his arrest. Shiromani Akali Dal (SAD) leader Bikram Singh Majithia claimed that Arora has been arrested for alleged GST fraud.

Hydroponic Marijuana Worth Rs 34.9 Crore Seized At Delhi Airport From Bangkok Passengers

New Delhi: Delhi Customs officials at the Indira Gandhi International Airport have seized 34,935 grams of suspected hydroponic marijuana from two passengers who arrived from Bangkok on flight TG-323, officials said on Thursday. The contraband was detected after the passengers were flagged through the Advance Passenger Information System (APIS) profiling and intercepted by Customs officers after they crossed the Green Channel at the airport. According to officials, the passengers came under suspicion during routine profiling procedures carried out by Customs authorities. Their baggage was subsequently subjected to X-ray screening, during which suspicious images were noticed by officials. A detailed examination of the luggage led to the recovery of 31 vacuum-sealed packets



containing a substance suspected to be hydroponic weed, commonly referred to as ganja or marijuana. In an official statement, Delhi Customs said, "On the basis of APIS profiling, two passengers travelling from Bangkok to Delhi by Flight No. TG-323 dated 08.05.2026 were intercepted by Customs officers after crossing the Customs

Green Channel at Indira Gandhi International Airport." Officials further stated that the recovered substance weighed a total of 34,935 grams, including the packing material. "The total gross weight of the recovered substance was found to be 34,935 grams (including packing material). Prima facie, it appeared to be ganja/

marijuana. The market value is approximately 34.935 crores in the market," the statement added. According to Customs officials, the act amounts to a violation of Section 8 of the Narcotic Drugs and Psychotropic Substances (NDPS) Act, 1985, and is punishable under Sections 20, 23 and 29 of the Act. Both passengers have been arrested under the relevant provisions of the NDPS Act, 1985, officials confirmed. The seized narcotics are estimated to be worth nearly Rs 34.935 crore in the Indian illicit drug market, making it one of the significant drug recoveries at the airport in recent times. Officials said that further investigation is currently underway to ascertain the source, intended recipients and possible links to any larger drug trafficking network.

Social Security, Pension Schemes Show Our Commitment To Bring Dignity, Financial Security To People: PM Modi

New Delhi, 9/5: Prime Minister Narendra Modi on Saturday said that key Jan Suraksha Schemes, which completed 11 years of providing social security cover, reflect the government's commitment to bring dignity, assurance and financial security into the lives of the people of India. Launched on May 9, 2015, by PM Modi, the schemes — Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY), Pradhan Mantri Suraksha Bima Yojana (PMSBY), and Atal Pension Yojana (APY) — were envisioned to provide affordable financial protection to all, particularly underserved and vulnerable sections of society. "On this day, 11 years ago, key social security and pension schemes were launched by the NDA Government. They reflect our commitment to bring dignity, assurance and financial security into the lives of the people of India," the Prime Minister said in a post on X. Sharing a



MyGovIndia thread, PM Modi said that "This thread highlights that the PM Jeevan Jyoti Bima Yojana and PM Suraksha Bima Yojana have had a positive impact at the grassroots". PM Modi further stated that the Atal Pension Yojana has been highly beneficial for many people, enabling them to lead a more secure life in their old age. "The scheme reflects our commitment to making social security

accessible and inclusive. It is gladdening to see our Nari Shakti in particular benefit from this scheme," he mentioned. The three Jan Suraksha Schemes have reached 94.5 crore in cumulative enrolments under PMJJBY have exceeded 27.43 crore; under PMSBY, more than 58.09 crore people have enrolled; and more than 9.04 crore individuals have enrolled in the APY scheme (till April 30).

India Thanks Portugal For Support In Extraditing Fugitive Abhay Rana

Lisbon, 9/5: India on Saturday thanked the Portugal government and its law enforcement authorities for their cooperation and support in the successful extradition of wanted fugitive Abhay Rana to India. The Central Bureau of Investigation (CBI), in coordination with the Ministry of External Affairs (MEA) and the Ministry of Home Affairs (MHA), successfully secured the extradition of Abhay alias Abhay Rana from Portugal to India. The Embassy of India in Lisbon also issued a statement, thanking the Portuguese authorities after the conclusion of the extradition process. "Abhay Rana is charged with several serious offences and will now be subject to trial in the Indian courts. This extradition was carried out under the bilateral extradition agreement between the India and Portugal, following the issuance of an Interpol Red Notice," read a statement issued by the Indian Embassy. "The return of Abhay Rana marks an important step in the ongoing efforts of the Government of India to extradite fugitives currently residing in



various foreign countries. The success of this operation was made possible through active and sustained coordination between the Ministry of External Affairs, Ministry of Home Affairs, Haryana Police and the Embassy of India in Lisbon and various law enforcement agencies of Portugal," it added. According to the CBI, Abhay alias Abhay Rana, who was

the subject of an Interpol Red Notice, was wanted by the Haryana Police in multiple criminal cases registered in the state. The charges against him include extortion, criminal intimidation, operating an organised crime syndicate, attempt to murder, and issuing life threats. Investigators revealed that, in one of the cases registered

in Karnal district of Haryana, the accused, along with his associates, allegedly threatened local businessmen through social media platforms, including WhatsApp calls, demanding ransom payments. Those who failed to comply with the demands were reportedly assaulted by members of the syndicate. Following the completion of the investigation, a

charge sheet was filed against the accused before the competent court. On the request of Haryana Police, the National Central Bureau (NCB)-New Delhi got an Interpol Red Notice issued against the accused. India submitted a formal extradition request after he was geo-located and arrested by the Portuguese authorities. Following due legal proceedings, the Portuguese authorities approved the extradition of the accused to India. A Haryana Police escort team subsequently travelled to Portugal, where the accused was formally handed over to Indian authorities. The team, along with the accused, arrived at the Indira Gandhi International Airport in New Delhi on Saturday. CBI, as the National Central Bureau for Interpol in India, coordinates with all law enforcement agencies in India through Bharatpol for assistance via Interpol channels. More than 160 wanted criminals have been successfully brought back to India in the last few years through coordination via Interpol channels.

Japan Reports More Than 400 Measles Cases Since January

Tokyo: Japan has recorded more than 400 measles cases since January, a national health research body said. According to the Japan Institute for Health Security, medical institutions across the country reported 68 measles cases in the week through April 26, bringing the cumulative total for this year to 436. In comparison, 96 cases were recorded during the same period last year, and the full-year total for 2025 stood at 265. Tokyo alone has recorded 211 cases this year, accounting for nearly half of the national total. Including the neighboring prefectures of Kanagawa, Chiba and Saitama, the greater Tokyo metropolitan area has reported more than 300 cases in total. In a notice issued in late April, the institute said most domestic measles patients this year were teenagers and people in their 20s, around half of whom had either not completed the recommended two-dose vaccination schedule or had unclear vaccination histories. The highest annual number of measles cases in Japan

in the past decade was 744 in 2019. The institute warned that measles is highly contagious, with more than 90 per cent of non-immune individuals likely to become infected after exposure to the virus. Severe cases can lead to complications such as pneumonia and encephalitis. Japan was declared measles-free by the World Health Organization in 2015. However, since 2023, the number of measles cases reported worldwide has continued to rise, increasing the risk of imported infections. The institute said receiving two doses of the vaccine remains the most effective way to prevent measles infection and severe illness. It also advised travelers heading to countries or regions where measles may be spreading to confirm their vaccination status beforehand. Xinhua news agency reported. People experiencing symptoms such as fever, rash, coughing, or conjunctival redness were urged to contact medical institutions before seeking treatment and to inform healthcare providers of any recent overseas travel or contact with infected individuals.

S. Korea, US Join Hands To Advance Shipbuilding Cooperation

Washington, 9/5: South Korea and the United States have signed a memorandum of understanding (MOU) to advance bilateral shipbuilding cooperation, an agency of the U.S. Commerce Department said, as Seoul has committed to help revitalise the U.S. shipbuilding sector as part of a bilateral trade agreement. Park Jung-sung, deputy minister for trade at Seoul's Ministry of Trade, Industry and Resources (MOTIR), and U.S. Under Secretary of Commerce for International Trade William Kimmitt inked the MOU in Washington, overseen by Industry Minister Kim Jung-kwan and Commerce Secretary Howard Lutnick, according to the International Trade Administration. The MOU signing came as South Korea has pledged to invest US\$150 billion in the U.S. shipbuilding sector as part of last year's trade deal that committed the Asian country to

investing a total of \$350 billion in the U.S. with an annual cap of \$20 billion, reports Yonhap news agency. "The MOU signing builds on ongoing U.S.-Korea cooperation in strategic industries and reflects continued efforts to strengthen allied industrial capacity, promote investment, and expand collaboration in advanced manufacturing sectors," the administration said in a release. Under the MOU, the two sides will establish the Korea-U.S. Shipbuilding Partnership Initiative (KUSPI) — a new platform to strengthen bilateral cooperation in commercial shipbuilding, workforce development, industrial modernisation, and maritime manufacturing investment, it said. The partnership will leverage the Korea-U.S. Shipbuilding Partnership Center, which is expected to be established in Washington later this year, and will support expanded collaboration

between government, industry, and research institutions from both countries. Specific activities under the partnership will include facilitating foreign direct investment into the U.S. maritime industrial base, workforce training initiatives, shipyard productivity improvement projects and technical exchanges, among others. In line with the MOU, the Commerce Department will facilitate the centre's interactions with U.S. shipbuilding companies, suppliers, universities and research institutes, and act as the U.S. government-wide point of contact for the centre, according to the administration. MOTIR will coordinate cooperation across the Korean government and other shipbuilding stakeholders and provide the personnel and funding necessary for the center. Meanwhile, Kim and Lutnick held talks on Friday to discuss South Korea's projects to invest in the U.S. as part of the trade deal, an informed source said.

Indian Seafarer Killed After Ship Catches Fire, Sinks Near Strait Of Hormuz

Dubai/New Delhi: An Indian seafarer lost his life while four others sustained burn injuries after a wooden dhow carrying 18 Indian crew members capsized near the Strait of Hormuz following a fire onboard, official sources confirmed on Saturday. The incident took place on Friday in the strategically sensitive Strait of Hormuz region, where tensions linked to the ongoing Iran-US conflict continue to escalate, and reports of drone activity in the area have heightened security concerns. According to sources, the wooden dhow was transporting general cargo when the fire broke out. Authorities are still trying to determine the exact cause of the blaze that led to the vessel capsizing. Providing details of the incident, a government source said, "A wooden Dhow, carrying general cargo, with 18 Indian crew capsized yesterday close to the Strait of Hormuz after it caught fire. The exact cause of the fire is



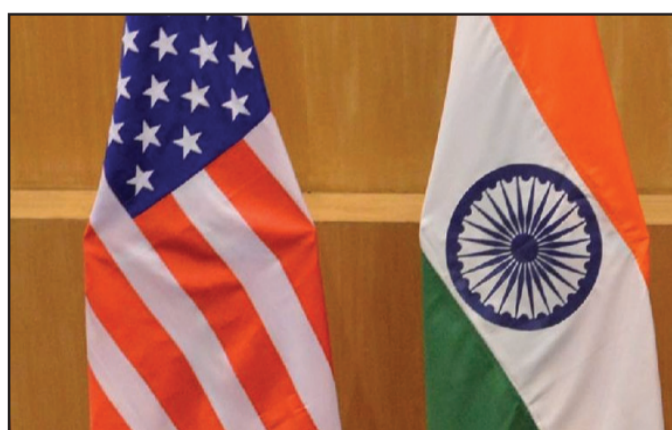
being ascertained. The crew members were rescued by a vessel which was passing by. In this incident, one Indian on the dhow died while four received burn injuries. The injured are receiving medical treatment in Dubai and are safe." The source further stated that officials from the Indian Consulate had met the rescued Indian nationals on Friday night and were coordinating with the dhow owner while extending all

possible support and assistance to the crew members and their families. Earlier on Friday, the Consulate General of India in Dubai had also confirmed the incident through a post on X, expressing grief over the death of the Indian crew member. "The Consulate is saddened to learn of the unfortunate incident at Sea that caused the tragic death of an Indian crew member of a ship. The Consulate is in touch with the owner of the ship and is

ascertaining further details. The Consulate will render all possible assistance in this matter on priority. Our deepest condolences," the Consulate stated. The latest maritime incident comes amid worsening instability in West Asia and growing risks to commercial shipping routes in and around the Strait of Hormuz, a key global energy transit corridor. The conflict in the region intensified after joint US-Israel strikes targeted Tehran on February 28, resulting in the death of Iran's Supreme Leader Ayatollah Khamenei. In response, Iran launched retaliatory attacks on Israel and on US military bases located across Gulf nations. The hostilities have also contributed to disruptions and blockades around the Strait of Hormuz, increasing risks for commercial vessels operating in the area. Similar incidents involving attacks or threats to Indian crew members have also been reported in the past.

US-India Push AI Defence Cooperation

Washington, 9/5: The United States and India must step up cooperation in artificial intelligence and defence as warfare shifts to data and algorithms, experts said. Speaking at a US-India forum, Vivek Lall, Chief Executive of General Atomics Global Cooperation, and Lt Gen (Retd) Raj Shukla said the nature of war is changing fast. The session was moderated by Sameer Lalwani of the Special Competitive Studies Project. Shukla said AI is already shaping the battlefield. "AI is not futuristic... algorithmic warfare is arrived, and it will change the workflows of combat forever," he said. He said militaries must adapt quickly. "Military is conservative organizations don't update their process once a year... in Ukraine... software innovations are being delivered every two weeks, hardware every four weeks," he said. He called for a



major shift in defence systems. "Departments of Defense... now need to operate as software companies," he said. Shukla said India needs stronger debate and thinking on these issues. "Ideation in these domains in India has to strengthen," he said. Lall said no country can lead alone in new technologies. "No one country has remarked on the

best ideas," he said. He said the US and India together can deliver results. He pointed to the need for cooperation across industry and academia. "Universities vocational institutes... play a great role, because at the end of the day, it's global talent," he said. Lall listed key areas for joint work. These include data sharing, training, and control of the

electromagnetic spectrum. Shukla also flagged the cost factor in modern war. "For every \$1 that the Iranians spent... it took the Americans... \$28 to intercept," he said. He said India must break silos across sectors. "Civil, military, private sector, government Academy... operated in science," he said. Both speakers said the partnership is at a key moment. Lall said, "We're at an inflection point," and added that the next decade could see "a lot of co development work... a lot of co production work." The United States and India have expanded defence ties over the past two decades. This includes joint exercises and technology partnerships. AI and emerging technologies are now central to the relationship. Both countries are working to build capabilities in data, autonomous systems and next-generation warfare.

Attacks On Civilians In Democratic Republic Of Congo Raise Alarm: UN



United Nations, 9/5: A new wave of deadly attacks against civilians in the eastern Democratic Republic of the Congo (DRC) has raised alarm, a UN spokesman has said. In the last three days, at least 34 civilians have reportedly been killed in a series of attacks in Ituri and North Kivu provinces, said Farhan Haq, deputy spokesman for the UN secretary-general on Friday (local time), quoting the UN Office for the Coordination of Humanitarian Affairs. In Ituri's Irumu and Mambasa, attacks reportedly killed at least 15 civilians between Tuesday and Thursday. The violence forced people to flee to neighbouring

villages in North Kivu province, said Haq. In North Kivu's Oicha, an attack by an armed group near the border with Ituri province reportedly killed at least 19 civilians on Tuesday and Wednesday. Local partners reported that several civilians were attacked while working in their fields, and other people remain missing, he said. In Ituri's gold-rich Mambasa, at least 130 civilians have reportedly been killed and more than 500 others abducted since mid-March. The violence has displaced over 68,000 people within Mambasa and into neighbouring Tshopo province, while more than

310,000 people have also been displaced across Beni and Lubero territories in North Kivu province, said the deputy spokesman. "Our humanitarian partners are currently assessing displacement and urgent needs," said Haq. "As you can imagine, these attacks are heightening humanitarian and protection concerns in the northern parts of eastern Democratic Republic of the Congo. We reiterate our call on all parties to the conflict to immediately cease attacks against civilians and on all parties to uphold their obligations under international humanitarian law," he added.

Indian Ambassador Vinay Kwatra Backs 'AI For All' Vision

Washington, 9/5: India is pushing for the "democratisation of AI" while expanding technology cooperation with the United States, Ambassador Vinay Kwatra said at the US-India AI and Emerging Technology Forum. Speaking at an event here, Kwatra said the recent AI summit in India brought together global leaders, scientists and industry to shape a shared vision. "One of the driving thrust... was eventually the democratisation of AI," he said. He explained the idea as wider

access to AI outcomes. "If the end product of this technology is intelligence... the diffusion of that intelligence has to be democratised for the benefit of people," he said. Kwatra said Prime Minister Narendra Modi's approach is clear. "AI for all in many ways," he said, adding that the idea was captured in the New Delhi Declaration. He said the summit showed convergence across global innovation systems. "You saw convergence of the multiple innovation

ecosystem," he said. Kwatra said more than 20 heads of state and government attended, along with global research communities. He also pointed to growing India-US cooperation. "We could also sign a joint cooperative framework between India and the US in this space," he said. Kwatra said the partnership spans technology, innovation and manufacturing. These links are shaping supply chains and economic activity.

Nifty, Sensex Rise Notably This Week As Crude Prices Ease, Rupee Strengthens

Mumbai,9/5: The Indian equity benchmarks posted notable gains during the week over easing crude prices, a firmer rupee and softer 10-year bond yields despite lingering geopolitical tensions. Nifty gained 0.76 per cent during the week and dipped 0.60 per cent on the last trading day to reach 24,180. At close, Sensex was down 516 points or 0.66 per cent at 77,328. It advanced 0.54 per cent during the week. "The improvement in macro conditions shifted sentiment from early-week caution to a more constructive stance, allowing markets to absorb profit booking triggered by fresh headlines towards the end of the week," an analyst said.

Investor confidence was further supported by favourable state election outcomes and Q4 earnings that came in better than cautious expectations. Midcap and smallcap indices outperformed benchmark indices, while sectors such as autos, defence, realty, and pharma witnessed strong buying interest. Nifty Midcap100 added 3.49 per cent, while Nifty Smallcap100 gained 4.05 per cent during the week. While stable crude prices and rupee recovery offer near-term support, a renewed escalation in West Asia remains a key risk, particularly for commodity-sensitive sectors,



they added. The markets ended lower on the last day of the trading week as the United States and Iran exchanged fire which prompted investors to reassess expectations of a near-term peace deal and rekindled energy supply chain concerns. Iran claimed the US had violated the ceasefire agreement. However, US President Donald Trump reaffirmed that the ceasefire remained in effect, and Iran said the situation has returned to normal. Brent crude oil declined over 3 per cent in international markets to trade below the \$95-per-barrel mark, while domestic crude futures slipped below the Rs 9,000 level,

reversing much of the previous session's escalation-driven rebound. Meanwhile, Nifty 50 is expected to see the 24,250-24,300 level as an immediate resistance zone and the 24,100-24,000 band remains a crucial support area, market participants said. In Bank Nifty, a sustained move above 55,500 could extend the recovery toward 55,800-56,000, strengthening near-term momentum, they added. Investors remain keen on cues from India and US inflation data, along with domestic credit growth trends, as these will influence RBI rate expectations and corporate margin outlook.

CBDT Plans Recovery Drive For Rs 2.57 Lakh Crore Tax Arrears: Report

New Delhi,9/5: The Central Board of Direct Taxes is stepping up efforts to recover Rs 2.57 lakh crore in confirmed tax demands in the current fiscal year, a report has said. Under the enforcement drive, special teams will track the top 10,000 high value arrears cases nationwide in FY27, the tax department officials told NDTV Profit. Tax recovery and compliance monitoring will see a technology-driven push from artificial intelligence, data analytics and digital forensics, they said. The CBDT officials said recovery teams may also use the CERSAI mortgage and asset database to trace properties and secured assets linked to defaulters. The tax department will monitor top advance tax payers and identify misuse of

exemptions and deductions, it added. In FY26, the board disposed of 2.24 lakh appeals involving disputed demand of Rs 8.27 lakh crore. Pending appeals have declined from 5.40 lakh to 4.95 lakh during FY26, the department officials said, adding that directions have been provided to officers to focus on recovery from non-compliant taxpayers. FY27 direct tax collection target stood at 26.97 lakh crore as per the Budget 2026. Moreover, India's direct tax collections inched up moderately in FY26 on an annual basis but missed the government's revised estimates, due to evolving macro-economic conditions. Net direct tax collections rose 5.1 per cent year-on-year to Rs 23.4 lakh

crore in FY26 as per provisional data, short of the Revised Estimate (RE) of Rs 24.21 lakh crore by approximately Rs 81,000 crore, highlighting weaker-than-anticipated buoyancy in tax revenues. The government's newly implemented Income Tax Act 2025 has made India's tax system simpler, easier to understand and more taxpayer-friendly, Chief Commissioner of Income Tax (IT & TP) Nirupama Kotru said on Friday. Speaking to IANS on the sidelines of an awareness programme here, she said the reforms are aimed at helping ordinary citizens file returns without confusion and reducing dependence on tax professionals for basic compliance.

SEBI Mulls Additional Changes To Strengthen Buyback Framework

Mumbai,9/5: The Securities and Exchange Board of India (SEBI) has proposed additional measures to its plan to reintroduce open-market buybacks through stock exchanges, including a shortened completion timeline and new safeguards for minority shareholders. SEBI, after consultation with the Primary Market Advisory Committee (PMAC), said companies would be allowed to undertake open-market buybacks which must be completed within 66 working days from the offer opening, and must use at least 40 per

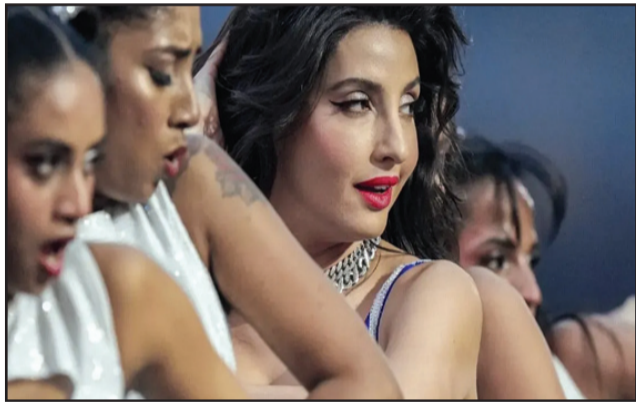
cent of the buyback size within the first half of the offer period. The regulator said a 66-day timeline is warranted due to recent changes under the Finance Act, 2026 to the Companies Act, with respect to the permissible gap between two buyback offers, which necessitates a balanced approach. The regulator said that a six-month-long period proposed by PMAC may make buybacks irrelevant in the context of market developments and could prove difficult for shareholders to track. As an additional safeguard,

SEBI may direct freezing of shares and other specified securities held by promoters and their associates at the ISIN level during the buyback period. Existing rules bar promoters from dealing or transferring company shares from the board decision until the buyback closes. The regulator has proposed removing the requirement for a separate trading window for buyback transactions and conducting such trades through the normal market mechanism. Further, it proposed dispensing with the requirement to display the company's identity as a

purchaser on the trading screen. The regulator also proposed introducing an explicit provision to ensure buybacks do not breach minimum public shareholding norms and aligning the interval between two buyback offers with provisions under the Companies Act, 2013. It also mulls making companies mandatorily send an intimation to shareholders through electronic mode regarding the buyback offer within one working day of such public announcement.

Nora Fatehi set to perform at FIFA World Cup 2026 opening ceremony in Toronto

Bollywood star and dance sensation Nora Fatehi has been confirmed to perform at the FIFA World Cup 2026 opening ceremony on June 12 at BMO Field in Toronto, Canada, making her one of the most prominent Indian performers on a global stage. She will join a star-studded lineup of Canadian and international artists, including Michael Bublé, Alanis Morissette, Alessia Cara, Elyanna, Jessie Reyez, Sanjoy, Vegedream, and William Prince. The opening ceremony in the USA will feature global music icons Anitta, Future, Katy Perry, Lisa, Rema, and Tyla, highlighting the World Cup's celebration of international music, culture, and entertainment across the three co-hosting nations. FIFA President Gianni Infantino described the Toronto event as "a powerful reflection of Canada's identity," adding that it would welcome the world through music and culture in a celebration that is "uniquely Canadian while also connected to a larger story unfolding across Mexico and the United States." The FIFA World Cup 2026 is set to be the largest tournament in history, with 104 matches across 16 host cities. The opening match will take place on June 11 in Mexico City, while the grand final is scheduled for July 19 at the New York New Jersey Stadium. Nora Fatehi, 34, made her acting debut in the 2014 Hindi film *Roar: Tigers of the Sundarbans* and rose to fame through special appearances in Telugu blockbusters like *Temper*, *Baahubali: The Beginning*, and *Kick 2*. RR vs GT IPL 2026 Match 52 Preview as Playoff Battle Intensifies in Jaipur

NEWDELHI: Rajasthan Royals aim to protect their top-four standing against an surging Gujarat Titans unit at the Sawai Mansingh Stadium this Saturday. Both squads enter this 52nd fixture of the season tied on 12 points, making this encounter a virtual four-pointer for postseason qualification. While the hosts recently suffered a setback against Delhi, the visitors arrive in Jaipur carrying the momentum of a three-match winning streak. Skipper Riyan Parag remains the central figure for the home side after his valiant 90-run effort in the previous outing. His leadership faces a stern test against a Gujarat bowling attack led by a disciplined Jason Holder and the pace of Mohammed Siraj. The Royals will rely heavily on their young opening pair, Yashasvi Jaiswal and Vaibhav Sooryavanshi, to set a high tempo during the powerplay overs. Jaipur's surface traditionally offers a balanced



contest, though recent games suggest a high-scoring trend with averages crossing 210 runs. Boundary dimensions here are larger than most Indian venues, which might bring veteran spinners like Ravindra Jadeja into play during the middle phase. Dew is expected to influence the second innings, often prompting captains to choose

chasing upon winning the toss. Historically, Gujarat Titans have held a dominant grip on this rivalry, winning six out of their last eight meetings. However, the Royals can take confidence from their narrow six-run victory against the Titans earlier this April. This venue holds deep significance for local fans, as it was the fortress

that helped Rajasthan secure the inaugural title back in 2008. Gujarat's resurgence is largely credited to the consistency of Sai Sudharsan and the tactical calm of Shubman Gill. With both teams desperate to avoid the mid-table scramble, tonight's result could dictate the final composition of the 2026 knockout bracket.

'His Vision Is Very Clear': Sumit Rathi Praises Coach Khalid Jamil Approach Towards Players

New Delhi, 9/5: Indian footballer Sumit Rathi has praised new India head coach Khalid Jamil for creating a positive atmosphere in the national team setup and increasing competition among players through a simple and clear approach. Rathi said Indian coaches understand Indian players better and highlighted it as one of Jamil's biggest strengths since taking charge of the national team. "To be honest, Indian coaches understand Indian players better. That is a fact. That is a plus point in the atmosphere of the current national team. It is very important for any country. His vision is very

clear. He won't go to the players and say that you have to do this. He won't complain that we didn't play in one style or didn't get enough training sessions. He tells us to do what is our strong point," Rathi told IANS. "He will never force the players to do what he wants. You have to do what you can do best, what you have been doing for your club and country, but you have to find the best version of that," Rathi added. The 48-year-old Khalid Jamil became the first Indian in over a decade to take charge of the men's national team full-time in August last year. He immediately stabilised the team by leading a depleted squad to a bronze medal at the

2025 CAFA Nations Cup, featuring wins over Tajikistan and Oman, which showed some good signs for the future. Rathi also credited the coach for creating healthy competition within the national team setup by rewarding players based on current performances rather than reputation. "He has created an atmosphere and increased the competition level. He doesn't think about whether a player is from ISL or I-League. He gives chances to the players he likes and the ones performing well for their clubs. The player who does well should get a chance. He should be called to the camp and given a chance to represent the national team. These things

are very important in any sport," he added. He further revealed that Jamil personally watches both ISL and I-League matches closely, something he believes has positively impacted player morale. "Khalid sir personally watches the matches. It doesn't matter whether it is ISL or I-League. I think he has done two or three things very well since joining the national team," Rathi said. Widely respected in Indian football circles, Jamil made history by guiding Aizawl FC to a remarkable I-League title in 2017 and later impressed with clubs like NorthEast United FC and Jamshedpur FC in the ISL.
