## Delhi Announces 2 Days Of WFH A Week In Government Offices

New Delhi: Delhi Chief Minister Rekha Gupta announced two days work from home for government offices, minimum use of vehicles, in line with Prime Minister Narendra Modi's appeal for fuel conservation amid rising global uncertainties. The Chief Minister has also reduced her official carcade by nearly 60 per cent, bringing it down to just four vehicles. The revised convoy structure now includes only four vehicles, two of which are electric vehicles (EVs), marking a notable shift towards cleaner and more sustainable mobility in official travel. The BJP-led

government is launching a campaign "Mera Bharat Mera Yogdan" (My India, My Contribution) in the national capital to promote fuel saving and efficient governance. Every Monday will be observed as "Monday Metro", the government said, adding all ministers, officers, and employees will commute by metro. The government has also appealed to the general public to observe one "No Vehicle Day" every week. There will not be any new purchase of a petrol, diesel, or electric vehicle for the next six months, it said. The transport allowance for employees,

the government said, will be increased by 10%. There's also ban on foreign Travel. No Minister or officer of the Delhi government will undertake any official foreign trip for the next one year, it said. Additionally, a 90-day campaign will be run to spread awareness. Citizens will be administered a pledge to promote savings and contribute towards nation-building, the government said. To reduce electricity consumption, it has been decided that air conditioners in all government offices will be set between 24 to 26 degrees Celsius. Master switches will be



installed in government offices to prevent unnecessary wastage of electricity. Addressing a public

meeting organised by the BJP at Parade Grounds in Secunderabad on Sunday, PM Modi had urged citizens to collectively contribute

towards protecting the Indian economy from the ripple effects of the ongoing conflict in West Asia. He went on to highlight

the challenges posed by various factors such as global supply chain disruptions, rising fuel prices, and increasing economic uncertainty resulting from international tensions. In this context, PM Modi appealed to citizens to conserve fuel, use Metro rail and public transport wherever possible, adopt car-pooling, and increase the use of electric vehicles. He also encouraged industries and offices to revive work-from-home arrangements, online meetings, and virtual conferences - measures that had proven effective during the Covid-19 period in reducing fuel consumption

and improving efficiency. Importantly, he also appealed to citizens to avoid non-essential purchases of imported goods and unnecessary overseas vacations in order to conserve foreign exchange reserves. "This is not austerity. It is economic prudence," say experts. The distinction matters because austerity implies the state's withdrawal of expenditure from the economy. PM Modi and Union Home Minister Amit Shah have reduced the number of vehicles in their convoys, while efforts are also being made to increase the use of electric vehicles in official movement.

## Madhya Pradesh HC grants Hindu side right to worship, sets aside 2003 order permitting Namaz

New Delhi: In a significant development in the long-standing Bhojshala-Kamal Maula Mosque dispute, the Indore Bench of the Madhya Pradesh High Court has delivered a historic verdict, granting the Hindu side the right to worship and recognising the complex as belonging to Raja Bhoj. Addressing media personnel after the court's order, Vishnu Shankar Jain, representing the Hindu side, termed the judgment as "historic," noting that the court has partially set aside the Archaeological Survey of India's (ASI) order dated April 7, 2003. "The Indore High Court has delivered a historic verdict, partially setting aside the ASI's order dated April 7, 2003. Furthermore, the Court has granted the Hindu side the right to worship and has recognised the Bhojshala complex as belonging to Raja Bhoj," Jain said. The advocate further revealed that the court addressed the demand for the repatriation of the idol, which is currently housed in a museum in London.

idol currently housed in a London museum, the Court has directed the government to consider this request; the Court also noted that the Muslim side is free to present its views before the government as well. Additionally, the Court has asked the government to consider allocating alternative land to the Muslim side. In an effort to provide a resolution for the other party, Jain said that the court has suggested the allocation of alternate land for the Muslim side. "The Court has granted us the right to perform worship rituals and has directed the government to oversee the management of the site. The ASI's previous order, which granted the right to offer Namaz (prayers), has been completely set aside; henceforth, only Hindu worship shall take place there," he added. Later, speaking to ANI, the advocate said the court ruled that Bhojshala was built by King Bhoj as a Maa Saraswati shrine and a Sanskrit learning centre, set aside part of the 2003 order

on Namaz at the site, and directed the government to consider bringing back the Maa Saraswati idol from the British Museum. He added that the Muslim side may seek alternate land for the Namaz and a mosque in the Dhar region. "It has today been established that the entire Bhojshala complex was indeed constructed by King Bhoj. It served as a shrine dedicated to Maa Vagdevi (Maa Saraswati)--a renowned School of Sanskrit Learning and a temple dedicated to her worship. Furthermore, regarding the Muslim community members who have been offering Namaz at this site illegally, the Court has today set aside that specific portion of the order issued on April 7, 2003. The Court has accepted all the arguments we presented. Additionally, regarding the idol of Maa Saraswati (Maa Vagdevi)--which is currently housed in the British Museum in London--the Court has directed the government to consider measures to facilitate its repatriation. Furthermore,

the Court has granted the Muslim side the liberty to submit a representation to the government requesting alternative land for offering Namaz and for a mosque; the government will consider such a request in the Dhar region," he told ANI. He further said the Court held that Bhojshala falls under the ASI's 1951 notification and the ASI Act, 1958, with ASI retaining full control of the site, while permitting the Hindu side to perform Pooja and rituals there under Section 16. "This property falls under the purview of the ASI notification issued in 1951. The Bhojshala complex is listed under Entry Number 90 of that notification, and the site is governed by Section 16 of the ASI Act, 1958. Therefore, the ASI shall retain total dominion and control over the site. However--in consonance with Section 16--the Court has granted the Hindu side the right to perform worship and rituals at the site." Meanwhile, Dhar Shahar Qazi Waqar Sadiq, on the verdict, expressed

disappointment and said he will challenge the verdict in the Supreme Court. "We will review the decision that has been given against us. We will challenge the verdict in the Supreme Court..," he said. The Hindu side have argued that the Bhojshala complex, is a temple dedicated to Goddess Vagdevi (Saraswati), while Muslims believe that it is the site of the Kamal Maula mosque. On May 12, the Indore Bench of the Madhya Pradesh High Court reserved its decision following final arguments. A division bench of Justice Vijay Kumar Shukla and Justice Alok Awasthi was hearing the matter regularly from April 6 and heard all the parties concerned, including petitioners, respondents, interveners and the Archaeological Survey of India (ASI). According to an arrangement in 2003, Hindus perform puja at the complex on Tuesdays from sunrise to sunset, while Muslims offer namaz on Fridays from 1 pm to 3 pm.

## PM Modi reaffirmed he will visit Russia this year: Russian FM Lavrov

New Delhi : Russian Foreign Minister Sergey Lavrov on Friday said that Prime Minister Narendra Modi has reaffirmed that he will visit Russia later this year during their talks on Thursday, as both countries continue preparations for the upcoming BRICS summit. Speaking at a press conference in India after the BRICS Foreign Affairs Meeting, Lavrov said Moscow remains committed to expanding its "privileged strategic partnership" with India across multiple sectors. "We are preparing for the BRICS summit. Prime Minister Narendra Modi yesterday reaffirmed that this year it's his turn to make a visit to the Russian Federation. We will be preparing for this top-level summit", Lavrov said. Highlighting the breadth of India-Russia cooperation, Lavrov said the partnership spans several sectors and continues to deepen with mutual interest from both sides. "If we list all the areas where we cooperate, well, it will take all of this day, probably more," he remarked. Lavrov further said that both countries are increasingly shifting towards settlements in national currencies and reducing dependence on the US dollar in bilateral transactions. "Our settlements with India were going away from dollars to using national currencies and the currencies of other countries that do not abuse their position in the global financial institutions," he said. The Russian Foreign Minister also underlined Moscow's openness towards expanding cooperation in areas of interest to India.

"There are no restrictions that you have mentioned in any area for us. We are open to everything that our Indian partners are interested in," Lavrov said, adding that Russia has not encountered any major issues in bilateral cooperation and does not expect difficulties going forward. The remarks come amid continued engagement between New Delhi and Moscow on trade, energy, connectivity, and strategic cooperation under the framework of their longstanding bilateral partnership. Earlier on Thursday, Prime Minister Narendra Modi received the Russian Foreign Minister and reiterated India's consistent support for the peaceful resolution of conflicts amid discussions on Ukraine and West Asia. In his post shared on X, Prime Minister Narendra Modi thanked Lavrov for sharing an update on progress across the facets of the Special and Privileged Partnership between New Delhi and Moscow. As per the Prime Minister's Office, Lavrov briefed PM Modi on the progress achieved in bilateral cooperation since the meeting of the two leaders in December 2025 for the 23rd India-Russia Annual Summit. The leaders also exchanged views on several of the pressing geopolitical concerns, including Ukraine and West Asia. He reaffirmed the consistent support for a peaceful resolution. "We also exchanged views on various regional and global issues, including the situation in Ukraine and West Asia. Reiterated our consistent support for efforts aimed at peaceful resolution of conflicts," PM Modi stated in a post on X.

## Strong public consensus emerges in favour of Aditya Aluminium expansion project.

Sambalpur-15/05(DMS) The public hearing for the proposed expansion of Hindalco Industries Limited's Aditya Aluminium plant at Lapanga on 15th may witnessed overwhelming support from local people and Panchayat Raj Institution (PRI) representatives, who unanimously endorsed the project, citing employment generation and long-term socio-economic benefits for the region. Held in the presence of district administration officials, representatives of the Odisha State Pollution Control Board (OSPCB), and members of the public, the hearing was conducted under the provisions of the EIA Notification, 2006, for environmental clearance of the proposed expansion of the aluminium smelter and captive power plant. According to participants at the meeting, local villagers

from nearby areas including Lapanga, Bomaloi, Derba, Khadiapali, Tileimal and Dharopani voiced strong support for the expansion proposal. Many speakers said the project would create new livelihood opportunities for local youth and further accelerate development in the industrial belt of Sambalpur district. Significantly, the company officials highlighted that the proposed expansion is a brownfield project to be executed entirely within the existing plant premises, eliminating the need for fresh land acquisition, displacement, rehabilitation or resettlement. "The expansion will open doors for employment and business opportunities for local people. A resident of Laumal village, Mr. Haldhar Makar, expressed full support for the expansion of

the Aditya Aluminium project. During the hearing Ms. Sulochana Pradhan of Dharopani Village under Bomaloi Gram Panchayat said, "We wholeheartedly support the expansion of Aditya Aluminium plant of the Aditya Birla Group, as it has opened up valuable employment opportunities for our community. Most importantly, the company has empowered women and young girls from our village -- many without formal education -- by providing them with dignified livelihoods. This has enabled us to contribute to our household income and lead a more secure and happy family life." The proposal seeks expansion of the aluminium smelter capacity from 6.8 lakh tonnes per annum (LTPA) to 9.0 LTPA and enhancement of the captive power plant



capacity from 1230 MW to 1530 MW. Jagannath Prasad Nayak, Unit Head of Aditya Aluminium, Lapanga informed that the project would generate employment for around 1,169

additional persons, with preference to local candidates. Beyond its industrial footprint, Hindalco Industries continues to drive community development in Odisha through extensive CSR

initiatives benefiting 1.42 lakh people across 63 villages in Sambalpur district. The company's interventions span education, healthcare, women's empowerment and livelihoods, including Aditya Birla Public

Schools, digital classrooms, libraries, science centres, remedial learning and competitive exam coaching. In healthcare, Hindalco runs nine dispensaries serving nearly 70,000 patients annually, along with Swasthya Vahini mobile health units reaching around 36,000 people each year. Livelihood initiatives include Project Unnati, supporting over 1,000 farming families, and Project Shakti, which empowers nearly 3,000 women through 268 self-help groups. ## Another person gets 20 years in prison in a gang rape case, Earlier one get 20 years RI and 2 others are still absconding

Keonjhar : Keonjhar Fast Track Court Judge Bijay Kumar Mishra today sentenced a person to 20 years in prison and fined him Rs 10,000 in a gang-rape of a 16 year old minor girl. For nonpayment of the fine, the court ordered an additional 6 years in prison. The convicted person is Ramesh Naik (20) of Bamebari police station area. Earlier Pradeep Naik (25) was convicted and the other two involved in the incident are still absconding, and a non-bailable arrest warrant has been issued against them.

According to Special Public Prosecutor Patitapaban Nath, on February 13, 2021 the Child Line

of Banspal block received an information that a 16 year old girl, who was 7 months pregnant, was living in the house of a goat herder in Nayakot police station area. On the same day the Child Line rescued the victim and placed her in the Sakhi One Stop Center, District Headquarter Hospital, keonjhar. During the counseling, the center's director came to know that she was 7 years pregnant. The said victim was found to have been a victim of gang rape by multiple people.

In this regard, the center's director, Aishwarya Sanghamitra Das, gave a written complaint to the Nayakot police station on 13

July 2021. The police registered a case based on the complaint and conducted an investigation. During the investigation, evidence was found against Manu Pradhan, Pradeep Naik, Asadhu Pradhan and Ramesh Naik in this incident and a case was registered under POCSO Section 6.

The police arrested Pradeep and tried him in court. The other accused, Manu Pradhan, Asadhu Pradhan, are absconding. However, today the court passed the above sentence based on the statements of 20 witnesses and the police investigation report while hearing the case.

# MSJK Hospital: Expanding Healthcare Access in Rural Lanjigarh

Bhubaneswar 15 May 2026 : Kalahandi, a district in Odisha that was once associated with poverty and limited access to basic amenities, has witnessed a steady transformation in how essential medical services reach rural communities. At the centre of this shift is the Maa Santoshi Jankalyan (MSJK) Hospital, which has emerged as an important healthcare support centre for people living in the remote parts of Lanjigarh and surrounding areas.

For years, families in this region had to travel long distances to access even basic treatment facilities. Delayed medical care often worsened health conditions, especially for pregnant women,

children, elderly people, and those suffering from diseases prevalent in the area, such as malaria and filaria.

MSJK Hospital was established in the year 2000 to serve nearly 8,000 people across 70 villages in 4 Gram Panchayats. Its reach, however, expanded significantly after Vedanta partnered with the hospital in 2014. With the company's support, MSJK Hospital now caters to 120 villages across 12 Gram Panchayats, benefiting nearly 20,654 people annually. The hospital has helped improve access to quality medical care in one of Odisha's remotest regions, offering essential treatment and timely medical support to communities that

previously had limited access to healthcare. Located around 25 km from Lanjigarh, it remains a key healthcare centre for the Bankakundru region and beyond.

The impact is visible beyond numbers. Pregnant women, who earlier faced serious risks due to limited maternal care, now have access to specialised medical attention at the hospital. Children are able to avail of regular vaccinations and health check-ups. Patients suffering from malaria, diarrhoea, sickle cell anaemia and other illnesses can receive treatment closer to their homes.

"Earlier, it was very difficult for us to access medical care, and many had



to rely on traditional remedies or unregistered medical practitioners in the hope of curing our illnesses. The MSJK Hospital has been a true blessing for the region and helps keep us healthy and happy" said, Bharat Majhi, a resident of

Lanjigarh. Healthcare access has also moved beyond the hospital premises. Through Vedanta's Mobile Health Units, expert doctors and nurses are able to reach remote villages more easily, helping detect illnesses early and reducing the need for emergency hospitalisation. This has allowed many families to receive medical attention within their communities, eliminating the need for travelling long distances.

Emergency care has also improved through the introduction of ambulance support, helping ensure faster medical intervention in critical cases. Vedanta-supported initiatives linked

to maternal and community healthcare have also been recognised under the Pradhan Mantri Surakshit Matrutwa Abhiyan, underscoring the role such interventions play in rural healthcare.

Today, MSJK Hospital stands as a vital healthcare institution for rural Lanjigarh. From a modest facility serving a limited population, it has grown into a dependable medical support system for thousands of people across the region, with extensive support from Vedanta. This reflects how sustained partnerships and targeted interventions can help strengthen healthcare access in underserved communities.

## Kerala Choice

THE Congress seems to have got so used to losing elections that it struggles to be decisive after it actually wins. The remarkable victory in Kerala was the face-saver for the party in the recent Assembly elections. Yet, the Congress took no less than 10 days to appoint VD Satheesan as the chief minister. It's true that the high command was spoilt for choice — experienced leaders such as KC Venugopal and Ramesh Chennithala were also in contention for the top post — but the inordinate delay in naming the CM exposed the Congress' familiar struggle with internal consensus-building.

In choosing Satheesan, the party appears to have rewarded political performance over hierarchy. Over the past five years, he emerged as one of Kerala's most prominent Opposition voices, consistently challenging the Left government on corruption and misgovernance. His sharp legislative interventions and energetic campaigning helped revitalise the Congress-led United Democratic Front (UDF) after its 2021 defeat. More importantly, he succeeded in projecting a younger and more assertive image of the party in the southern state.

Venugopal, who is close to Rahul Gandhi, has "humbly accepted" the top brass' decision, which aims to balance the party's state and national interests. His continued organisational role at the central level is vital for the Congress in view of the 2027-28 Assembly elections and the 2029 Lok Sabha polls. The party will expect Venugopal and Chennithala to provide tangible support to Satheesan, who has his work cut out. The new government must address youth unemployment (which prevails despite a high literacy rate), rising debt, infrastructure concerns and social welfare expectations, while maintaining unity among UDF allies. The Congress should make the most of this opportunity to assert its southern dominance through good governance.

## LPG Price

THE Rs 993 increase in commercial LPG prices, pushing the 19-kg cylinder beyond Rs 3,000, is striking as much for its timing as for its scale. Announced just days after Assembly elections concluded in four states, the move is bound to invite scrutiny. It suggests that price decisions, while driven by global pressures, may also be calibrated around electoral cycles. The hike itself was neither abrupt nor unexpected. Crude oil prices have climbed sharply in recent weeks, crossing the \$100-per-barrel mark amid escalating tensions in West Asia. Supply uncertainties and market volatility had already



made a price correction inevitable. In that sense, the increase was anticipated; only its timing raises questions.

The choice of timing — and of the segment — tells its own story. Domestic LPG prices remain untouched, sparing households a direct burden. Commercial users, however, face a sharp escalation. This distinction shifts the impact away from voters and onto businesses — restaurants, eateries and small vendors — who are more likely to absorb or pass on the costs. The effect will surface gradually in the form of higher food prices rather than immediate public discontent. For now, households have been shielded, but this respite may not last. If global crude prices remain elevated, pressure will inevitably build for a revision in domestic LPG and piped natural gas (PNG) tariffs as well. Such increases, if they come, are likely to be staggered and calibrated. But the burden would only have been deferred, not avoided.

When expected economic adjustments follow so closely on the heels of elections, it creates the impression that decisions are being timed as much by political convenience as by market logic. India's energy vulnerability is real, and periodic corrections are unavoidable. But when timing invites doubt, credibility becomes collateral.

# India's Missing Financial Multiplier

When Jitu Munda, a 50-year-old tribal man from Dianali village in the Kendujhar (Keonjhar) district of Odisha, India, walked into his nearest bank branch carrying his deceased sister's skeletal remains, he was not merely confronting bureaucratic indifference but he had also confronted a financial system he did not understand fully. After the death of his sister, who had some amount in her bank account, he reportedly struggled to withdraw it because he could not navigate the documentation required for a death claim. Asked repeatedly for proof of death, he exhumed her remains and carried them to the branch. The episode triggered outrage, administrative intervention and compensation promises.

The horror of the incident lay not simply in the grotesque image it produced. It exposed the missing layer in India's financial inclusion story: the country has opened bank accounts faster than it has equipped citizens to understand nominations, claims, documentation and the basic rules governing their own money. That distinction matters because India's first-generation financial inclusion project has been undeniably successful. Pradhan Mantri Jan Dhan Yojana has pushed total accounts beyond 55 Crore, nearly two-thirds of them in rural and semi-urban India. Digital payments have expanded rapidly. Welfare transfers increasingly move through formal channels. But access without comprehension creates ownership without agency.

As Annamaria Lusardi argues, personal finance is not merely about

individual well-being; it shapes the financial stability of countries. Financial literacy, in that sense, is economic infrastructure.

India's literacy challenge is no longer simply about reading. The more policy-useful benchmark comes from the RBI-NCFE's Financial Literacy and Inclusion Survey, which placed India's average score at just 11.7 out of 21. Based on the globally used Organisation for Economic Co-operation and Development/INFE framework, it measures financial knowledge (interest, inflation, risk diversification), financial behaviour (budgeting, bill payments, borrowing discipline), and attitudes such as long-term planning. That makes it more policy-relevant than the narrower Standard & Poor's survey, which found only 24% of Indian adults could correctly answer basic questions on inflation, compound interest, numeracy and risk diversification. One measures broad financial capability; the other measures strict conceptual mastery. Together, they reveal a deeper deficit. That deficit already carries visible costs. As per RBI, unclaimed bank deposits rose to Rs.78,213 Crore by March 2024 and the deficit is also reflected with the lapse of Insurance claims, stranded provident fund balances. Households save formally but often allocate inefficiently and this reflects India's missing financial multiplier.

The multiplier works through three channels. It improves savings efficiency by moving households from idle balances and dormant accounts into productive financial instruments. It improves credit

discipline by helping borrowers better understand repayment costs and respond rationally to interest-rate signals. And it strengthens household resilience through insurance, pensions and emergency preparedness.

When these channels remain weak, the macroeconomic costs compound: savings remain underutilised, credit quality deteriorates, households remain vulnerable to shocks, and financial deepening generates weaker returns for the broader economy. India expands financial access without fully converting household savings into capital formation. Money left unclaimed, poorly allocated, or locked in dormant accounts does not simply sit idle—it weakens credit intermediation, slows productive investment and reduces the growth impulse formal finance is meant to generate.

At its core, this is a productivity problem disguised as a literacy problem. A household that cannot claim its insurance delays recovery after a health shock. A worker who cannot transfer provident fund savings loses long-term returns. A family that keeps savings idle or falls for fraud reduces investible surplus. Multiply these micro failures across millions of households, and the result is slower capital formation, weaker consumption stability and lower long-term growth.

The global evidence also reflects this. A 2025 study covering 61 economies found that higher financial literacy improves GDP-per-capita growth, with the gains strongest in lower-income economies, and also delays the diminishing returns to financial-sector

expansion by over 7 per cent. Another study across 49 African economies found financial inclusion alone had no statistically significant effect on growth; gains emerged only when literacy improved alongside access.

India is not short of programmes. RBI runs Financial Literacy Centres. The National Centre for Financial Education designs national modules. Securities and Exchange Board of India funds investor awareness programmes, even as concerns persist over underutilisation and weak outcome tracking in parts of its education corpus. Yet success is still measured through camps organised, pamphlets distributed and accounts opened: not through nominee registration rates, dormant account reduction, claim settlement efficiency or sustained investment participation.

India's first generation of reform opened accounts. Its second-generation challenge is ensuring citizens can protect, inherit and grow what those accounts hold. Until financial literacy converts savings into productive capital, improves credit behaviour, and strengthens household resilience, India's missing financial multiplier will remain unrealised.

Jitu Munda received compensation. His village briefly entered national headlines. But unless his family, and millions like them, are equipped to understand the basic rules that govern their own money, India will keep expanding financial access without unlocking its full economic value.

## Long Screen Hours and Digital Dementia

Have you noticed that people today forget things more easily than before? Misplacing keys, mobile phones, pens, or important documents has become common. Many dismiss it as a natural part of aging, but the problem is not limited to older people. Increasingly, even children and young adults struggle with memory, attention, and concentration. One of the major reasons behind this growing problem is excessive dependence on digital devices and long screen hours.

The human brain, though weighing only a few hundred grams, is the most powerful organ in the body. Made up of billions of neurons, it controls every voluntary and involuntary function. The cerebrum, cerebellum, and brain stem work together with glands such as the thalamus, hypothalamus, pituitary gland, and medulla to regulate memory, thinking, emotions, movement, breathing, heartbeat, hunger, and body balance.

Like muscles in the body, the brain becomes stronger when it is used regularly. Activities such as memorising facts, solving mathematical problems, reading, recalling events, doing puzzles, or playing quizzes keep the brain active and improve cognitive abilities. Earlier generations often depended on mental calculations, remembered phone numbers, learnt multiplication tables by heart, and recalled historical events or scientific principles without depending on gadgets. Such constant mental exercise sharpened memory and analytical thinking.

Today, however, the situation is changing rapidly. Smartphones and calculators have taken over many basic mental functions. Even for small calculations or remembering simple information, people instantly reach for their phones. This growing dependence weakens the brain's natural ability to think, memorise, and analyse. Experts describe this condition as "digital dementia" — a decline in memory and cognitive abilities caused by excessive use of digital devices.

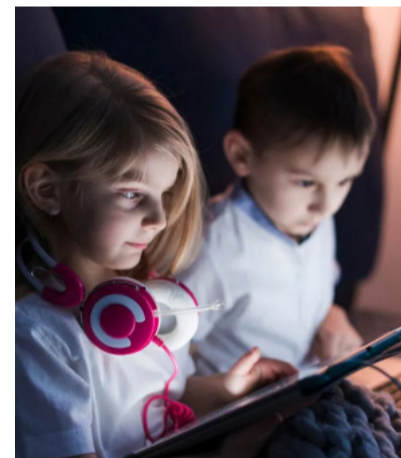
Digital dementia is marked by forgetfulness, poor concentration, inability to recall names, dates, events, or recent activities, and reduced attention span. The more dependent people become on devices, the less they exercise their own memory. Gradually, phones become smarter while human beings become mentally weaker.

Children and teenagers are among the worst affected. In many countries, concerns over excessive screen time have led to restrictions on smartphone use for children below the age of 12. Health experts often recommend limiting recreational screen exposure to less than two hours a day. Yet many children and young adults spend five to eight hours or more daily on mobile phones, gaming consoles, or laptops.

Excessive screen time not only affects memory. It also reduces physical activity, weakens muscles and bones, and affects

eyesight and posture. Many youngsters spend long hours with earphones or earbuds, exposing themselves to hearing problems and mental fatigue. Lack of outdoor activity further damages both physical and emotional health.

Scientists and psychologists now compare mobile addiction with substance addiction. Just as a drug addict becomes



restless without drugs, many people today feel anxious and uncomfortable when separated from their phones even for a short period. Continuous scrolling through social media, gaming, or watching videos stimulates the brain in unhealthy ways and reduces the ability to focus on meaningful tasks or relationships.

This growing dependence on technology is also affecting human relationships. Many people prefer virtual interaction over real conversations with family members, friends, or neighbours. Youngsters of the so-called Gen Z

generation often spend more time online than engaging with society around them. Social isolation, anxiety, and loneliness are increasing despite constant digital connectivity.

The rapid rise of Artificial Intelligence has added another dimension to the problem. Applications such as ChatGPT and similar AI tools are becoming part of daily life. While AI can be highly useful in education, communication, and professional work, overdependence on it may gradually reduce independent thinking and creativity. If humans stop using their own minds for analysis and decision-making, they risk losing critical

mental abilities.

Excessive mobile use is also affecting personal and family life. Long hours on phones create distance between couples, parents and children, and friends. Reports of broken relationships, emotional stress, and even extreme conflicts linked to digital addiction are becoming increasingly common. Technology, which was



designed to make life easier, is slowly controlling human behaviour.

The good news is that the problem can still be addressed. Reducing screen time is the first step. Avoiding unnecessary social media use, limiting entertainment browsing, and taking regular breaks from devices can significantly improve mental health. Instead of spending hours online, people should engage more in real-world activities such as meeting friends and relatives, participating in community events, reading books, travelling, or pursuing hobbies.

Children, especially, should be encouraged to play outdoor games, participate in cultural and extracurricular activities, and interact socially without depending on mobile phones. Schools and colleges can also help by restricting unnecessary smartphone use within campuses.

Experts also recommend activities such as meditation, yoga, deep breathing exercises, hiking, camping, swimming, music, and dance to improve concentration, memory, and emotional balance. Such activities stimulate the brain naturally and strengthen social bonds.

The brain grows stronger the more it is used. Mobile phones are undoubtedly useful devices that have transformed communication and access to information. However, misuse and overdependence can damage memory, critical thinking, relationships, and overall well-being.

The choice ultimately lies with us. We can either use technology wisely as a helpful tool or allow it to dominate our lives and weaken our minds. A healthy society depends on mentally active, emotionally balanced, and socially connected individuals — not people enslaved by screens.

According to the World Stroke Organization, one in four people worldwide is at risk of experiencing a brain stroke during their lifetime. Stroke remains one of the leading causes of death and disability globally, underscoring the urgent need for awareness on symptoms, risk factors, emergency response and rehabilitation, along with promotion of preventive lifestyle practices.

# India Issues Chair Statement After BRICS Meeting Amid Differences Over West Asia Conflict

New Delhi, 15/5: Insisting that there were differing views among members with regard to the situation in West Asia and the Middle East, India on Friday issued a chair's statement instead of a joint statement at the conclusion of the two-day BRICS Foreign Ministers' Meeting in New Delhi. The BRICS Ministers of Foreign Affairs reaffirmed their commitment to strengthening multilateral cooperation to address humanitarian crisis worldwide and expressed concern at the dwindling of international responses. They strongly condemned all violations of international humanitarian law, including deliberate attacks against civilians and civilian infrastructure, as well as the denial or obstruction of humanitarian access and the targeting of humanitarian personnel. The ministers underlined the need to address accountability for violations of international humanitarian law. They acknowledged international efforts made by BRICS members to promote respect for, adherence to, and effective implementation of International Humanitarian Law. "There were differing views among some members as regard



to the situation in the West Asia/Middle East region. BRICS members expressed their respective national positions and shared a range of perspectives. Views articulated by them included the need for an early resolution of the current crisis, the value of dialogue and diplomacy, respect for sovereignty and territorial integrity, upholding international law, the importance of safe and unimpeded flow of maritime commerce through international waterways, and the protection of civilian

infrastructure and civilian lives. The impact of recent developments on the global economic situation was stressed by many members. "The ministers expressed strong condemnation of any acts of terrorism as criminal and unjustifiable, irrespective of their motivation, whenever, wherever and by whomsoever committed. They condemned the terrorist attack in Jammu and Kashmir in April last year, which claimed 26 lives and injured several others." They reaffirmed their commitment to combating

terrorism in all its forms and manifestations, including the cross-border movement of terrorists, terrorism financing and safe havens. They reiterated that terrorism should not be associated with any religion, nationality, civilization or ethnic group and that all those involved in terrorist activities and their support must be held accountable and brought to justice in accordance with relevant national and international law. They urged to ensure zero tolerance for terrorism and rejected double

standards in countering terrorism," the statement said. They stressed the primary responsibility of nations in combating terrorism and the global efforts to stop and counter terrorist threats must fully comply with their obligations under international law, including the Charter of the UN, particularly the purposes and principles thereof, and relevant international conventions and protocols, in particular international human rights law, international refugee law and international humanitarian law, as applicable. The ministers welcomed the activities of the BRICS Counter-Terrorism Working Group (CTWG) and its five Subgroups based upon the BRICS Counter-Terrorism Strategy, the BRICS Counter-Terrorism Action Plan and the CTWG position paper. They looked forward to further deepening counter-terrorism cooperation. They called for an expeditious finalisation and adoption of the Comprehensive Convention on International Terrorism in the UN framework. They called for concerted actions against all UN designated terrorists and terrorist entities.

# Bengal CM Suspends 3 IPS Officers In RG Kar Rape-Murder Case, Orders Departmental Probe

Kolkata, 15/5: The new and the ninth Chief Minister of West Bengal, Suwendu Adhikari, on Friday announced the suspension of three Indian Police Service (I.P.S.) officers including a former Commissioner of the Kolkata Police in connection with the rape and murder of a lady junior doctor of state-run R.G. Kar Medical College & Hospital in Kolkata within the hospital premises in August 2024. Those suspended include the-then Commissioner of Kolkata Police, Vineet Kumar Goyal, the-then Deputy Commissioner of Police (North Division) Abhishek Gupta and the-then Deputy Commissioner of Police (Central Division) of the city police, Indira Mukherjee. Announcing their suspension on Friday, CM Adhikari said that a departmental probe will be initiated against all three of them. At the same time, he added, the role of the former West Bengal C h i e f



Minister, Mamata Banerjee, in the matter will also be reviewed. "After taking charge as the Chief Minister, also incharge of the state home department, I asked the Chief Secretary and the State Home Secretary, to submit a detailed and written report in the R.G. Kar matter and also on developments after the incident. "I wanted to know how the police officers incharge at that point in time handled the investigation. Now we have decided to take an administrative decision. As the state police minister, I declare that the main complaints against the two police officers were mishandling of investigation and not taking proper action by filing an FIR, among others," he said. Adhikari also claimed that there was an indirect attempt to bribe the victim's family.

# EAM Jaishankar Holds Bilateral Talks With Counterparts From Malaysia, Uganda And Cuba

New Delhi, 15/5: Deepening cooperation across various sectors, External Affairs Minister (EAM) S Jaishankar on Friday held a series of bilateral meetings with his counterparts from participating countries on the sidelines of the BRICS Foreign Ministers' Meeting in New Delhi. EAM met his Malaysian counterpart, Mohamad Hasan, with both sides reviewing the progress of the Comprehensive Strategic Partnership between the two nations. The two leaders also discussed the follow-up on the outcomes from Prime Minister Narendra Modi's visit to Malaysia in February this year. Sharing the details of the meeting on X, EAM posted: "Always good to meet FM Mohamad Hasan of Malaysia. Reviewed the progress of our comprehensive strategic partnership, including follow-up on the outcomes from PM Narendra Modi's visit to Malaysia earlier this year." EAM Jaishankar also met the Foreign Minister of Uganda, Odongo Jeje



Abubakar, as the two leaders discussed ways to expand bilateral cooperation across key sectors, including food and health security, while exploring greater technological collaboration and stronger business linkages. Taking to his X following the meeting, EAM posted, "Great meeting FM Odongo Jeje Abubakar of Uganda on the sidelines of BRICS India 2026 FMM. Our longstanding cooperation continues to advance. Discussed food and health security, as well as experience sharing, including the use of technology and

stronger linkages enabled by the Indian community and businesses." EAM also held talks with the Foreign Minister of Cuba, Bruno Rodríguez Parrilla, where the two sides reviewed bilateral cooperation in areas such as health, development initiatives and capacity building. Both leaders also exchanged an MoU for regular diplomatic consultations between the foreign ministries of India and Cuba. "Glad to meet FM Bruno Rodríguez Parrilla of Cuba. Discussed cooperation focusing on health, development partnership and capacity building.

# From 1951 To 2026, EC Tracks Voter Surge, Turnout In Assam, Bengal, TN, Kerala And Puducherry

New Delhi, 15/5: The Election Commission of India has released detailed data charting the electoral journey of Assam, Kerala, Tamil Nadu, West Bengal and the Union Territory of Puducherry from the first general and Assembly elections after Independence to the Assembly polls held in April and May 2026. The data highlights a sharp rise in voter strength over the decades, along with consistently high polling participation across these regions. The Election Commission of India (ECI) released the data under the theme "Chunav Ka Parv, Matdata Ka Garv", highlighting how the electorate in these four states and the Union Territory has multiplied several times over the decades, while voter turnout has remained among the highest in the country. Among all the states, West Bengal has recorded the highest latest polling percentage at 93.71 per cent in the Assembly polls, the highest since Independence. The state's electoral participation graph shows a steady climb from the



early decades after Independence, when polling remained below 50 per cent in the 1950s, to consistently crossing the 75 per cent mark from the late 1970s onwards in both the Lok Sabha and Assembly polls. The number of voters in the state has surged from nearly 76 lakh in 1951 to over 6.38 crore ahead of the 2026 Assembly election. Assam has also shown a remarkable rise in electoral participation in the just-concluded Assembly elections. The latest turnout figure stands at 86.33 per cent. The voter base

in the state has expanded sharply from around 24 lakh voters in 1951 to more than 2.16 crore voters in 2026. However, the Election Commission also points to a sharp drop in voters in the 1983 Assembly election, which was held amid the peak of violence in the state. The polling percentage was nearly 32 per cent. Several constituencies had witnessed extremely poor polling, making 1983 one of the most turbulent elections in Assam's history. In Tamil Nadu, polling participation has touched 86.03

per cent in the latest trend shown by the Commission. The state's electorate has grown from nearly 1.59 crore voters in the 1967 election to close to 4.94 crore voters for the 2026 polls. The turnout curve reflects stable and high public participation across successive elections, particularly from the 1970s onwards. Kerala recorded the latest turnout figure of 79.53 per cent in the April 9 Assembly polls. The state began its electoral journey with around 58 lakh voters in 1957 and has now crossed 2.16 crore electors. Kerala's polling percentage has largely remained within the high 70s and 80s across decades, reflecting sustained voter engagement. The Union Territory of Puducherry emerged as another standout performer with a turnout figure of 91.19 per cent. From just over 1.71 lakh voters in 1964, the electorate has expanded to nearly 8.67 lakh voters in 2026. Despite its smaller size, Puducherry has consistently recorded robust participation in Assembly elections.

# SC Announces Virtual Hearings, Car-Pooling, Partial WFH For Registry Staff

New Delhi, 15/5: The Supreme Court on Friday announced a series of fuel conservation measures, including virtual hearings on miscellaneous days, car-pooling by judges and Work From Home (WFH) arrangements for registry staff, in line with the Centre's broader push to cut fuel consumption amid the ongoing West Asia crisis. In a circular issued by Secretary General Bharat Parashar, the apex court said that matters listed on miscellaneous days — Mondays, Fridays or such other days declared as miscellaneous — as well as matters taken up during partial working days, will now be heard only through video-conferencing until further orders. "The Registry shall ensure that links for the video-conferencing are sent in a timely manner, maintain stable video-conferencing facilities and extend timely technical



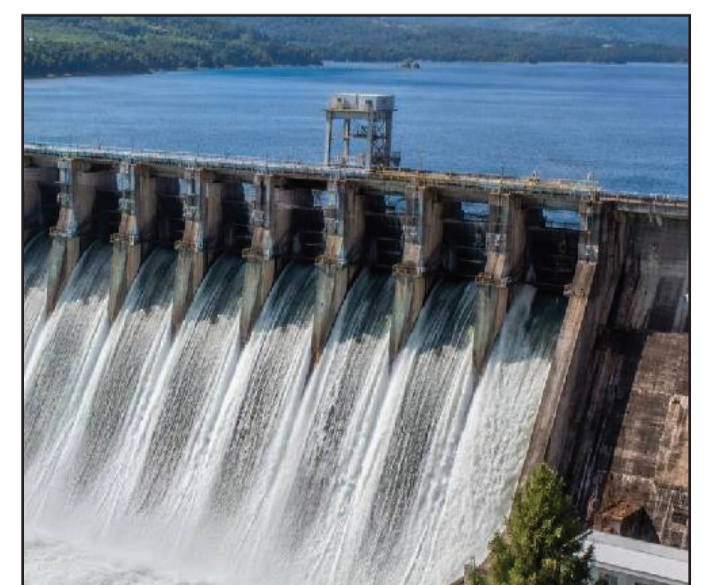
assistance so as to avoid any inconvenience to the Hon'ble Court," the circular stated. The Supreme Court also said that its judges have "unanimously resolved" to encourage car-pooling arrangements among themselves "to ensure optimum utilisation of fuel". In another significant step, the apex court permitted up to 50 per cent staff in each branch or section of the registry to

work from home for up to two days a week. The circular clarified that the remaining staff would continue to remain physically present in office to ensure uninterrupted functioning of the court administration. "The Registrar concerned shall ensure that a weekly roster is prepared before the commencement of the week," the circular said. It further directed that officials

permitted to work from home must remain available on telephone and be prepared to attend office whenever required. The circular also empowered concerned Registrars to restrict or modify the WFH arrangement in branches where the nature of work requires physical presence or where remote functioning is found ineffective. The measures come days after Prime Minister Narendra Modi appealed to citizens and institutions to reduce fuel consumption and avoid unnecessary expenditure in view of the economic pressures arising from the prolonged conflict in West Asia. Several state governments and organisations, including the Delhi government, have since announced fuel-saving steps such as WFH arrangements, promotion of public transport and curbs on official travel.

# Digital Tools, Rehabilitation Project Enhance India's Dam Safety And Ageing Resilience

New Delhi, 15/5: The Dam Rehabilitation and Improvement Project (DRIP), statutory oversight under the Dam Safety Act, 2021, and digital tools such as DHARMA are strengthening real-time monitoring, inspection and data-driven safety management of Indian dams, the government said on Friday. The nation is shifting focus from dam expansion to safety, resilience and lifecycle management to deal with the increasing age of its extensive network of large dams and changing climatic conditions, an official statement said. The DRIP is being implemented in phases to improve dam safety and operational performance. The aforesaid act provides surveillance, inspection, operation, and maintenance of the specified dam for the prevention of dam failure-related disasters. It also provides an institutional mechanism to ensure their safe functioning and for matters connected therewith or incidental thereto. The government



highlighted that India ranks third worldwide in large dams, with 6,628 specified dams, of which 6,545 are operational and 83 are under construction, and a combined gross water storage capacity of about 330 billion cubic metres. About 26 per cent or 1,681 dams, among them are more than 50 years old,

including 291 that are over 100 years old, the statement added. Around 42 per cent of dams fall within the 25-50 years age bracket. India's oldest, the Kallanai (Grand Anicut) in Tamil Nadu, has functioned for nearly 2,000 years, showcasing enduring engineering and maintenance.

## Africa CDC Confirms Ebola Outbreak In Eastern Congo

Kinshasa, 15/5: Health authorities have confirmed a new outbreak of Ebola virus disease in eastern Democratic Republic of the Congo (DRC) on Friday. Hundreds of suspected cases have been reported in Ituri Province, according to the Africa Centres for Disease Control and Prevention (Africa CDC).

Preliminary tests by the National Institute of Biomedical Research detected the virus in 13 of 20 samples, Africa CDC said in a statement, citing consultations with the DRC's Ministry of Health and National Public Health Institute. Xinhua news agency reported. About 246 suspected cases and 65 deaths have been recorded, mainly in Mongwalu and Rwampara, with four deaths among confirmed cases. Suspected cases have also been reported in Bunia. Africa CDC warned of a high risk of further spread due to urban settings,



population movement, mining activities, insecurity, and proximity to Uganda and South Sudan. The agency is convening an urgent meeting on Friday afternoon with health authorities from the DRC, Uganda and South Sudan, as well as key international partners, to strengthen cross-border coordination, surveillance and

response efforts. Africa CDC Director General Jean Kaseya stressed that rapid regional coordination is essential due to the high mobility between affected areas and neighbouring countries. Previously, on September 4, 2025, the DRC government confirmed an Ebola outbreak in Kasai Province in central DRC, the country's 16th

outbreak since 1976. The flare-up came amid an agitated public health environment, marked by the simultaneous resurgence of mpox, cholera, and measles across the country. The DRC, on December 2, 2025, declared an end to the previous Ebola outbreak in the country that killed 45. "On behalf of the government, and taking into account all the scientific and operational indicators confirming that the chain of transmission of the virus has been broken, I hereby officially declare the end of the 16th Ebola outbreak in the DRC," Health Minister Roger Kamba told a ceremony in the capital, Kinshasa. Ebola is a highly contagious hemorrhagic fever that causes symptoms such as fever, vomiting, diarrhoea, generalised pain, and malaise, and in many cases, internal and external bleeding, according to the WHO.

## PM Modi, UAE Prez Oversee Signing Of New Pacts To Boost Bilateral Energy, Economic Ties

Abu Dhabi, 15/5: Prime Minister Narendra Modi and UAE President Sheikh Mohammed bin Zayed Al Nahyan on Friday agreed to launch new initiatives to promote a comprehensive energy partnership. In this context, they welcomed the conclusion of a Strategic Collaboration Agreement between Indian Strategic Petroleum Reserves Limited and Abu Dhabi National Oil Company to enhance the UAE's participation in India's Strategic Petroleum Reserves to 30 million barrels, and to work together to set up strategic gas reserves in India, according to a Prime Minister's Office statement issued after the meeting between the two leaders in Abu Dhabi. They also welcomed the arrangement entered into between Indian Oil Corporation Limited and Abu Dhabi National Oil Company on long-term Liquefied Petroleum Gas supplies. The two leaders welcomed the announcement of



USD 5 billion in investment into India by UAE entities. This includes investments of USD 3 billion by the Emirates New Development Bank in RBL Bank of India, USD 1 billion by the Abu Dhabi Investment Authority in the National Infrastructure and Investment Fund of India for priority infrastructure projects in India, and USD 1 billion by the International Holding Company

in Sammaan Capital of India. These investments underscore the UAE's sustained, long-term commitment to India's growth story and strengthen the bilateral strategic investment partnership, the statement said. The other agreements signed during PM Modi's visit to the UAE include the inking of a Memorandum of Understanding between Cochin Shipyard Limited and Drydocks

World, Dubai, for setting up a Ship Repair Cluster at Vadinar in Gujarat, including offshore fabrication, under the Maritime Development Fund Scheme launched by the Government of India, the Prime Minister's Office statement said. The tripartite Memorandum of Understanding between Cochin Shipyard Limited, Drydocks World Dubai, and the Centre of Excellence in Maritime and Shipbuilding on skill development in ship repair establishes a framework to mobilise, train and employ a skilled maritime workforce, enhances the capabilities of the Indian maritime workforce, and positions India as a hub for skilled shipbuilding and ship repair professionals, the statement said. Besides, the two sides concluded a term sheet for setting up an 8 Exaflop Super Compute Cluster in partnership between the Centre for Development of Advanced Computing, India, and G-42, UAE.

## Brazil Extend Ancelotti's Contract Until 2030

Rio de Janeiro: Carlo Ancelotti has extended his contract as manager of Brazil's national team until 2030, the Brazilian Football Confederation (CBF) said. The 66-year-old Italian took over as Brazil's head coach in May 2025 and secured the team's qualification for the FIFA World Cup 2026, which begins next month in the United States, Mexico and Canada. In total, he has been in charge for ten matches, with five wins, two draws, and three losses. "I arrived in Brazil a year ago. From the very first minute, I understood what football means in this country," Ancelotti told the CBF's official website. "For a year now, we've been working to bring the Brazilian national team back to the top of the world. But the CBF and

I want more. More wins, more time, more work." "We are very happy to announce that we will continue together for another four years," said Ancelotti. "We're going all the way to the 2030 World Cup. I want to thank the CBF for their trust. Thank you, Brazil, for the warm welcome and all the affection." Ancelotti has overseen five wins, two draws and three losses since his appointment. CBF President Samir Xaud called the extension a historic day. "Carlo Ancelotti's contract extension represents another firm step in our commitment to providing the five-time World Cup-winning national team with an increasingly strong, modern, and competitive structure," he

## Trump-Xi Summit Highlights Cooperation, Lacks Breakthroughs On Key Fault Lines

Beijing: When US President Donald Trump and Chinese President Xi Jinping met in Beijing this week, their cordial exchange of pleasantries, a firm handshake and emphasis on cooperation fueled cautious optimism about relations between the two superpowers. However, a lack of major breakthroughs on complex issues, including the status of Taiwan, underscored the persistent challenges facing the Sino-US relationship amid increasingly rancorous competition over trade, security and technological leadership. Above all, the latest Trump-Xi summit drove home one clear message: The leaders of the world's most powerful nations remain on speaking terms and plan to meet several more times this year alone, including during Xi's anticipated reciprocal visit to Washington in September, Yonhap news agency reported. "When there were difficulties, we worked it out. I would call you, and you would call me," Trump said at the start of the talks with Xi on Thursday. "Whenever we had a problem, we worked it out very quickly, and we are going to have a fantastic

future together." Xi struck a cooperative tone, stressing that the United States and China should be "partners, not rivals." "China and the United States both stand to gain from cooperation and lose from confrontation," he said in his remarks translated through an interpreter. "We should help each other succeed and prosper together, and find the right way for major countries to get along well with each other in the new era." Friday's summit venue, Zhongnanhai, added to the mood for Sino-US cooperation. Zhongnanhai is the central complex of the top Chinese leadership. Situated close to the Forbidden City, it was where then US President Richard Nixon met then Chinese leader Mao Zedong in 1972 to lay the groundwork for Sino-US detente. Despite the cooperative atmosphere, the summit brought renewed attention to long-running geopolitical fault lines between Washington and Beijing, including Taiwan, the self-governing democracy that China considers part of its territory. Xi warned during Thursday's summit that if the Taiwan question is



mismanaged, the two countries may end up having "clashes" and "even conflicts," according to Xinhua News Agency. In an interview with Fox News, Secretary of State Marco Rubio, who doubles as Trump's top National Security Advisor, said "it is not in China's interest or anyone's interest for there to be any sort of forced change in the status quo" regarding Taiwan. "I think stability there is very important," the Secretary said.

In the lead-up to Trump's China trip, speculation had lingered that the Trump administration could consider a shift in US policy language to "opposing" Taiwan's independence from "not supporting" it. On Iran, the two sides found some common ground, though they diverged on China's purchase of Iranian oil. The US and China agreed at the summit that Iran can never have a nuclear weapon, and that the Strait of Hormuz, a crucial shipping route

## Thailand Declares Hantavirus 'Dangerous Communicable Disease'

Bangkok, 15/5: Thailand's National Communicable Disease Committee on Friday approved the designation of hantavirus as a "dangerous communicable disease." According to the Ministry of Public Health, the new mandate requires authorities to report suspected cases within three hours, conduct disease investigations within 12 hours, and enforce a strict 42-day quarantine for high-risk contacts. Hantavirus, which can spread through respiratory droplets, with certain strains capable of human-to-human transmission, has emerged as a significant global concern and a serious threat, necessitating the designation, the ministry said in a statement, Xinhua news agency reported. To ensure a rapid and coordinated response, the ministry said it is implementing an elevated action plan focusing on surveillance, laboratory testing, medical treatment, and local implementation. Health authorities are stepping up monitoring at international points of entry, with the Department of Disease Control finalising "Patients Under Investigation" definitions and immediate investigation protocols for



domestic cases, alongside the quarantine enforcement, said Somruek Chungsamarn, the ministry's permanent secretary. Somruek said provincial public health offices and hospitals nationwide have been tasked to maintain close surveillance, ensuring facilities report suspected cases within three hours, review treatment protocols, and immediately communicate risks to local populations. He urged anyone with a history of rodent exposure or recent travel from high-risk areas who develops a high fever and difficulty breathing to seek immediate medical attention to ensure rapid diagnosis and prevent the disease from spreading. Hantaviruses are a group of viruses carried by

rodents that can cause severe disease in humans. Infection typically occurs through contact with infected rodents or their urine, droppings, or saliva, while human-to-human transmission is rare. Human Hantavirus infection is primarily acquired through contact with the urine, faeces, or saliva of infected rodents or by touching contaminated surfaces. Exposure typically occurs during activities such as cleaning buildings with rodent infestations, though it may also occur during routine activities in heavily infested areas. Human cases are most commonly reported in rural settings, such as forests, fields, and farms, where rodents are present, and opportunities for exposure are greater.

## US Congressman Urges Trump To Publicly Disclose Any China-Linked Financial Interests

Washington, 15/5: Indian-American Congressman Raja Krishnamoorthi has demanded that President Donald Trump publicly disclose any China-linked financial interests involving himself, his family, or senior administration officials as Trump meets Chinese President Xi Jinping in Beijing. In a letter sent on Thursday, Krishnamoorthi said Americans "deserve confidence" that US policy towards China is being driven by national interests and not private business considerations. "Given the national security and economic stakes in the US-China relationship, the American people deserve confidence that outcomes of the summit and US policy are being conducted solely in the national interest, not influenced by private financial motivations," Krishnamoorthi wrote. The Illinois Democrat raised concerns over Trump's continued business interests and alleged ties between Trump-affiliated entities and Chinese authorities. "To date, you

have not divested from your own multi-billion-dollar business interests or created a blind trust, and though you have reportedly handed daily management of the Trump Organization to your children, you and your family still stand to profit from deals related to your family's businesses," the letter said. Krishnamoorthi cited findings from a Democratic staff report of the House Oversight Committee, which said entities linked to the Chinese government spent more than \$5.5 million at Trump-owned properties during his first term. The letter also referred to reports that Trump-affiliated businesses received trademarks and approvals from Chinese authorities while he was serving as President. The Congressman said he was particularly worried about "the possibility of concessions or policy shifts being discussed or agreed to in ways that could create even the appearance of personal benefit". He specifically referred to issues involving

advanced AI chip exports to China, US policy towards Taiwan, and possible discussions over American arms sales to Taiwan. Krishnamoorthi asked Trump to publicly disclose "any current or recent business dealings, investments, trademarks, or licensing agreements in China" involving Trump, his family, the Trump Organisation, or affiliated entities. The Indian American Congressman in his letter sought details about "pending or recently approved trademarks, permits, or regulatory approvals granted by Chinese authorities to Trump-affiliated entities" and "any financial interests held by senior administration officials or immediate family members that could present a conflict of interest involving China policy". "Transparency is essential to maintaining public trust and ensuring that US policy toward China is driven by America's national interests alone," Krishnamoorthi wrote.

from Iran. The Trump administration has wanted Beijing to halt its purchases of Iranian oil, a key source of revenue for the Tehran regime, as part of its pressure campaign against Tehran, according to the report by Yonhap. It remains unclear whether Trump and Xi touched on North Korea's advancing nuclear and missile programs, though China's state media said they discussed key regional and international issues, including those concerning the Korean Peninsula. Ahead of the Beijing summit, expectations had arisen that North Korea could be brought up at the Trump-Xi summit, as the US president has repeatedly expressed his desire to re-engage with North Korean leader Kim Jong-un since his second term began early last year. On trade, Trump said he and Xi made "some fantastic trade deals" that are "great for both countries." He did not elaborate, but Trump told Fox News that China committed to purchasing US soybeans, oil and liquefied natural gas, as well as 200 Boeing jets, noted the report. Aside from the purchase commitments, there was no announcement on how the two sides will deal with their

temporary trade truce set to expire later this year, as the Trump administration is conducting trade investigations into China and other countries, which could result in new tariffs. During the Trump-Xi summit in South Korea in late October, the two sides reached a one-year truce aimed at lowering existing tariffs and suspending further trade restrictions, including China's export curbs on rare earth elements. China's accelerating nuclear buildup was expected to be part of the leaders' discussions, but there was no word on whether the leaders discussed the security issue. Trump has shown his interest in forging a new arms control treaty that includes China, after the New Strategic Arms Reduction Treaty between the US and Russia, known as the New START, expired in February. China's nuclear stockpile has been growing at an alarming pace from the US perspective. China's stockpile of nuclear warheads remained in the low 600s in 2024, and its military remains on track to possess over 1,000 warheads by 2030, according to a 2025 Pentagon report on China's military developments.

## Petrol, Diesel Prices: Centre Bearing Huge Burden Through Excise Duty Cut, Says Piyush Goyal

Mumbai, 15/5: Union Minister Piyush Goyal on Friday said the central government has taken a significant financial burden on itself by reducing excise duty on fuel and continuing heavy subsidies on fertilisers to protect farmers and consumers from rising global prices. Speaking to IANS on the sidelines of an event here, Goyal said the Centre had reduced excise duty by Rs 10 to provide relief to citizens despite mounting fiscal pressure. He added that the government was also bearing massive subsidy costs to ensure farmers do not face higher fertiliser prices. "The central government has taken more burden on itself. The excise has been reduced by Rs 10. Similarly, the expense of Rs 3,000 crore in fertiliser, our



farmers have to pay the same old price, no increase has been made. And because of this, 90 per cent subsidy has to be given by the central government by lakhs of crores," Goyal said. Commenting on Maharashtra's government

decision to cut VAT on aviation fuel, the Union Minister said sectors such as tourism and civil aviation would benefit from the government's economic measures. "Tourism will benefit a lot, the civil aviation sector which

is in a lot of pressure will also be relieved, which is an important sector for the long term. I think all the opposition ruled states, only few are left now, there are not much, they will also learn something from this," Goyal told. Commenting on Prime Minister Narendra Modi's security arrangements, Goyal said concerns over the Prime Minister's safety remain paramount. He said the reduction in security was not due to pressure from the opposition and urged that there should be no compromise on the Prime Minister's protection. "He is the Prime Minister of the country and a leader of the world. We are worried about every aspect of his security," Goyal said.

## Palm Oil Shouldn't Be Defamed Without Evidence: Experts

New Delhi, 15/5: Palm oil is crucial for India's edible oil security and reduced import dependence, experts said at an event held this week, adding that it should not be defamed without adequate evidence, PHDCCI said on Friday. Food Safety and Standards Authority of India said that it does not endorse or defame any food ingredient without credible scientific evidence and called for balanced, evidence-based public messaging.

In a conference on edible oils held by PHDCCI and AYUSH Committee, Dr. Alka Rao, Advisor, FSSAI said palm oil continues to be widely used in Indian households and the food industry owing to its stability and suitability for high-temperature cooking applications. "Our stakeholder consultation framework remains open and inclusive, allowing individuals, industry bodies and experts to present scientific data and perspectives for consideration. India's apex food regulator, FSSAI remains committed to promoting evidence-based nutrition

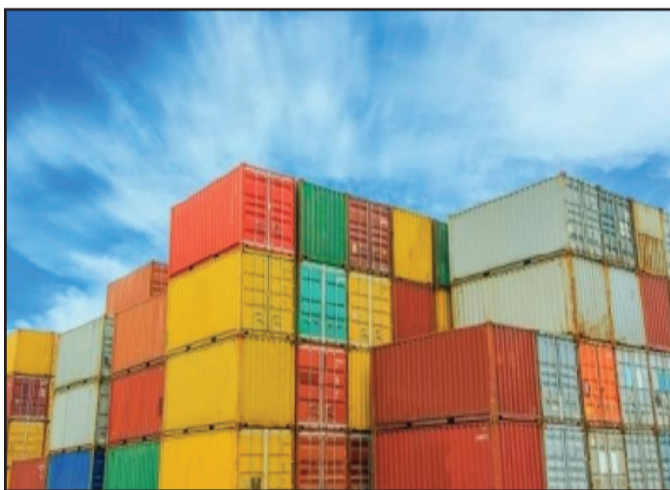


awareness and encouraging balanced, informed dietary choices among consumers," she said. The interactive conference drew over 90 delegates from industry, hospitals and academia and featured three technical sessions on palm oil science, food labels and the truth about saturated and trans fats. Speakers emphasised the role of palm oil in food security and affordability and urged clarity in public discourse. India's renewed focus on strengthening domestic palm oil cultivation is a significant step towards strengthening the country's edible oil security and reducing import dependence,

said Dr. Shri Rishi Kant, Additional Economic Advisor, Department of Agriculture & Farmers Welfare, Ministry of Agriculture & Farmers Welfare. Through initiatives such as the National Mission on Edible Oils, the government is creating an enabling ecosystem for farmers through improved infrastructure, financial incentives and stronger market linkages, the release said. India has also expanded its oil palm cultivation ambitions significantly, with the targeted area increasing from 6.5 lakh hectares to nearly 10 lakh hectares by 2025-26, it added.

## India Eyes \$1 Trillion Exports In FY27 Backed By FTAs, Export Push

New Delhi, 15/5: India is banking on the proposed export promotion mission and a new wave of free trade agreements (FTAs) to push the country's exports towards the ambitious \$1 trillion milestone in FY27, a top government official said on Friday. Speaking to NDTV Profit, Commerce Secretary Rajesh Agrawal said the government expects export growth in the current financial year to surpass last year's pace, with efforts aimed at achieving expansion well beyond the 10-15 per cent range required to meet the target. Agrawal said the proposed Export Promotion Mission is expected to become a major pillar of India's trade strategy by supporting exporters, improving access to overseas markets and helping domestic businesses tap into emerging global opportunities. "The implementation of recently



concluded FTAs in the coming months is likely to provide an additional boost to outbound shipments," he mentioned. According to the commerce secretary, India is also well-positioned to benefit from ongoing shifts in global supply chains, as multinational companies increasingly look to diversify manufacturing and

sourcing operations beyond traditional hubs. "India is steadily emerging as a reliable and trusted partner in the changing global trade ecosystem," Agrawal stated. Earlier, Commerce and Industry Minister Piyush Goyal had urged exporters to aggressively explore fresh opportunities created through trade agreements, while

emphasising that India should aim to cross the \$1 trillion exports mark in FY27. India's combined goods and services exports touched a record \$863.11 billion in FY26 despite geopolitical uncertainties, weak global demand and elevated tariffs imposed by the United States. While merchandise exports posted modest growth during the year, services exports continued to remain the key driver of overall trade expansion. Goyal said achieving the FY27 target would require export growth of around 16-17 per cent.

He highlighted that India already has operational FTAs with the United Arab Emirates, Australia, Mauritius and the European Free Trade Association, while negotiations are currently underway with several other countries and regional blocs aimed at expanding India's global trade footprint.

## Sensex, Nifty End Lower Amid Surge In Crude Oil Prices

Mumbai, 15/5: Indian benchmark equity indices ended lower on Friday as late-session selling pressure dragged the markets down amid weakness in the rupee against the US dollar and a sharp rise in crude oil prices. The benchmark Nifty closed 46.10 points, or 0.19 per cent, lower at 23,643.50, while the Sensex declined 160.73 points, or 0.21 per cent, to settle at 75,237.99. Commenting on Nifty technical outlook, experts said that a sustained breakout above this zone will be required to strengthen bullish momentum and improve broader market sentiment further toward the 23,900-24,000 range. "On the downside, the 23,500-23,400 zone continues to act as an important immediate support level, and a decisive break below this region could drag the index toward the 23,300-23,200 support area," an analyst stated. Market sentiment turned cautious during the final hours of trade after the domestic currency touched a fresh low against the US dollar, adding to concerns over rising import costs and inflationary pressures. The surge in global crude oil prices further weighed on investor sentiment, especially in energy-sensitive

sectors. Among the top laggards on the Nifty index were Hindalco Industries, Eternal and UltraTech Cement. Broader markets also witnessed selling pressure, with the Nifty MidCap index ending 0.45 per cent lower and the Nifty SmallCap index falling 0.61 per cent. Sectoral performance remained largely weak, with the Nifty Metal, Nifty Realty and Nifty Oil and Gas indices emerging as the worst-hit segments during the session. However, buying interest in technology and media stocks helped the Nifty IT and Nifty Media indices close in positive territory. Meanwhile, global oil prices rose sharply, with Brent crude's May futures contract climbing 2.9 per cent to \$108.8 per barrel on the Intercontinental Exchange, raising concerns about higher fuel costs and their potential impact on inflation and corporate margins. The Indian rupee also plunged to a fresh record low of 96.14 before settling at 95.97, as the trade deficit widened beyond market expectations and a sudden short squeeze after breaching of 96. "Technically, spot USDINR has support at 95.45, with resistance levels seen at 96.20 and 96.85," an analyst stated.

## India's Ethanol Capacity At 2,000 Crore Litre Exceeds Demand: Report

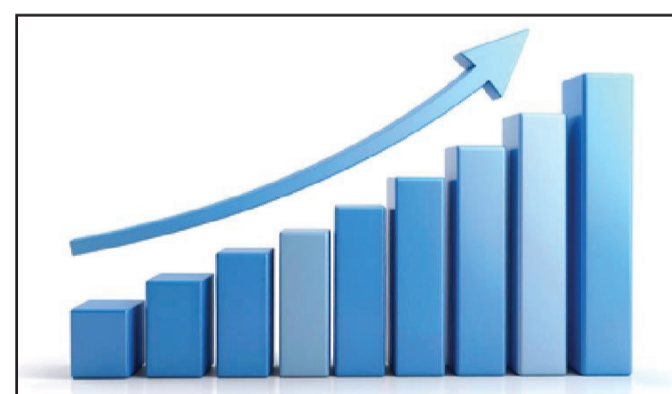
New Delhi, 15/5: India's ethanol production capacity has scaled to about 2,000 crore litres, with additional 400 crore litres expected to be operational by fiscal 2027, a new report has said. The report from CareEdge Ratings said that the demand under E20 blending is only roughly 1,100 crore litres, with nonfuel demand of around 300-350 crore litres. Only around 60 per cent of offered ethanol is being absorbed, leaving utilisation pressures across the sector. The surplus has led to the sector transitioning into a consolidation phase with utilisation likely to remain in the 65-75 per cent range for the next three years. Capacity addition is concentrated in select states such as UP, Maharashtra, Karnataka, leading to regional surpluses ranging from 277 crore litres surplus in Maharashtra to 77 crore litres deficit in Tamil Nadu. Correspondingly,

Engineering, Procurement, and Construction (EPC) activity has begun to moderate, with industry focus shifting toward brownfield capex, debottlenecking, and operational efficiencies. The report highlighted that roughly 700 crore litres of excess supply relative to absorption have kept margins under pressure. "The transition toward higher ethanol blending presents a complex mix of operational, consumer, and infrastructure challenges, even as demand is expected to rise to roughly 1200 crore litres by ESY 2026-27 and roughly 1,600 crore litres by ESY 2029-30," said Niraj Thorat, Assistant Director, CareEdge Ratings. "Achieving this will depend on FFV penetration increasing from roughly 5 per cent of new vehicle sales in FY28 to roughly 20 per cent by FY30, alongside coordinated investments in logistics, storage, and distribution to avoid supply bottlenecks and

ensure smooth adoption," he noted. Meaningful demand expansion depends on scaling up higher ethanol blends (E85/E100) and Flex Fuel Vehicle (FFV) adoption. In the absence of these demand side triggers, incremental capacity additions are unlikely to be absorbed in the near term, the report forecasted. In the Ethanol Blended Petrol (EBP) Program, India reached an average 20 per cent ethanol blending level in December 2025, five years ahead of schedule. The Ministry of Road Transport and Highways (MoRTH) then came out with draft amendments to create grounds for increasing the EBP to E85 or exclusive ethanol fuel. Ethanol has emerged as a globally preferred sustainable fuel, offering significant benefits in reducing greenhouse gas emissions, enhancing energy security, promoting agricultural demand, and supporting cleaner, renewable energy transitions across major economies worldwide.

## India's Overall Exports Rise 13.6 Pc To \$80.8 Billion In April

New Delhi, 15/5: India's overall exports registered a strong growth of 13.6 per cent year-on-year (YoY) to reach \$80.8 billion in April 2026, despite geopolitical tensions in West Asia disrupting key trade routes and global markets, according to government data released on Friday. The goods exports rose to a record \$43.56 billion in April, compared to \$38.28 billion in the same month last year. Meanwhile, services exports also witnessed healthy growth, increasing to \$37.2 billion from \$32.8 billion a year ago. Commerce Secretary Rajesh Agrawal said India's exports have remained resilient despite regional conflicts and trade disruptions, supported by the country's strategy of diversifying into new geographies and product markets. Agrawal further said the government currently does not see elevated crude oil prices hurting



India's export competitiveness. He also indicated that preliminary trends for May 2026 suggest export momentum remains encouraging despite continuing global uncertainties. India's overall imports also increased during the month to \$88.6 billion from \$82.3 billion in April 2025. Goods imports stood at \$71.9 billion against \$65.4 billion in the year-ago period, while services imports

edged lower to \$16.66 billion from \$16.9 billion. As a result, the merchandise trade deficit widened slightly to \$28.4 billion in April 2026, compared to \$27.1 billion in the corresponding month last year. The United States remained India's largest export destination, while China continued to be the country's biggest source of imports. Government officials said India has managed to cushion the

impact of geopolitical conflicts by expanding into alternative markets. According to official data, India entered 1,821 new product-country export combinations during FY26 as part of its broader export diversification strategy. Exports of ships, boats and floating structures generated \$57 million across 19 new markets, while exports of nuclear reactor and boiler parts contributed \$14.3 million across 13 new destinations. Meanwhile, India's gold imports rose sharply to \$5.63 billion in April 2026 from \$3.1 billion in the same month last year. Officials said the increase was largely driven by higher unit prices rather than a rise in import volumes. However, gold imports during FY26 declined in quantity terms even as the overall import value increased. The government noted that higher import duties on gold and silver are likely to affect consumption patterns going forward.

## Retail inflation may rise to 5.1% in current fiscal from 2% in last fiscal: Crisil

New Delhi, 15/5: Retail inflation in India is expected to rise to 5.1 per cent in the current fiscal year as higher wholesale prices, elevated crude oil costs and a weakening rupee increase pressure on consumer prices, according to a report by Crisil. The report stated that the recent sharp rise in wholesale inflation, mainly due to the ongoing West Asia conflict, could gradually pass on to consumers in the form of higher retail prices. It stated, "We

expect retail inflation to print higher at 5.1 per cent in the current fiscal compared with 2 per cent last fiscal". According to the report, Wholesale Price Index (WPI)-based inflation rose sharply to 8.3 per cent in April 2026 from 3.9 per cent in March, while Consumer Price Index (CPI)-based inflation increased only marginally to 3.48 per cent from 3.40 per cent during the same period. The report noted that the impact of the West Asia conflict has

already started affecting wholesale prices through higher energy and commodity costs, although the full impact is yet to reflect in retail inflation. "WPI inflation decisively surpassed a benign CPI, hit by the West Asia conflict. The upside risk to inflation from the conflict is yet to materially reflect in CPI," the report said. Crisil stated that the divergence between wholesale and retail inflation is expected to continue in the current fiscal year, unlike last year. The report

explained that WPI inflation is more directly impacted by global commodity shocks because it reflects prices in wholesale markets and production costs, while CPI measures prices paid by consumers for goods and services. The report highlighted that WPI inflation has historically been more volatile than CPI inflation. According to the report, inflation in several commodity-linked segments rose sharply in April

2026. Crude petroleum inflation surged to 88.1 per cent in April from 51.6 per cent in March, while furnace oil inflation jumped to 74.2 per cent from 9.7 per cent. Natural gas inflation also increased to 24.9 per cent. Inflation in liquefied petroleum gas (LPG) rose to 10.9 per cent, while basic chemicals inflation increased to 7.8 per cent during April. The report stated that rising wholesale inflation increases input costs for industries,

which may eventually force companies to pass on higher costs to consumers. According to Crisil, retail inflation is expected to rise to 5.1 per cent in the current fiscal compared with 2 per cent in the previous fiscal. The report identified several reasons for the expected increase in inflation. These include persistently high global crude oil prices, rising prices of petrol, diesel and compressed natural gas, and the depreciation of the rupee,

which increases the cost of imported goods and raw materials. The report also warned that food inflation may rise because of disrupted agricultural production due to heatwaves and an expected below-normal monsoon linked to El Niño conditions. Crisil further stated that statistical low-base effects could also contribute to higher inflation readings in the current fiscal year.

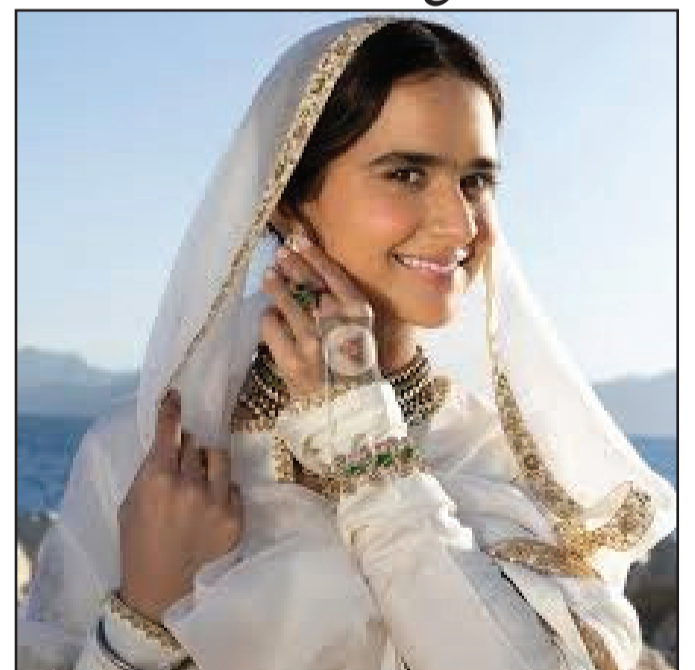

Perhaps most striking was the film's title, 'Chardikala,' intricately embroidered in Gurmukhi script directly onto the fabric. Authenticity served as the ultimate fashion statement for the actress, who described the moment as bringing "Punjab di Mitti" (the soil of Punjab) to the



global stage. Chardikala, a central tenet in Sikhism, refers to a state of eternal optimism and rising spirits—a theme that resonated through her choice of traditional Polki and Kundan jewellery accented with emerald drops. While Bollywood figures like Aishwarya Rai and Alia Bhatt frequently grace these

steps, the 2026 festival marks a shift toward regional Indian cinema. This year, the Indian pavilion has placed significant emphasis on diverse storytelling, moving beyond Mumbai-centric narratives to showcase the vibrant film industries of Punjab, Maharashtra, and Gujarat.

### 'Welcome To The Jungle' teaser unveils star-studded jungle of madness

The makers of 'Welcome To The Jungle' have released the film's highly anticipated official teaser, offering a first look at a large-scale, chaotic comedy built on meta-humour, nostalgia, and slapstick spectacle. Directed by Ahmed Khan and produced by Firoz A. Nadiadwallah, the film is set for a global theatrical release on June 26, 2026. Positioned as the third installment in the popular 'Welcome' franchise, following 'Welcome Back,' the teaser introduces a self-aware comedic tone that leans heavily into parody and ensemble-driven chaos. The teaser opens with a satirical twist on standard industry disclaimers, immediately setting a tongue-

in-cheek tone. The on-screen text reads: "In the making of this film no animals were used... except for some horses and us donkeys." The footage then transitions into a fictional film-set premise, where the ensemble cast plays characters trapped in a production environment and being paid "crores of rupees" to perform. The teaser relies on rapid-fire dialogue and situational humour. In one standout moment, Akshay Kumar's character attempts to exit the chaotic production, but then returns remarking that "money always comes in between". The action quickly escalates into exaggerated gunfire and explosive comedic sequences.
