PM Narendra Modi holds high-level meetings with French business leaders in Paris



New Delhi: Prime Minister Narendra Modi is holding a series of high-level meetings with leading French business leaders in Paris as part of efforts to deepen India-France economic and industrial cooperation. Prime Minister Modi will attend VivaTech 2026, alongside French President Emmanuel Macron in the evening.

Prime Minister Modi will lead a series of high-level engagements at the summit, culminating in a highly anticipated keynote address that highlights India's skyrocketing global digital footprint. The VivaTech

Summit is Europe's largest technology and startup event, where Mr modi is expected to highlight India's growing innovation ecosystem and technological advancements. India will have the largest national pavilion at this edition of VivaTech Summit, a fitting symbol of the enormous potential for partnership between the Indian and European innovation ecosystems.

The Prime Minister is also scheduled to address members of the Indian community during a special diaspora event.

HM Amit Shah meets US Ambassador to India Sergio Gor in New Delhi

New Delhi: Union Home Minister Amit Shah met US Ambassador to India Sergio Gor in New Delhi, with discussions focused on strengthening bilateral cooperation in key security areas, including counter-terrorism and counter-narcotics efforts.

According to Shah's post on X, the meeting involved detailed deliberations on enhancing India-US collaboration in tackling terrorism, drug trafficking



and organised crime networks, while also improving border security mechanisms.

The Home Minister reiterated India's commitment under Prime Minister Narendra Modi's leadership to further strengthen the India-US Comprehensive Strategic Partnership for mutual benefit and global security cooperation.

US Ambassador Sergio Gor described the meeting as "excellent" and said both sides discussed ways to deepen cooperation in combating

terrorism, preventing narcotics trafficking and ensuring stronger border security, along with coordinated efforts to bring criminals to justice.

The meeting comes shortly after the interaction between Prime Minister Narendra Modi and US President Donald Trump at the G7 Summit in France, signalling continued high-level engagement between the two countries on strategic and security issues.

Essel Group's Subhash Chandra Sells Delhi Bungalow For Rs 1,260 Crore

New Delhi : Essel Group Chairman Subhash Chandra has sold a prime bungalow in Delhi's prestigious Lutyens' zone for Rs 1,260 crore, in what is being described as one of the most expensive property transactions in recent years, sources told news agency PTI.

Chandra had acquired the bungalow in 2015 for Rs 304 crore. The latest deal represents a more than four-fold increase in the property's value over the past decade.

The nearly three-acre property, located on Bhagwan Das Road near Connaught Place and India Gate, has been purchased by a Delhi-based business family. The identity of the buyer



has not been revealed as of now.

The transaction is expected to be completed by the first week of December, according to PTI sources.

The Lutyens' Bungalow Zone, a tightly regulated

enclave in the heart of the national capital, comprises around 3,000 bungalows and has long been synonymous with power and privilege. Home to senior government officials, judges, diplomats and a select group of industrialists, the area is marked by strict development norms and limited land availability.

Delhi's Lutyens' zone and Gurugram's Golf Course Road have witnessed several high-value real estate transactions since the Covid-19 pandemic.

Gurugram, in particular, has seen a surge in luxury property deals, with apartments in DLF's ultra-luxury residential projects, The Camellias and The Dahlias, commanding premium prices.

governance and policymaking. I also emphasized the need to work closely with the Global South for global prosperity," the Prime Minister said.

India has increasingly positioned itself as a leading voice of the Global South, advocating for inclusive economic growth, equitable access to technology, climate justice and reforms in global governance institutions. PM Modi's interventions at the G7 Summit are viewed as part of India's broader diplomatic outreach aimed at ensuring that the concerns and aspirations of developing nations receive greater attention on international platforms.

During his Paris visit, the Prime Minister is scheduled to participate in VivaTech 2026, one of Europe's largest technology and innovation events. His address at the summit is expected to showcase India's rapidly growing digital economy, thriving startup ecosystem and advancements in emerging technologies.

France remains one of India's closest strategic partners in Europe, with both countries sharing strong cooperation on regional and global issues. Recent years have witnessed growing collaboration in areas such as defence manufacturing, maritime security, renewable energy, artificial intelligence and innovation.

Delhi CM orders high alert ahead of monsoon

New Delhi: The Delhi government on Wednesday issued the Flood Control Order-2026 and directed all departments to remain on high alert ahead of monsoon. Chief minister Rekha Gupta warned that officials would be held accountable for waterlogging and preparedness lapses. Chairing a meeting of the Apex Committee at the Delhi Secretariat, Gupta said the focus is on preventing disasters

through advance planning rather than responding after emergencies occur.

She directed departments to closely monitor vulnerable areas and said negligence would not be tolerated.

Under the new order, a nodal officer will be appointed for every identified waterlogging point. Officials said the Central Flood Control Room has been functioning round-the-



clock since June 15, while sector committees have

been formed under cabinet ministers Parvesh Sahib

Singh, Ashish Sood and Manjinder Singh Sirsa.

The Irrigation and Flood Control Department said over 3 million metric tonne of silt has been removed from 77 drains, including 22 major drains, surpassing this year's desilting target. The number of pumps available for flood management has been increased to over 243, while 41 boats have been deployed for rescue operations, said officials.

Health Minister recovers from accident

Keonjhar : Health Minister Mukesh Mahaling’s official vehicle met with an accident near Jagmohanpur today while going to Mayurbhanj district via Keonjhar. He was going to Mayurbhanj district on NH 49 , at about 5.45 pm an accident occurred at Jagmohanpur under Telkoi police station. After receiving the information, the police reached and rescued him and sent him safely in another vehicle. According to the sources, when they are proceeding the pilot vehicle moving ahead suddenly stopped due to sudden braking at a humps. As a result, the minister’s vehicle is coming from behind the pilot vehicle. The police are taking steps to move the accident vehicle aside. As a result, traffic problems were reported on the road for some time, but it has been resolved. The minister and others got out of the car after the safety balloon of the vehicle was released. A crowd of people gathered to watch. As a result, traffic on the road was stopped. Anjan Kumar Patra, Telkoi police station officer said that it was a minor accident. Everyone is safe. Traffic is cleared after minister went. Although the construction of humps on NH-49 is illegal, people blocked the road to build humps after an accident at the same place a few months ago in which three people lost their lives. Such accidents have occurred due to the said humps. Due to the construction of humps in various places, many accidents have occurred and traffic has become unsafe.

Parking Chaos Grips Khordha City:-Traffic Congestion, Safety Risks and Public Outcry on the Rise.

Khordha- 18/6-As khordha steadily transforms into one of odisha’s rapidly growing urban centres, the city is simultaneously grappling with a serious civic challenge that is affecting the daily lives of thousands of residents—an increasingly chaotic and unregulated parking system. What should have been a symbol of urban growth and economic activity is now emerging as a major obstacle to smooth transportation, public safety and emergency services. From the bustling Marwari Patti market area to the Old Bus Stand, New Bus Stand, Hospital Square, Court Square and several key commercial hubs, indiscriminate roadside parking has become a common sight. Vehicles parked haphazardly on both sides of the roads have significantly narrowed traffic corridors, leading to frequent congestion, delays and growing frustration among commuters. Every morning, as office-goers rush to work and students head to schools and colleges, the city’s major roads witness a sharp rise in traffic volume. Instead of facilitating smooth movement, many stretches of road become bottlenecks due to rows of parked motorcycles, cars and commercial vehicles occupying valuable road space. Commuters often find themselves trapped in traffic snarls, while public transport vehicles struggle to navigate through congested streets. Residents say the problem has become particularly severe in the New Bus Stand area, where shopping complexes, retail stores, restaurants and food outlets and juice shop attract large numbers of customers throughout the day. In the absence of designated parking facilities, many visitors leave their vehicles directly on the roadside while they shop or dine. According to local residents, several commercial establishments have failed to provide adequate parking spaces for customers, forcing public roads to serve as unofficial parking lots. The consequences of this growing disorder are visible everywhere. Bus drivers, auto-rickshaw operators, motorcyclists and cyclists are finding it increasingly difficult to move safely through crowded streets. During peak hours, even a minor obstruction can quickly escalate into a major traffic



jam, disrupting movement across large sections of the city. For pedestrians, the situation is even more alarming. In many areas, footpaths are either absent or encroached upon by parked vehicles. As a result, pedestrians are often compelled to walk on busy roads alongside moving traffic. Elderly citizens, women, children and school students are among the worst affected. Parents have expressed concern over the safety of children who are forced to navigate through traffic due to the lack of pedestrian-friendly infrastructure. The growing parking crisis has also raised serious concerns about road safety. Residents report several near-miss incidents and minor accidents caused by sudden vehicle movements and reduced road visibility. Traffic experts warn that unless corrective measures are taken soon, the city could witness a significant increase in road accidents. Perhaps the most worrying aspect of the situation is its impact on emergency services. There have been instances where ambulances transporting critically ill patients and fire service vehicles responding to emergencies have been delayed due to severe traffic congestion caused by indiscriminate parking. Such delays can have life-threatening consequences, especially during medical emergencies when every minute matters. Hospital visitors and patient

attendants have repeatedly voiced concerns about traffic congestion near healthcare facilities. Many believe that blocked access roads and poorly managed parking arrangements could jeopardize emergency medical response times, placing lives at risk. Adding to the city’s woes is another civic issue that has increasingly drawn public attention—the malfunctioning street lights in several parts of Khordha. As darkness falls, numerous roads remain poorly illuminated, making it difficult for drivers to spot parked vehicles along road shoulders. The combination of inadequate lighting and unauthorized parking creates a dangerous environment for motorists and pedestrians alike. The risk becomes even greater during the monsoon season. Heavy rainfall, waterlogged roads and poor visibility make driving challenging, while parked vehicles become unexpected hazards that can lead to accidents. Residents fear that without immediate intervention, the city could witness a rise in nighttime road mishaps. Despite repeated complaints and appeals from citizens, many residents allege that authorities have yet to implement a long-term solution to the problem. While traffic enforcement drives

and fines are occasionally imposed, people argue that these measures only provide temporary relief and fail to address the root causes of the crisis. Citizens believe that Khordha’s parking and traffic problems require comprehensive urban planning rather than periodic enforcement campaigns. They have urged the district administration, municipal authorities and traffic police to work together in developing a sustainable traffic management strategy that reflects the city’s growing population and vehicle density. Urban planners and members of civil society have suggested several measures, including the creation of multi-level parking facilities, establishment of designated parking zones, installation of digital traffic monitoring systems, strict penalties for illegal parking and regular public awareness campaigns promoting responsible road usage. They also emphasize the urgent need to repair all non-functional street lights to ensure safer nighttime travel. Many experts point out that khordha is currently at a crucial stage of its urban development. The city is witnessing expansion in commerce, infrastructure and residential growth. However, without addressing fundamental civic issues such as parking management, traffic regulation and pedestrian safety, the benefits of development could be overshadowed by growing urban challenges. For many residents, the parking crisis is no longer merely an inconvenience—it has become a daily struggle affecting productivity, public safety and quality of life. As Khordha aspires to evolve into a modern and smart city, citizens believe that solving the parking and traffic management problem must become an immediate priority. Unless swift and decisive action is taken by the concerned authorities, residents warn that the issue may spiral into a far more complex urban challenge in the coming years, threatening not only public safety but also the city’s overall growth and development. The people of khordha now await concrete action, hoping that their concerns will finally translate into meaningful reforms before the situation reaches a critical point.

District-Level Disaster Management Tabletop Exercise Held in Khordha.

Khordha-18/6- With the monsoon season approaching and the possibility of natural calamities such as cyclones, floods, and heavy rainfall looming over the state, the khordha district administration has intensified its preparedness efforts by conducting a comprehensive district-level disaster management tabletop exercise. The exercise, aimed at enhancing coordination among various government departments and emergency response agencies, underscored the administration’s commitment to achieving a “Zero Casualty” target during any future disaster situation. The important preparedness meeting was held at the conference hall of the Panchayat Samiti khordha and brought together senior officials from multiple departments, emergency response agencies, and public utility service providers. The exercise focused on reviewing preparedness measures, identifying possible challenges during emergencies, and ensuring seamless coordination among all stakeholders responsible for disaster response and relief operations. Presiding over the meeting, Additional District Magistrate (Revenue) Safalya Mandit Pradhan emphasized the importance of proactive planning

and coordinated action before, during, and after disasters. He reviewed the preparedness status of various departments and stressed that every agency must remain fully equipped to respond swiftly to any emergency. Highlighting the district administration’s commitment to safeguarding human lives, he reiterated that the primary objective of all disaster management activities should be the prevention of loss of life. The meeting was attended by Additional Superintendent of Police, Srinivas Mohanty, Bhubaneswar Sub-Collector Dr. Manoranjan Sahu, General Manager (Planning and Administration) of the Odisha State Disaster Management Authority (OSDMA) Dr. Sarita Jena, Khordha Block Development Officer Siddhartha Pattnaik, Executive Officer of Khordha Municipality Kaberi Muduli, and representatives from several line departments and emergency response agencies. During the deliberations, officials discussed various disaster scenarios, including cyclones, floods, urban waterlogging, power disruptions, communication failures, and damage to critical infrastructure. Special emphasis was placed on preparedness measures that could minimize risks and ensure rapid response in



the event of a natural calamity. Addressing the gathering, Additional Superintendent of Police Srinivas Mohanty highlighted the critical role of law enforcement agencies during disasters. He stated that maintaining law and order becomes a major challenge during emergency situations, particularly when relief and rescue operations are underway. The police department, he said, plays a vital role in ensuring the safe transportation and distribution of relief materials, regulating traffic, preventing panic among citizens, and maintaining public order. He further noted that uninterrupted supply and fair distribution of essential commodities such as kerosene, fuel, food items, medicines, and drinking water are crucial during disaster situations. The police department, he assured, remains fully prepared to assist all concerned agencies in carrying out their responsibilities efficiently. Bhubaneswar Sub-Collector Dr. Manoranjan Sahu stressed the need for timely evacuation of residents living in vulnerable and disaster-prone areas. He pointed out that early evacuation has repeatedly proven to be one of the most effective measures in reducing casualties during cyclones and floods in Odisha. Dr. Sahu also highlighted the importance of protecting livestock and domestic animals during disasters. He stated that ensuring proper shelter and safety

arrangements for animals is equally important, as many rural families depend on livestock for their livelihood. He urged officials to maintain close coordination and work with dedication to provide timely assistance to affected communities. Providing technical guidance during the exercise, OSDMA General Manager Dr. Sarita Jena explained the responsibilities and duties of different departments during disaster management operations. She emphasized that disaster preparedness is not the responsibility of a single department but requires collective effort and coordination among all stakeholders. She pointed out that proper planning, efficient communication systems, and timely execution of

response measures can significantly reduce the impact of disasters. According to her, every department must clearly understand its assigned role and be ready to act immediately when a disaster warning is issued. Representatives from local administration and municipal authorities also shared details about their preparedness measures. Block Development Officer Siddhartha Pattnaik and Municipal Executive Officer Kaveri Muduli informed the meeting about the arrangements being made at the grassroots level, including the readiness of cyclone and flood shelters, maintenance of drinking water facilities, sanitation services, and emergency support systems. Officials reported that efforts are underway to ensure that shelter homes remain equipped with essential facilities such as clean drinking water, electricity, toilets, medical support, and emergency food supplies. Special attention is also being given to sanitation management in order to prevent disease outbreaks in the aftermath of disasters. A major part of the exercise focused on reviewing the preparedness of critical service providers and emergency response agencies. Official’s from TPCODL, ODRAE, NDRF, Fire Services, Health Department, Social Welfare

Department, Child Protection Unit , Education Department, WATCO, Rural Water Supply and Sanitation, Rural Development, Agriculture and Horticulture, Veterinary Services, Irrigation Department, Drainage Department, and Bharat Sanchar Nigam Limited (BSNL) presented their action plans and preparedness strategies. Power utility officials briefed the administration about contingency plans for restoring electricity supply after storms and cyclones, while communication service providers discussed measures to maintain connectivity during emergencies. Health department officials highlighted arrangements for emergency medical teams, stockpiling of medicines, ambulance services, and disease surveillance mechanisms. Agricultural and veterinary departments shared plans for protecting crops and livestock, while irrigation and drainage authorities outlined flood mitigation measures and strategies for clearing waterlogged areas. The tabletop exercise also served as a platform to identify potential gaps in preparedness and to strengthen inter-departmental coordination. Officials engaged in detailed discussions on emergency communication protocols, resource mobilization, rescue operations, relief distribution mechanisms, and post-disaster rehabilitation measures.

Former Law Minister appeal the CM to challenge HC's order on Sarada Mines case

Naresh Chandra Pattanayak Keonjhar : Former Minister of Law and leader of Opposition Narasingh Mishra wrote letter to the Chief Minister of Odisha Mohan Charan Majhi on Tuesday to challenged the order of High Court before Supreme Court to quash the order where the HC allowed the extension of lease period to Sarada Mines Pvt. Ltd for 5 years and 10 months.

“In my opinion the judgment is not correct. Under the law once the lease period has expired, it should be put auction and can't extend”, he mentioned in the letter.

Citing the writ petition(C) No. 17676/2024 i.e. Sarada Mines Pvt Ltd and others vs State of Odisha and others has held the lease period should be extended the above period, the former Law minister wrote the letter.

According to the judgment after hearing the

Sarada Mines Private Limited vs State of Odisha (writ petition(C) No. 17676/2024) the HC on 20 May 2026 ordered, the state government (OP) to permit the petitioner to operate the Mining Lease for an added period of 5 years and 10 months reckoned from the resumption order dated 31-01-2020 without interference, subject to unusual compliances.

Sources said that the state government has stopped the mining operation on the ground of Apex court's interim order dated 16-05-2014 in the case a writ petition no 114 of 2014 filed by the Common Cause.

Further the government vide letter number 15-01-2015, had categorically stated that the environment clearance dated 22-09-2004 was valid and subsisting.

Subsequently the petitioner had filed IA No. 42 of 2014

and IA No 186810 of 2019 seeking resumption of Mining Operation and the Apex court allowed the same vide order dated 15-01-2020.

Deputy Director of Mines, Joda Biswaranjan Sethy said “So far we have not received any order regarding it and the

mines yet not started. Government will take decision and accordingly steps will be taken”. (EOM)

According to the sources the company was got mining on lease of 947.046 hectares of land in Block B of Thakurani iron ore mine near Soyabali village in Joda mining mandal of Keonjhar district in the year 2001 for the period of 20 years. The lease expired on 18-08-2021.

Due to lack of environmental and forest clearance, the mining department stopped the work for 5 years and 10 months from 01-04-2014 to 31-01-2020. Later, mining work was resumed on the orders of the court. The lease period of the said company had expired in 2021. However, it had

applied to the mining

department for permission to continue the work for 5 years and 10 months, which was stopped without any reason. After failing, it approached the High Court. The High Court (W.P. (C) 17676/2024) heard this and allowed the mining work to continue for 5 years and 10 months, which was stopped. As a result, a dispute has arisen regarding this. Paradip,(DMS) -: In the port and industrial city of Paradip, workers have allegedly been subjected to exploitation and deception for many years. However, with the emergence of local labour leader Prakash Tripathy, the influence of leaders accused of exploiting workers has reportedly begun to decline.

Prakash Tripathy's dedicated efforts toward safeguarding workers' interests have benefited a large number of labourers. At the prohibited zone of Paradip Port, nearly 500 workers are employed by Baman India, a contractor working under JSW. Of these, around 200 workers were already members of the Paradip Port Mazdoor Sangh, led by renowned trade union leader Prakash Tripathy, while the remaining workers belonged to the Paradip Erasama Industrial Labour Union, headed by so-called



labour leader Bapi Sarkhel.

After Baman India operated the contract for four years, the work was reportedly taken over a few months ago by Chennai Radha Engineering Works. However, workers' dues in the form of retrenchment compensation and gratuity accumulated over the four-year period remained pending from Baman India.

According to reports, workers alleged that Bapi Sarkhel attempted to prevent the payment of these dues through various means. Upon learning of this, more than 200 workers formally left Bapi Sarkhel's union and joined Prakash

Tripathy's union on Tuesday.

It may be noted that several workers had earlier also left Bapi Sarkhel's organization and joined Prakash Tripathy's union. Sources indicate that Prakash Tripathy's strong leadership, continuous struggle for workers' rights, and success in securing justice for labourers have made him a prominent figure among Paradip's working community. As a result, workers from various unions are increasingly choosing to join the organization led by Prakash Tripathy, reflecting his growing popularity and influence among the labour force in the region.

Senior Deputy Election Commissioner Reviews SIR Exercise in Puri, Conducts Field Visit

Puri: Senior Deputy Election Commissioner of India, Gyanesh Bharati, on Wednesday reviewed the progress of the Special Intensive Revision (SIR) programme in Puri district and assessed the ongoing electoral roll verification exercise.

The review was held at the Circuit House, where Puri Collector Divya Jyoti Parida welcomed the Election Commission team upon their arrival. During the meeting, the Collector presented a detailed overview of the SIR exercise being carried out across the district.

According to officials, Puri district comprises six Assembly constituencies, with six senior officers designated as Electoral Registration Officers (EROs). The district has a



total of 1,609 polling booths, for which 1,609 trained Booth Level Officers (BLOs) have been deployed. To support and monitor their work, 161 BLO supervisors have also been appointed.

The district has a voter base of 13.88 lakh electors. Officials informed the review

team that BLOs have so far distributed forms to 99.43% of voters. While one copy of the form is retained by the voter, the duly filled and signed copy is being collected by the BLOs. Election officials are also assisting voters in filling up the forms wherever required.

The digitisation of voter

forms is progressing simultaneously, with 40.67% of the records already digitised, the Collector said through a PowerPoint presentation.

During the review, Bharati sought clarifications on various aspects of the SIR process. The queries were addressed by Odisha Chief Electoral Officer R. S. Gopalan and Collector Parida.

The meeting was attended by several senior officials, including Principal Secretary to the Election Commission S. B. Joshi, Deputy Secretary Abhinav Agrawal, Chief Development Officer of the Zilla Parishad Sneha Arugula, Additional CEO Sushanta Kumar Mishra and other district-level

officers.

Following the review meeting, Bharati and members of the delegation visited the revered Shri Jagannath Temple and offered prayers. On the occasion, the Collector presented traditional Pattachitra paintings depicting Lord Jagannath as a token of felicitation. Earlier in the day, the Election Commission team undertook field visits and inspected several polling booths in the Pipili and Satyabadi Assembly constituencies. The officials interacted with BLOs and BLO supervisors to obtain first-hand feedback on the implementation of the SIR exercise and the challenges being faced at the ground level.

Opposition to Unauthorised Dance Performances Before Chariots During Rath Yatra; 6-Point Memorandum Submitted to Administration

PURI: Raising concerns over alleged unauthorised dance performances in front of the chariots during Lord Jagannath's annual Rath Yatra and the need to safeguard traditional rituals, several social and religious organisations on Thursday submitted a six-point memorandum to the district administration.

A seven-member delegation led by Roma Dasmahapatra, convenor of the Puri Parampara Suraksha Manch, along with representatives of Achyutananda Trust and eight other organisations, submitted the memorandum to the Chief Administrator of the Shree Jagannath Temple Administration (SJTA), the



district collector and the superintendent of police.

The organisations urged the authorities to formulate and publicly announce a clear policy regarding dance

performances conducted in front of the chariots during the Rath Yatra. They sought transparency on which individuals or groups would be permitted to perform and the

criteria governing such permissions.

According to the memorandum, eligibility for performances should be determined in accordance with the temple's age-old traditions, religious customs and the views of senior servitors. The groups also called for a public disclosure of the guidelines governing such performances.

The memorandum further demanded an independent inquiry into alleged unauthorised access, breaches of security cordons and other irregularities reported during the festival. It also sought action against any

servitor or official found guilty of misusing their position or violating established norms.

The delegation also expressed concern over the public presentation of Mahari (devadasi) dance, describing it as a sacred ritual tradition intrinsically linked to the service of Lord Jagannath. Members of the forum alleged that the commercialisation and public staging of the tradition were inappropriate and warranted review.

Among those present during the submission of the memorandum were Prasanna Lenka, Lalatendu Mishra and Suryakanti Pradhan, along with several other prominent citizens.

Defection Time

D

ays after Congress leader Rahul Gandhi astonishingly declared that the INDIA bloc had already won the 2029 Lok Sabha polls, Opposition parties such as the Trinamool Congress (TMC) and Uddhav Thackeray’s Shiv Sena are struggling to keep their flock together. The Congress and its allies have alleged that inducements and pressure tactics are being used rampantly by the BJP to make legislators switch sides. Shiv Sena leader Sanjay Raut has claimed that Maharashtra MPs are being offered Rs 50 crore each to defect. On Sunday, 20 rebel TMC MPs announced their merger with the Nationalist Citizens’ Party of India, a Tripura-based “registered unrecognised” political outfit. The Aam Aadmi Party is already smarting from the loss of seven Rajya Sabha MPs, who joined the BJP in April, while the Samajwadi Party is also facing a poaching threat.

The political turmoil involving defections, mergers and splits raises troubling questions about the health of I n d i a ’ s parliamentary democracy. What makes the situation extremely serious is the weakening of the anti-defection framework. The Tenth Schedule of the Constitution was introduced to curb political opportunism and instability. Yet, legal loopholes have turned defections into a recurring feature. Voters elect their representatives not merely as individuals, but as members of political parties with specific ideologies. When elected MPs jump ship without seeking a fresh mandate, public trust in the electoral process suffers. Democracy becomes vulnerable to transactional politics. These controversies put the onus on the Lok Sabha Speaker and the Rajya Sabha Chairperson to exercise impartiality and adhere to constitutional principles. Their decisions have a huge bearing on public confidence in parliamentary institutions.

Defections are not new to Indian politics, but their scale and frequency are increasing alarmingly. India risks normalising a culture where personal gain outweighs principles and electoral accountability doesn’t count.

RTI Misuse

T

he Supreme Court’s sharp observation that “RTI activism has become a new business” has turned the spotlight on public accountability and misuse of the law. The Court has denied anticipatory bail to an activist accused of obstructing a public servant involved in road construction work and hurling casteist abuse at labourers. Considering the gravity of the charges, the denial of pre-arrest bail appears legally justified. However, the general comments about RTI applicants deserve cautious reflection.

There is little doubt that some individuals misuse the Right to Information Act for the sake of personal gain. Frivolous complaints, pressure tactics and self-styled “activism” can disrupt governance and delay public projects. Yet, it would be dangerous to paint all RTI activists with the same brush. The Act, enacted in 2005, remains one of India’s most transformative democratic tools. Over the past two decades, it has exposed corruption, unearthed irregularities and empowered citizens to question authority. Many whistleblowers have faced threats, violence and social isolation.

Ironically, concerns over misuse are being raised at a time when the RTI framework itself is weakening. Several information commissions across the country suffer from vacancies and mounting backlogs, making citizens wait indefinitely for a response. Delays, administrative hurdles and attempts to dilute the law have steadily eroded its effectiveness. There is a dire need to distinguish genuine efforts initiated in public interest from coercive or unlawful conduct. Accountability mechanisms must function within the boundaries of law and civility. India’s democracy cannot afford reckless activism or opaque governance. The challenge lies in protecting both public order and the citizen’s right to know.

Mukti mandap

The Mukti mandap is the highest Pundit’s body in Sri Jagannatha temple, Puri. Learned Brahmins from the 18 sashana villages (previously 16) around Puri have their permanent seats on the Mukti mandap and the Shankaracharya of Puri Govardhana Pitha is the head of this august assembly of learned Brahmins. Sasans are the then autonomous villages during the Gajapati Kingdom. Even during the Gangas, Sashan Villages established by the then kings in Cuttack. Only designated families from these sashan Bramhins have rights to sit on Mukti mandap.

This highest priest’s assembly or Mukti mandap is located opposite to the Beharanadvara or the southern door way of the porch or mukhasala of the Sri Jagannatha temple beyond the passage under the Jhulana Mandapa. As per descriptions of the Madalapanji, present structure of Mukti mandap was built by Rani Gauri, wife of General Mansingh, who came to Odisha at the behest of

the Mughal emperor Akabar to decide on the fate of Odisha and to choose the real Gajapati king of Puri during 1572 AD. So the date of the structure is thus assignable to the last part of the 16th century A.D

In Puri Jagannatha temple, Mukti Mandap has a raised platform. You can see this as an open pillared mandapa

covered by pidha designed flat roof. The mandap height is about 20 feet and it has 16 numbers of pillars which support the stone beams under the corbelled roof, found in sections. The pillars have raised bases, shafts and square capitals, while the raised platform or pavilion is built in Khandolite stones along with the superstructure the pillars are found in dolerite stones.

The steps leading to the pavilion are found on the west side of the Mukti mandap, in front of the Mukta Narasimha temple. The flooring of the pavilion top is found in stone masonry. Few sculptural reliefs are found at ceiling portion of the mandap. Important among these are the Yajna Narasingha figure, opposite of the Mukta Narasingha temple.

Mukti mandap is blended with two Odia words Mukti and mandap, where Mukti means moksh or salvation and Mandap means the platform.

Telegram Restrictions Imposed After Less Restrictive Measures Failed: Centre Tells Delhi HC

New Delhi,18/6: The Centre has defended its decision to temporarily suspend Telegram’s services across India ahead of the NEET (UG) 2026 re-examination, telling the Delhi High Court that the messaging platform’s architecture and repeated misuse for examination-related frauds left the Union government with “no other option” but to invoke emergency blocking powers under the Information Technology Act.In a short affidavit filed before the Delhi High Court in response to Telegram’s writ petition challenging the suspension, the Ministry of Electronics and Information Technology (MeitY) said the decision was taken only after “exhausting alternatives” and resorting to less restrictive measures, including repeated requests for targeted takedowns of unlawful content.“I state and submit that the impugned decision was taken after exhausting alternatives, which were less

restrictive and included targeted takedown of unlawful content, but these would have been woefully inadequate,” the affidavit filed by Mayank, Scientist-E with the Government of India, MeitY, stated.The Centre argued that Telegram had become a key platform for the circulation of alleged NEET paper leaks, fake examination material, cyber frauds and other unlawful activities, posing a serious threat to public order and the integrity of the national examination system.“This issue is both sensitive and extremely sentimental for the entire student community, and any further dilutions/compromise as regards the integrity of the examination process to be taken by as many as 22 lakh students pan India is potentially fraught with unrest and disruption with public order issues,” the affidavit said.According to the reply document, MeitY received a

complaint from the National Testing Agency (NTA) on May 21 detailing a coordinated fraud network operating on Telegram under banners such as “Re-NEET 2026”, “Paper Leaked NEET” and similar names.The NTA claimed that the identified channels, groups and bots had a combined reach of nearly 1.46 lakh accounts and were openly advertising purported access to examination papers in exchange for money.The affidavit said a meeting was held with Telegram officials on June 3, during which the platform acknowledged difficulties in proactively identifying channels involved in selling leaked papers and admitted that bad actors were misusing its “anonymity” features.The government maintained that Telegram failed to take adequate proactive measures despite repeated concerns raised over several years.

ICAI Dismisses Social Media Claims On Security Breach In CA Exam Portal

New Delhi,18/6: The Institute of Chartered Accountants of India (ICAI) on Thursday rubbished social media messages claiming a security breach in its examination-related portal, assuring students that the integrity of the examination has not been violated.Advising students to ignore false, baseless and mischievous campaign on social media, the Institute, in a statement, said, “The ICAI has come across certain posts and reports circulating in social media alleging a security breach in an ICAI examination-related portal and claimed unauthorised access to ICAI examination records. These unverified claims have caused concern and confusion among students, members and other stakeholders.”“In this regard, ICAI clarifies that the portal being referred to, namely examiners.icaexam.icaai.org, is a training portal used exclusively for examiner orientation and has nothing to do with exam-related records as claimed in these social media posts,” it added.The Institute said, “The ICAI assure

all stakeholders that there has been no compromise of candidates’ examination records, answer books, marks data, or any sensitive information related to the examination process.”“The ICAI urges the stakeholders not to give any credence to such a false, baseless and mischievous campaign,” the statement said.The statement said the ICAI has viewed the matter seriously and assures that stringent action in accordance with law will be taken against persons spreading such rumours and false claims.“The ICAI further reiterates that its examination processes are robust, totally secure and supported by a strong information technology infrastructure with multiple layers of safeguards to protect the integrity and confidentiality of examination-related data,” it added.“Students, members and all stakeholders are, therefore, advised not to believe such rumours and false campaigns in social media and requested to refer only to official communications issued by ICAI for authentic updates,” the



statement said.The advisory from ICAI comes close to similar alert issued by the National Testing Agency (NTA) Director General Abhishek Singh cautioning National Eligibility-cum-Entrance Test-Undergraduate (NEET-UG) 2026 aspirants and their parents against social media rackets that lure aspiring doctors by offering to sell ‘leaked paper’ in exchange

for hefty amounts of money.He said the temporary suspension of the Telegram application till June 22 is a conscious step to check misleading claims and fake news.He also advised students to focus on their preparations for the NEET-UG 2026 on June 21 without being distracted by scammers’ offers to sell ‘leaked paper’.

PM Modi to Release 18,880 Crore Under 23rd PM-KISAN Instalment on June 20

New Delhi, 18/6: Prime Minister Narendra Modi will disburse the 23rd instalment of the Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) scheme on June 20 during a programme at Tarakeswar in West Bengal’s Hooghly district. The latest instalment will provide direct financial assistance of more than ₹18,880 crore to over 9.44 crore farmers across the country.According to official estimates, the amount will be transferred directly into beneficiaries’ bank accounts through Direct Benefit Transfer (DBT). Among the recipients are more than 2.18 crore women farmers, reflecting the government’s continued focus on strengthening rural livelihoods and supporting the agricultural sector.The event is being organised by the Ministry of Agriculture and Farmers Welfare

in collaboration with the West Bengal government. More than one crore farmers are expected to participate virtually through Krishi Vigyan Kendras (KVKs), ICAR institutions, agricultural universities, Farmer Producer Organisations (FPOs), agricultural markets, PM Kisan Samridhhi Kendras, cooperative societies and village-level programmes across the country.With the release of the latest instalment, the cumulative financial support extended under PM-KISAN since its launch on February 24, 2019, is set to cross ₹4.46 lakh crore. The scheme provides eligible farmer families with annual income support aimed at enhancing financial stability and promoting sustainable agricultural growth.West Bengal is expected to receive a substantial share of the disbursement. More than

45.35 lakh farmers in the state will receive over ₹907 crore under the latest instalment. Total transfers made under PM-KISAN in West Bengal are projected to exceed ₹15,055 crore.The programme is expected to be attended by Governor C. V. ‘Operation Tiger’ Succeeds: Six Shiv Sena(UBT) MPs Defy Party Whip, Move To Join Shinde Faction

New Delhi,18/6: In a major political upheaval rocking Maharashtra politics, the Uddhav Thackeray-led Shiv Sena (UBT) has suffered a crippling blow as six of its nine Lok Sabha Members rebelled to bypass a crucial party whip on Thursday.The high-stakes defection marks the definitive success of the Eknath Shinde faction’s meticulously

executed plan, code-named “Operation Tiger”. The internal fracture came to light during a parliamentary party meeting convened by Shiv Sena(UBT) at its office in Parliament House at 11:00 a.m.Despite a strict whip issued a day prior compelling mandatory attendance, only three Lok Sabha members and one Rajya Sabha member showed up. Those

who attended the meeting included Sanjay Raut (Rajya Sabha), Anil Desai, Arvind Sawant, and Rajabhau Waje, while Sanjay Dina Patil, Sanjay Deshmukh, Sanjay (Bandu) Jadhav, Omraje Nimbalkar, Bhausaheb Wakchaure, and Nagesh Patil Ashtikar staged a complete boycott of the meeting.According to sources, the rebel faction has already filed an application before

Lok Sabha Speaker Om Birla to be recognised as a separate bloc, paving a clear legal path for their formal merger with the Eknath Shinde-led Shiv Sena.Sources said the dissenting lawmakers passed an internal resolution detailing ideological differences as the driving force behind their exit. It says the leadership has drifted significantly from the original Hindutva ideology

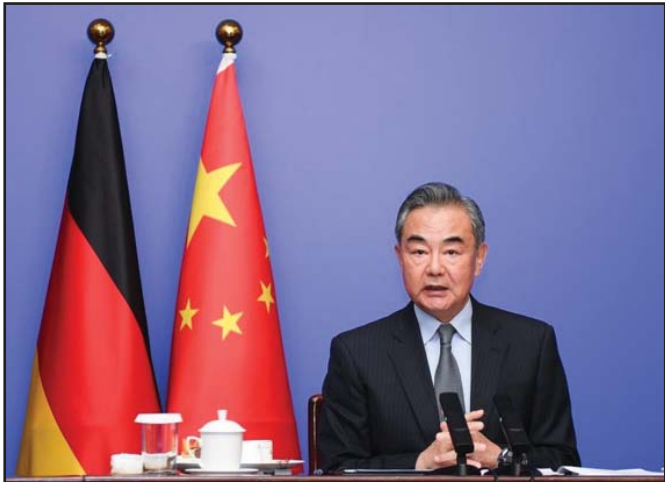
established by party founder Balasaheb Thackeray. The resolution explicitly notes growing anxiety within the rank and file regarding a potential full-scale merger of Shiv Sena(UBT) into the Congress party, highlighting that the regional party was never envisioned to lose its identity to a national outfit.The MPs further referenced recent statements by senior leader

Sanjay Raut suggesting that regional parties like the Trinamool Congress should merge with Congress, amplifying fears that a similar fate awaited the Thackeray group.Anticipating public outrage and potential law-and-order issues across Maharashtra, security has been beefed up substantially outside the residences of the defecting MPs. Local police forces

have set up heavy bandobast (security deployments) outside several properties, including Mumbai North East MP Sanjay Dina Patil’s residence, to prevent any untoward incidents. Sources indicate that Sanjay Jadhav is slated to take up the leadership mantle of this newly formed parliamentary breakaway group.

Chinese FM Wang Yi To Visit India For BRICS NSA Meeting

Beijing,18/6: Chinese Foreign Minister Wang Yi will visit India to attend the 16th Meeting of BRICS National Security Advisors (NSAs) and High Representatives on National Security set to be held from June 22-23. Confirming the visit, spokesperson for the Chinese Ministry of Foreign Affairs said on Thursday that Wang Yi will visit India at the invitation of National Security Advisor (NSA) Ajit Doval. “At the invitation of India’s National Security Advisor Ajit Doval, Wang Yi, Member of the Political Bureau of the CPC Central Committee and Director of the Office of the Central Commission for Foreign Affairs, will attend the 16th Meeting of BRICS National Security Advisors and High Representatives on National Security to be held in India from June 22 to 23,” the ministry spokesperson posted on X. India holds the BRICS chair in 2026 guided by the theme of ‘Building for Resilience, Innovation, Cooperation and Sustainability’, reflecting a people-centric and humanity-first approach



articulated by Prime Minister Narendra Modi at the 17th BRICS Summit held in Rio de Janeiro in 2025. On May 15, China’s Ambassador to India, Xu Feihong, congratulated India for successfully hosting the BRICS Foreign Ministers’ Meeting. He stated that BRICS Chair’s statement and outcome document demonstrate broad consensus on international and regional issues, the future development of BRICS and the reform of global governance and the multilateral system. In a post on X, Xu

Feihong stated, “Congratulations to India on successfully hosting the BRICS FMM. In the face of a complex global landscape, BRICS countries engaged in in-depth and constructive discussions on a wide range of issues.” “The Chair’s Statement and Outcome Document demonstrate broad consensus on international and regional issues, the future development of BRICS, as well as reform of global governance and the multilateral system. As incoming Chair, China stands ready to work with all partners

to deepen solidarity and cooperation, and looks forward to welcoming colleagues to China next year,” he added. India issued a Chair’s statement instead of a joint statement at the conclusion of the two-day BRICS Foreign Ministers’ Meeting in New Delhi, insisting that there were differing views among members with regard to the situation in West Asia and the Middle East. The high-level gathering was chaired by External Affairs Minister (EAM) S Jaishankar and witnessed participation of foreign ministers and senior representatives from BRICS member countries and partner nations. In February, China’s Executive Vice Foreign Minister Ma Zhaoxu visited India to participate in the BRICS Sherpa Meeting. During the visit, Ma Zhaoxu and Foreign Secretary Vikram Misri held the India-China Strategic Dialogue in New Delhi during which both sides discussed bilateral ties. The officials of two nations also exchanged views on global, regional situations and other multilateral issues.

India Is A Compelling Case For World On AI: Piyush Goyal

Paris/New Delhi,18/6: India is a compelling case for the world, Union Commerce and Industry Minister Piyush Goyal said on Thursday — highlighting the country’s young population, affordable data, growing technological capabilities and vision for inclusive growth as key factors positioning it at the forefront of the global technology revolution. Speaking on India’s role in the age of artificial intelligence (AI) at Viva Tech 2026, Goyal said the country has several inherent strengths that make it uniquely placed to bridge the global technological divide. He asserted that India adapts technology faster and more efficiently than many other nations and views AI as an enabler of growth rather than a threat. “India is a compelling case for the world. Our young & talented population, affordable data, growing capabilities & a vision for shared growth, position India at the forefront of technological development,” Goyal mentioned. The minister emphasised that AI can never



replace human intelligence, values, culture and traditions. Goyal noted that India’s demographic advantage remains one of its biggest strengths, with the country’s average age being below 30 years. “We have a youthful population. That’s important. Our average age is under 30 years. We are the world’s fastest growing large economy. So a lot of economic activities which spur innovation. We have 1.4 billion people generating demand and that gives us economies of scale,” Goyal stated. The minister further said India has sufficient power resources to

meet the growing requirements of data centres and computing infrastructure. “We have data at a fraction of the cost it costs in other countries. We have abundant power to meet the needs of data centres, computing capacity and all of that. And we produce the world’s largest number of STEM graduates, the techies in science and engineering and technology,” Goyal noted. Addressing concerns over job losses due to AI, Goyal said technological advancements would create new opportunities and career paths rather than eliminate human relevance.

Trump Seals Iran Breakthrough At Versailles; Says Step Towards Regional Stability, Lower Energy Prices

Washington,18/6: US President Donald Trump has secured a major diplomatic breakthrough with Iran, finalising a US-Iran memorandum of understanding aimed at ending hostilities and reopening the Strait of Hormuz before signing the accord at France’s Palace of Versailles. Speaking to reporters after arriving in Paris, Trump said the agreement was nearing completion and suggested a formal conclusion was imminent. “I’d say 48 hours,” Trump said when asked when the deal would be signed. Hours later, as he emerged from a dinner hosted by French President Emmanuel Macron at Versailles, Trump confirmed that the accord had been executed. “It’s signed,” Trump told reporters. “I signed it in Versailles. Just signed it.” The memorandum is intended to create a framework for further negotiations between Washington and Tehran while



reducing tensions in the Gulf region and restoring normal shipping through the Strait of Hormuz, one of the world’s most important energy corridors. Trump repeatedly portrayed the agreement as a step towards regional stability and lower energy prices. “The question was, how long will you leave the military in the Gulf? I would say a little while,

see how it all goes. I think it’s going to go well, but we’ll see,” he said. The president indicated that preventing Iran from obtaining a nuclear weapon remained the central objective of the negotiations. Asked about provisions concerning Iran’s nuclear programme, Trump said concerns over existing nuclear material were “much less important than not

having a nuclear weapon”. He also signalled flexibility regarding the memorandum’s reported 60-day timeframe for negotiating a broader settlement. “I don’t view it as hard, no,” Trump said. “Just as long as they’re behaving, I really don’t care that much.” At the same time, he made clear that military action remained an option if Iran failed to comply with the agreement. “If they don’t come through, is it a threat that we’d bomb? You can call whatever you want, but it will probably happen,” Trump said. The president also drew a distinction between nuclear weapons and conventional missile capabilities, suggesting Iran should be permitted some ballistic missiles if neighbouring states maintained similar arsenals. “I’m saying that if other countries have them, it’s a little bit unfair for them not to have some,” Trump said. “A ballistic missile is not the same thing

as what we’re talking about when we talk nuclear.” But if Saudi Arabia and Qatar and they all have some, I would say in relative proportion, I think it’s OK.” Trump’s comments came as leaders gathered in France for discussions on global security, trade and energy issues. On Ukraine, he said Kyiv was continuing to resist Russia despite Moscow’s larger military. “Russia’s a big country, a much bigger military. But they’re doing pretty well, they’re holding their own,” Trump said. He also suggested he could reconsider sanctions measures against Russia. “Yeah, I may put them back on,” he said. “Now that the oil price is way down ... I may put it back on.” The Versailles signing capped a day in which Trump repeatedly defended the emerging agreement and described it as a positive development for global markets and energy security.

The India-France partnership is vital for the progress of our planet.” Earlier on Wednesday evening, Prime Minister Narendra Modi said he had a productive round of meetings and interactions at the G7 Summit in Evian, where he presented India’s views on governance, policy-making and the importance of working closely with the Global South to ensure global prosperity. PM Modi noted that the discussions at the summit provided an opportunity to highlight India’s efforts in key areas of governance and to emphasise the role of the Global South in shaping a more equitable international order. He said India’s perspectives were well received by leaders attending the summit. Following the conclusion of his engagements in Evian, PM Modi will travel to Paris for the final leg of his visit to France. His programmes in Paris include an address at VivaTech 2026, one of Europe’s largest technology and innovation conferences, and an interaction with the Indian diaspora at a community event. Taking to his official X account, PM Modi wrote: “I had a series of productive meetings and exchanges during the G7 Summit in Evian. I had the opportunity to present India’s positions and efforts on key areas of governance and policymaking.

Regulatory, Tech And AI Risks In NSE IPO, Trading Activity Declines: DRHP

Mumbai,18/6: The National Stock Exchange (NSE) has cautioned investors that regulatory changes, technology failures, cybersecurity threats and emerging risks associated with artificial intelligence (AI) could materially impact its business operations and financial performance, as the stock exchange moves ahead with its long-awaited initial public offering (IPO).In its draft red herring prospectus (DRHP) filed with the Securities and Exchange Board of India (SEBI), NSE highlighted its significant dependence on trading revenues, particularly from the derivatives segment.

The exchange said transaction charges accounted for 78.65 per cent of its operating revenue in FY26, with options trading alone contributing 60.22 per cent of total revenue from operations.The exchange noted that recent regulatory measures introduced by SEBI to strengthen the equity derivatives framework have already resulted in moderation in trading activity across both cash and derivatives segments.This, in turn, led to lower trading revenues during FY26. NSE warned that



any further regulatory tightening, increase in transaction taxes, changes in investor behaviour or a shift toward alternative asset classes could adversely affect trading volumes and profitability.The stock exchange also underscored the extensive regulatory oversight under which it operates.It disclosed that it remains subject to continuous inspections, examinations and enforcement actions by SEBI and has received show-cause notices, warning letters, deficiency letters and advisory communications related to governance, operational,

technology and compliance matters.NSE revealed that it has incurred substantial settlement costs in recent years. In October 2024, the exchange paid more than Rs 643 crore in connection with proceedings related to its Trading Access Point (TAP) architecture and network connectivity.It also paid Rs 40.35 crore in July 2025 under a settlement order linked to regulatory inspection findings.The exchange further stated that several legal and regulatory proceedings remain unresolved, including matters related to the co-location and

dark fibre cases.According to the DRHP, these proceedings could continue to have reputational and financial implications for the bourse.Given the fully electronic nature of stock market operations, NSE identified technology failures and cyberattacks as major operational risks.The exchange acknowledged experiencing multiple technology-related incidents in recent years, including website outages, market data dissemination issues, login disruptions and errors involving derivatives-related information. Additionally, the bourse flagged risks associated with AI-powered cyberattacks, deepfake-based impersonation, data leaks through third-party AI tools and vulnerabilities introduced by AI-assisted software development.NSE also highlighted concentration risks among its trading members. The exchange said its top 10 trading members accounted for 46.78 per cent of operating revenue in FY26, making its earnings vulnerable to any disruption or decline in activity among these key participants.

Sensex, Nifty End Higher As PSU Banks, Healthcare And Realty Stocks Lead Gains

Mumbai,18/6: Indian equity benchmark indices closed higher on Thursday, supported by flag-end buying and gains in PSU bank, healthcare, metal and realty stocks, even as weakness in the IT sector capped the upside.The Sensex rose 254.36 points, or 0.33 per cent, to settle at 77,409.98, while the Nifty gained 82.30 points, or 0.34 per cent, to close at 24,168.00.Commenting on Nifty technical outlook, experts said that the 24,200 level now emerges as the immediate resistance.“A sustained breakout above this level would reinforce bullish momentum and could pave the way for an extension of the rally towards the 24,400 region, which represents the next significant upside target,” an analyst said.“On the downside, the psychological 24,000 mark is expected to act as an important immediate support level. Holding above this zone will be crucial to preserve the ongoing recovery structure and maintain the positive momentum. However, a decisive break below 24,000 could trigger fresh profit booking and drag the index towards the 23,900 support region,” a market expert mentioned.Market sentiment improved in the latter half of the

trading session, helping benchmark indices recover and end in positive territory.Buying interest in public sector banks, healthcare and real estate counters provided support to the broader market.Among the Nifty constituents, Adani Enterprises, InterGlobe Aviation and Max Healthcare Institute emerged as the top gainers of the day.Among Sensex constituents, shares of Adani Ports, InterGlobe Aviation, Trent, NTPC, Bharat Electronics Limited, HDFC Bank and State Bank of India were among the major gainers, helping benchmark indices end the day in the green.

The broader market also witnessed positive momentum. The Nifty MidCap index ended



0.41 per cent higher, while the Nifty SmallCap index advanced 0.44 per cent.Sectorally, the Nifty PSU Bank, Nifty Healthcare, Nifty Realty and Nifty Consumer Durables indices outperformed

the broader market. The healthcare pack led the gains, with the Nifty Healthcare index climbing 0.98 per cent.On the other hand, information technology stocks remained under pressure. The Nifty IT index declined 1.19 per cent, making it the worst-performing sectoral index of the session.“Going forward, market participants will continue to monitor developments in the US-Iran talks, crude oil prices, and foreign fund flows,” an analyst stated. Meanwhile, Rupee traded stronger by around 16 paise to 94.32, extending its positive trend

for the fifth consecutive session.“Technically, the rupee remains well supported, with the near-term trading range seen between 94.00 and 94.75,” the analyst mentioned.

RBI Compounds FEMA Violations In Apollo Hospitals Case With Rs 17.77 Crore Fine

New Delhi,18/6: The Reserve Bank of India (RBI) on Wednesday issued a compounding order under Section 15 of the Foreign Exchange Management Act (FEMA), in the case of M/s. Apollo Hospitals Enterprises Limited and its five concerned directors and officers, including Preetha Reddy, Suneetha Reddy, S.K. Venkatraman, Akhileswaran Krishnan and S.M. Krishnan, which has resulted in termination of adjudication proceedings against the company for contraventions of provisions under FEMA with a one-time payment of Rs 17.77 crore.In addition, each of the directors and officers of the company have to pay Rs 18 lakh.

The order has been passed by the RBI after the Enforcement Directorate (ED) issued a “no objection” in the case.The ED had taken up investigation after receiving credible information in the case.After completion of investigation, the ED filed a case under FEMA before the Adjudicating Authority.The company, later on, filed an application before the RBI for



compounding the contraventions in accordance with the provisions of Section 15 of the Act.Section 15 provides a mechanism for individuals or companies to voluntarily admit to a violation of FEMA regulations, pay a penalty, and regularise the contravention without undergoing lengthy litigation or legal proceedings.On reference from RBI, the ED issued no objection for such compounding in line with the true spirit of the Act.Accordingly, the RBI, on the basis of no objection issued by ED, has compounded the contraventions in the case which

include receiving FDI in retail trading, which is a sector in which foreign investment is prohibited.A sum of Rs 859. 88 crore was involved in the contravention.The complaint filed against Apollo Hospital Enterprise also included issuance of Foreign Currency Convertible Bonds (FCCBs) valued at Rs 70.02 crore in contravention of FEMA.Besides, the company received foreign investment under Foreign Institutional Investor-Portfolio Investment Scheme route to the tune of Rs 623. 88 crore which in aggregate breached the 24 per cent paid-up capital limit.

Mumbai,18/6: Gold and silver prices traded lower on Thursday after easing geopolitical tensions, and the US Federal Reserve kept interest rates unchanged while signalling support for additional rate hikes.On the Multi Commodity Exchange (MCX), gold futures (August) declined as much as 1.37 per cent or Rs 2,111 to hit an intraday low of Rs 1,51,768 as of around 11:36 am.The yellow metal was trading at Rs 1,51,797, down 1.35 per cent or Rs 2,082. It touched an intraday high of Rs 1,52,831, down 0.68 per cent or Rs 1,048 from its previous close of Rs 1,53,879.Meanwhile, silver futures (July) were trading at Rs 2,44,945, down Rs 6,862 or 2.73 per cent from the previous close of Rs 2,51,807.The white metal touched an intraday low of Rs 2,44,647, down nearly 3 per cent or Rs 7,160 during the session. It recorded an intraday high of Rs 2,48,000 during the day. Earlier in the day, gold and silver opened at Rs 1,52,306 and Rs 2,48,000,



respectively.According to commodity market experts, gold and silver remained under pressure as rising US Treasury yields and a stronger dollar reduced the appeal of precious metals.They said sentiment weakened after the US Federal Reserve kept interest rates unchanged while signalling support for additional rate hikes and reiterating its commitment to bringing inflation back to

target.Analysts said easing geopolitical tensions following the interim US-Iran agreement further dampened safe-haven demand.However, silver's losses remained limited amid expectations of strong industrial demand, supported by investments in artificial intelligence (AI) infrastructure, data centres, renewable energy projects and energy storage systems, particularly in China,

analysts added.Similarly, in international markets, COMEX silver was trading nearly 3 per cent lower at \$68.76, while COMEX gold was at \$4,318.90, down more than 1 per cent.On the oil commodities front, the international benchmark Brent crude declined 1.64 per cent to trade around \$78 per barrel, while US West Texas Intermediate (WTI) crude fell 2 per cent to about \$75 per barrel.

Apple May Increase Product Prices Amid Soaring Memory, Storage Costs: CEO Tim Cook

New Delhi:,18/6: US-based tech giant Apple may raise prices across some of its products as surging memory and storage chip costs due to an increase in demand from artificial intelligence (AI) data centres continue to put pressure on the company's margins, according to a report.Speaking to The Wall Street Journal, Apple CEO Tim Cook said the company can no longer fully absorb the sharp increase in component costs and may eventually pass some of the burden on to consumers.“Unfortunately, price increases are unavoidable,” Cook was quoted as saying,“We're doing our best to mitigate the huge increases that are being passed to us, and we've been trying to shield our customers from the increases, but the situation has become



unsustainable.”The comments come amid growing concerns over the impact of AI-driven demand on global semiconductor supply chains.

Industry groups representing automakers, retailers and electronics manufacturers have warned that rising demand for

memory chips could lead to higher consumer prices and supply disruptions. However, Cook did not specify when the price increases could take effect, how large they would be or which Apple products would be affected.According to the report, memory and storage components have emerged as key concerns for the iPhone maker, particularly the dynamic random-access memory (DRAM)

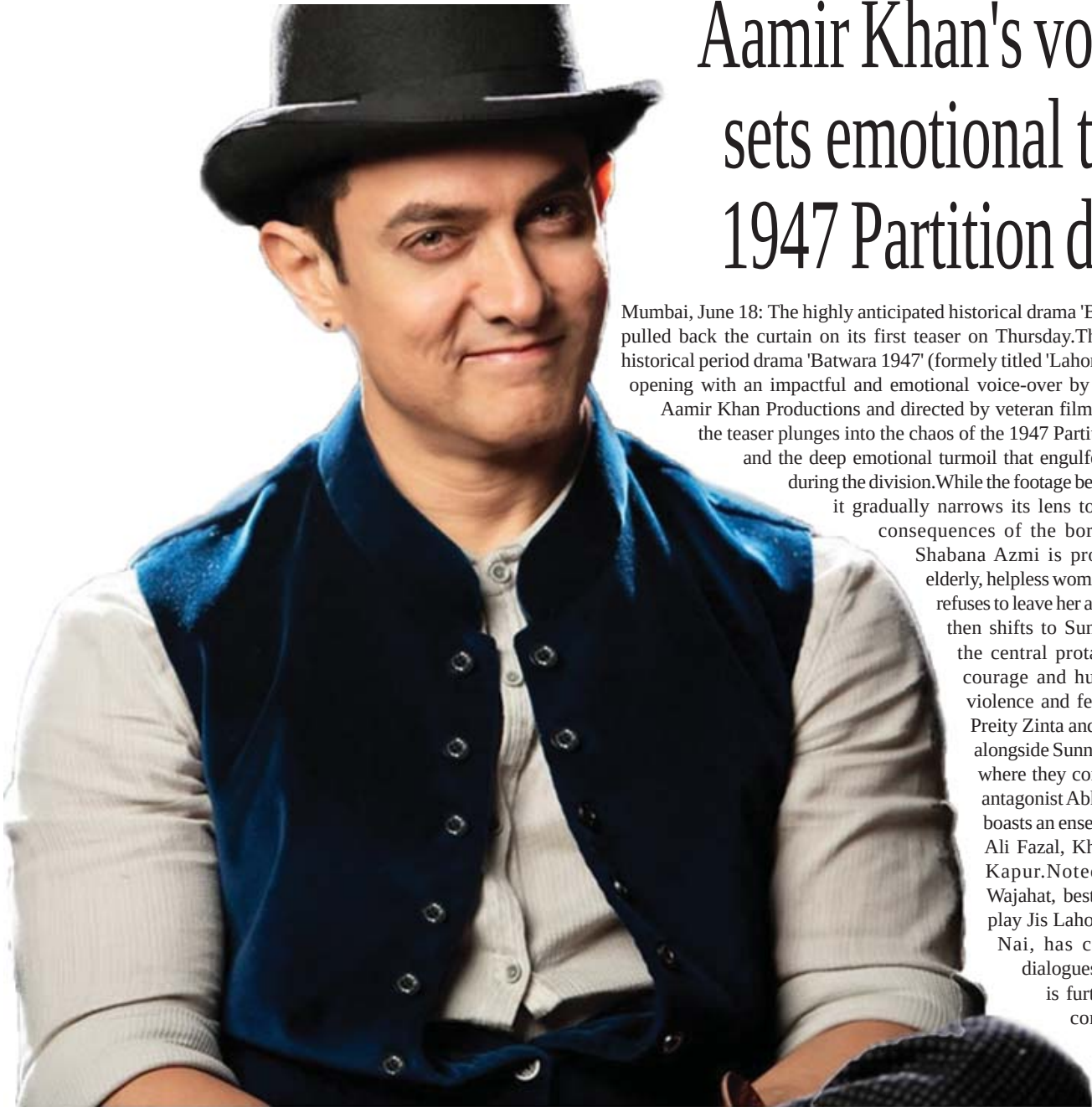
market, where supplies have tightened as chipmakers allocate more production capacity to high-bandwidth memory used in AI servers.Cook said increasing volumes of memory supply are being directed towards AI infrastructure, reducing

availability for consumer electronics.“There's less supply at a time when consumers want devices and the memory guys are passing along huge price increases,” he said.Cook said memory pricing and supply need to return to reasonable levels for consumer products.Earlier in April, the US-headquartered firm announced that John Ternus, Senior Vice President of Hardware Engineering, will succeed Tim Cook as Chief Executive Officer, effective September 1, 2026, concluding a long-running succession process that the board approved unanimously.However, he will transition to the newly created role of Executive Chairman, where he will engage with global policymakers and assist with select company matters.

Mumbai,18/6: The Reserve Bank of India (RBI) on Wednesday temporarily eased interest rate curbs on certain non-resident deposits to enable banks to offer higher returns on fresh FCNR(B) and NRE deposits with the aim of attracting more overseas funds to prop up the country's foreign exchange reserves and strengthen the rupee.Under the relaxed rules that have been put in place till September 30, the RBI has withdrawn the interest rate ceiling on fresh Foreign Currency Non-Resident (Bank) deposits with maturities of more than three years and up to five years. It has also removed restrictions on interest rates offered on fresh Non-Resident External (NRE) deposits of three years and above.However, the RBI said that transfers from Non-Resident Ordinary (NRO) accounts to NRE accounts would not qualify

for the exemption.Before the new rules were rolled out, banks were required to ensure that interest rates on NRE deposits did not exceed those offered on comparable domestic rupee term deposits. FCNR(B) deposits of three to five years were subject to an interest rate ceiling linked to the applicable overnight alternative reference rate or swap rate plus 350 basis points.The move gives banks more freedom to offer higher interest rates to non-resident Indians, in order to mobilise more foreign-currency and rupee deposits from overseas investors and savers.The measure also comes close on the heels of a series of steps that have been taken with a view to attracting foreign currency amid soaring oil prices in the global market and the exit of foreign funds from the Indian stock markets, which had led

to a drawing down of the country's foreign exchange reserves and weakened the rupee.Earlier this month, the RBI allowed all foreign individual investors to directly purchase shares in listed Indian companies, expanding access beyond non-resident Indians and overseas citizens of India. The move followed changes to foreign exchange rules that offered more investment opportunities to NRIs.The central bank also introduced a special swap facility that absorbs much of the hedging costs usually borne by banks. As a result, several private and public banks have passed on this benefit to customers, significantly hiking their dollar-denominated FCNR deposit rates (with some lenders offering between 6 per cent and 7.10 per cent on eligible tenor.

India Women Rally Past Uruguay to Top Pool A at FIH Nations Cup

NEWDELHI: India Women's Hockey Team defeated Uruguay 3-2 in their final Pool A match at the FIH Nations Cup in Auckland, maintaining an unbeaten record and securing the top spot in the group. Uruguay struck first in the 13th minute through Chiara Appennino's penalty corner. India responded with resilience as drag-flicker Deepika converted a penalty corner in the 24th minute to level the score. After halftime, India intensified their attack and Deepika Soreng netted a fine field goal in the 43rd minute to give India a 2-1 lead. Uruguay captain Manuela Vilar equalised in the 55th minute, setting up a tense finish. India answered immediately when Deepika converted her second penalty corner in the 56th minute, sealing the 3-2 victory. The win marked India's third



consecutive triumph after earlier victories against USA and Japan, ensuring they topped Pool A. USA joined India in the semi-finals as runners-up. The match also

carried special significance for midfielder Neha, who celebrated her 200th senior international appearance, a milestone applauded by teammates and fans alike. With three straight wins, India enters the

semi-finals brimming with confidence as they chase the Nations Cup title and a return to the FIH Pro League. They are likely to face Chile or Korea in the semi-final scheduled for June 20.

BCCI Breaks Silence on Vaibhav Sooryavanshi-Vishen Halambage Clash, Refuses to Intervene in Dambulla Incident

NEWDELHI: The Board of Control for Cricket in India (BCCI) has made it clear that it will not interfere in the recent on-field altercation involving India A batter Vaibhav Sooryavanshi and Sri Lanka A spinner Vishen Halambage during the tri-nation series in Dambulla. Addressing growing speculation on social media, BCCI Secretary Devajit Saikia stated that disciplinary matters arising from incidents on the field are solely the responsibility of match officials and not the cricket board. The controversy erupted following a heated exchange between Sooryavanshi and Halambage during India A's dramatic defeat to Sri Lanka A in a Super Over encounter. Television cameras captured the young Indian batter shoving the Sri Lankan spinner before being pushed back, leading to widespread debate among fans and former players. However, Saikia emphasized that the BCCI has neither the authority nor the intention to intervene in

such matters. "A lot of speculation is being made regarding possible action by the BCCI. These are baseless assumptions. The match referee and umpires are the competent authorities to deal with incidents that occur on the field of play," Saikia said. According to reports, match referee Pradeep Jayapragash has already taken action by imposing a fine on Halambage. Sri Lankan wicketkeeper Niroshan Dickwell, who stepped in during the confrontation, was also sanctioned. Sources indicate that tensions had been building between the two players, with Halambage allegedly engaging in verbal exchanges with Sooryavanshi during previous matches in the series as well. The BCCI chief reiterated that stepping into the matter would create an unhealthy precedent and undermine the authority of match officials. "The BCCI does not have any role in regulating on-field conduct during a match. If there is any breach of discipline or playing conditions, it is the responsibility of the match

referee and umpires to take appropriate action. There is already a well-established system in place," Saikia explained. The incident occurred after India A failed to chase 18 runs in the Super Over. As Sri Lanka A celebrated their victory, emotions spilled over, resulting in the confrontation that quickly went viral across social media platforms. While the BCCI has taken disciplinary action against players in off-field controversies in the past, including high-profile cases involving cricketers' public conduct, the board believes this incident falls exclusively within the jurisdiction of match officials. For now, the matter appears closed from the BCCI's perspective, with any further action expected to come only through the match referee's report and tournament disciplinary procedures. The episode has once again highlighted the intense rivalry between India A and Sri Lanka A, while also bringing attention to the growing spotlight on teenage sensation Vaibhav Sooryavanshi as he continues his development on the international stage.
