Govt prohibits manufacture, Sale and Distribution of 16 Fixed Dose Combinations



New Delhi: The government has banned the manufacture, sale and distribution of 16 fixed-dose combination (FDC) drugs for human use with immediate effect. The move follows a Supreme Court-directed review by an expert committee set up by the Drugs Technical Advisory Board, which found the drug combinations lacked therapeutic justification and could pose health risks. The banned products include certain dermatological, pain-relief, antispasmodic and antibiotic-based medicines. The Ministry of Health and Family Welfare said the action aims to ensure only safe, effective and scientifically validated medicines remain available. State drug regulators and enforcement agencies have been directed to strictly implement the ban.

Health Minister Chairs High-Level Virtual Review Meeting of TB Mukht Bharat Abhiyan with all States and UTs

New Delhi: Union Minister of Health and Family Welfare J.P. Nadda chaired a high-level review meeting with all States and Union Territories yesterday to assess the progress of the TB Mukht Bharat Abhiyan and chart the way forward towards achieving a TB-free India. Mr Nadda emphasised that the second phase of the intensified 100-day TB Mukht Bharat Abhiyaan, scheduled to conclude in the first week of July, represents a critical last-mile effort to identify every missing tuberculosis case and ensure that no vulnerable individual is left behind.

He informed that the country's TB incidence has declined to 187 cases per lakh population in 2024 compared to the figure of 243 cases per lakh in 2014. He further said that TB mortality has also witnessed a significant reduction and stands at 21 per lakh of the population in 2024 compared to 34 per lakh in 2014.

Mr Nadda called upon the States to actively engage their MPs and MLAs to review TB elimination efforts in their respective constituencies through Jan Bhagidari. He urged the State Health Ministers to conduct district-level analysis to identify gaps and ensure timely corrective action.

Ghaziabad: NEET aspirant dies by suicide, cites repeated failures



Ghaziabad: A 22-year-old NEET aspirant died by suicide at his house in Vijay Nagar on Friday and left a video message saying he could not clear the examinations for the past six years, police said.

According to the police, they received information about the incident on Friday morning. A police team reached the spot and found the man dead. He went to his room on Thursday night and was found dead the next morning.

"In the video recovered from his mobile, he said he was preparing for NEET examination for the past six years and could not clear it. He was under depression. He did not hold anyone responsible for his death," Upasana Pandey, ACP of Vijay Nagar circle told HT.

Police said the body was sent for autopsy. "His family told the police that the deceased went to his room on the first floor where he used to study for hours. They said he also appeared for the NEET-UG exam in May which went well. He was preparing for

the re-exam," Dharampal, SHO of Vijay Nagar police station told media. The ACP said the death was not linked to the recent NEET paper leak. The National Eligibility cum Entrance Test (Undergraduate) (NEET-UG) 2026 was conducted on May 3 and later got cancelled by the National Testing Agency (NTA) on May 12 over a paper leak scandal. The re-exam is scheduled on June 21 for over 2.2 million candidates across the country.

Cleanliness, patient safety, critical care: MCD charts hospital upgrade roadmap



New Delhi: Delhi's municipal hospitals are set to undergo a quality upgrade this year, with the MCD bringing nine facilities under the Centre's Kayakalp programme and expanding critical care infrastructure, officials said on Saturday.

The initiative is part of the civic body's broader effort to align its healthcare facilities with national quality benchmarks through improvements in cleanliness, infection control, waste management, patient safety, infrastructure, and service delivery, they said.

"Hospitals will be required to secure more than 80 per cent marks under the Kayakalp assessment framework to qualify for incentive," an official told PTI.

New Delhi: A passenger died after a group of fellow passengers allegedly kicked and punched him following a disagreement over boarding a train at platform number 3 of Shahdara railway station in northeast Delhi, the railways police unit of Delhi police said on Saturday.

The incident was captured on onlookers' mobile phones. A 52-second video clip that surfaced on social media shows a man, whose face is not clearly visible, being surrounded and assaulted by five to six people on a platform where a train is stationed.

A railway protection force (RPF) constable is seen in the clip attempting to rescue the man by

pushing the alleged attackers away. The man can then be seen collapsing on the platform, after which the alleged attackers pick up their luggage and leave the scene. The RPF constable and another man are also seen dragging him across the platform. Dumani Mail could not independently verify the authenticity of the clip.

Deputy commissioner of police (railways) B Bharat Reddy said police received information about a violent scuffle at platform number 3 of Shahdara railway station at the Old Delhi Railway Station (ODRS) police police station. The investigating officer (IO) found that the victim, Pankaj

Dhama, a resident of Baghat in Uttar Pradesh, had been severely assaulted with punches and kicks by fellow passengers while attempting to board the Yoga Express.

"Dhama was rushed to Guru Teg Bahadur (GTB) Hospital, where doctors declared him dead. A case of culpable homicide not amounting to murder is being registered under section 105 of the Bharatiya Nyaya Sanhita (BNS) at the police station. Further legal procedure is underway," said DCP Reddy.

Police have not disclosed any information on the alleged attackers or clarified whether they managed to flee the station or were apprehended.

about 5am, he went to take bath in a pond near his house and he was killed. The body was seized and sent to medical for postmortem

After the arrest, he confessed to the murder and showed a crime recreation scene of how he killed the police, said IIC Sadar Police Station Amit Kumar Bhuyan. After the murder, the police seized the brick used in the murder from under a tree on Binida Road. Pateswar confessed to the police that he had killed him over a land dispute, police said.

District-Level Orientation and Awareness Workshop Held Towards a Child Labour-Free Odisha

Khordha : In a significant step towards ensuring a safe future for children and building a child labour-free odisha, the khordha district administration, in collaboration with the labour department, organized a district-level orientation and awareness workshop. The programme was aimed at creating awareness about the provisions of the child and adolescent labour (Prohibition and Regulation) Act, 1986, strengthening its implementation, and promoting collective action against child labour. The workshop was held at the Jayee Rajguru Conference Hall in the Collectorate premises and was chaired by Additional District Magistrate (Administration) Pratap Chandra Beura. Senior officials from the state and district administration,

representatives from various government departments, labour organizations, social activists, and members of voluntary organizations participated in the event and discussed strategies for the eradication of child labour. Addressing the gathering, speakers emphasized that a "Child Labour-Free Odisha is our collective commitment." They highlighted the importance of ensuring every child's right to education and bringing children into the mainstream educational system. The participants stressed that eliminating child labour is not merely a legal obligation but also a moral and social responsibility of every citizen. Among those present were District Labour Officer Prabhakar Biswal, Divisional Labour Commissioner Ajaya Kumar



Pradhan, Joint Labour Commissioner Pranab Kumar Patra, State Resource Officer Dr. Bhaktabandhu Acharya and Deputy Collector (Emergency) Sritapa Mishra. The speakers noted that child labour remains a serious social concern that deprives children of their childhood, education, and opportunities for a better future. The officials reiterated that employing children below the age of 14 years in any

occupation or process is a punishable offence under the law. Similarly, engaging adolescents between 15 and 18 years of age in hazardous occupations or industries is strictly prohibited. Citizens were urged to report any incidents of child labour to the nearest Labour Office, Police Station, District Child Protection Officer, District Administration, Child Helpline 1098, or the toll-free Labour Assistance Number

1800-34567-03. In his address, ADM Pratap Chandra Beura said that children are the future of the nation and that providing them with access to education, healthcare, and protection is essential for building a prosperous society. He emphasized that coordinated efforts by government departments, social organizations, and the public are necessary to achieve the vision of a child

labour-free Odisha. Assistant Labour Officer, Bhubaneswar, Kaliputra Kuldeep Prasad delivered a detailed presentation on the provisions of the Child and Adolescent Labour Act, 1986. He explained the legal consequences and penalties applicable to individuals and institutions found employing children illegally. State Resource Officer Dr. Bhaktabandhu Acharya addressed various queries raised by participants and shared valuable insights on government initiatives and programmes aimed at preventing child labour and protecting children's rights. He underscored the importance of community participation and awareness in achieving long-term success in child labour eradication efforts. The workshop was attended by

Additional District Education Officer Bijaya Kumar Behera, District Social Welfare Officer Kusum Kumari Praharaj, District Child Protection Officer Banishree Pattnaik, District Information and Public Relations Officer Laxman Kumar Behera, along with officials from different departments, NGO representatives, labour leaders, and social workers. Major Crackdown on Fake Pilgrim Facilitators in Srimandir Premises; 11 Arrested

Puri: In a major operation against fraudulent activities targeting devotees, Puri police have arrested 11 persons posing as "Yatri Gumastas" (pilgrim facilitators) in and around the Srimandir premises over the past five days.

Thousands of devotees visit the revered Shri Jagannath Temple every day. According to police, some anti-social elements were exploiting pilgrims by falsely claiming they could arrange special or expedited darshan in exchange for money.

Acting on credible intelligence, police from Singhadwar Police Station launched a special surveillance drive in the

temple area. Personnel in plain clothes were deployed to monitor suspicious individuals and gather evidence.

During the operation, five alleged fake facilitators were arrested on June 18 under Singhadwar Police Station Case No. 149/26 and later produced before a court. On June 19, three more accused were arrested in connection with Case No. 151/26 for allegedly collecting money from devotees on the pretext of arranging special darshan.

Police said that a total of 11 fake "Yatri Gumastas" have been arrested in the last five days. The action was based on CCTV footage,



intelligence inputs and field investigations.

The arrested persons include Shankar Biswal, Arun Patra, Babuni Mahapatra, Sarbeswar Raut, Ranjit Samantaray, Vikram Pradhan,

Ajay Kumar Jena and Umakanta Padhi, among others.

Police seized ₹2,620 in cash and three mobile phones from the accused. Investigators suspect that

more individuals may be linked to the racket, and further investigation is underway.

Advisory for Devotees
Puri police have urged devotees not to fall prey to anyone offering special darshan, quick entry or other temple-related services in exchange for money. Pilgrims have been advised to immediately report such individuals to the nearest police personnel, the Singhadwar Police Station or the Puri Police Control Room.

Police reiterated their commitment to ensuring the safety, convenience and smooth darshan experience of all devotees visiting the temple.

However, DMRC stated that the first train from Kirti Nagar to Brig. Hoshiar Singh metro station will leave at 04:10 am, and



the first train from Dwarka to Dhanu Bus Stand at 04:15 a.m. It further said that train services will be available at an interval of 30 minutes till 06:00 a.m., followed by regular services as per the Sunday timetable. Meanwhile, preparations are in full swing across the country for Yoga Day, with political leaders, yoga

practitioners, diplomats, and citizens coming together to celebrate the ancient Indian practice that has evolved into a global wellness movement. From Kolkata and Hyderabad to Jodhpur and New Delhi, large-scale yoga events and awareness programmes were organised on Saturday ahead of the

nationwide celebrations on June 21. In Kolkata, where Prime Minister Narendra Modi is scheduled to lead the main International Yoga Day event, Director of the Morarji Desai National Institute of Yoga, Prof. Kashinath Samagandi, said the Prime Minister would perform yoga alongside thousands of participants. Highlighting yoga's global recognition, BJP leader Prakash Reddy in Hyderabad said Prime Minister Modi's vision played a key role in securing international support for Yoga Day at the United Nations. Under Nirbhay Chetna, a cadre of 28,500 Master Trainers is being developed at the State, district, and block levels to reach over 17.5 lakh male elected representatives across the country, said the statement. The three-day programme also marked the launch of the Nirbhay Chetna training module, developed by Transform Rural India.

CPGRAMS, Digital Life Certificates Driving Transparency And Citizen-Centric Governance: Dr Jitendra Singh

New Delhi, 20/6: Union Minister of State Dr Jitendra Singh on Saturday said that initiatives such as CPGRAMS and Digital Life Certificates are transforming governance in India by enhancing transparency, improving service delivery and making public administration more citizen-centric. During talks with Republic of Korea Interior and Safety Minister Yun Hojung, he highlighted India's digital governance achievements and called for deeper cooperation between the two countries in areas such as e-governance, artificial intelligence and public administration. The minister made these remarks during a meeting with Republic of Korea Minister of Interior and Safety Minister Yun Hojung, who is currently on an official visit to India. The two leaders, accompanied by their respective delegations, held extensive bilateral discussions lasting over an hour on strengthening cooperation in digital governance, public administration, capacity building and citizen services. Welcoming the Korean

delegation, Dr Singh said India and the Republic of Korea share a Special Strategic Partnership rooted in democratic values, innovation and a common commitment to good governance. He referred to the Joint Strategic Vision Statement finalised during the visit of Republic of Korea President Lee Jae Myung to India earlier this year, describing it as a roadmap for expanding bilateral cooperation. Highlighting India's progress in digital governance under the leadership of Prime Minister Narendra Modi, Dr Singh said technology-enabled governance platforms have significantly improved service delivery and grievance redressal mechanisms. He noted that initiatives such as CPGRAMS and Digital Life Certificates have enhanced transparency, reduced procedural hurdles and brought governance closer to citizens. The minister said India and the Republic of Korea are vibrant democracies with shared values, cultural links and a



commitment to the rule of law. He added that both countries, as major Asian economies, share a partnership that is historic as well as future-oriented. Dr Singh also recalled the historical ties between the two nations, referring to the marital connection between Princess Suriratna of Ayodhya and King Suro of the ancient Gaya confederacy, which continues to hold cultural significance in both countries. He appreciated Yun Hojung's contribution to strengthening India-Korea relations, particularly in his role as Chairman of the Korea-India Parliamentary Friendship Group, and expressed confidence that the visit would further deepen bilateral cooperation.

Less Confident Than Last Time': NEET Aspirants Ahead Of June 21 Re-Exam

New Delhi, 20/6: With just a day left for the NEET-UG re-examination on June 21, aspirants across the country are engaged in last minute preparations, however, some of them told IANS that despite studying hard they are less confident about their preparation this time as compared to the May 3 exam. A student in Jammu and Kashmir said that she initially thought the paper leak news was a "prank". "It was big news as the exam is conducted at the national-level. Initially I did not take it seriously thinking that it would be taken care of but when finally, realisation hit me, I started preparing for the re-examination again," she said. According to her, the re-exam questions will be tough. "When I started preparing again, one could only revise, because with so much stress it was not possible to study something new. Honestly, I still don't think I am well prepared this time," she added. Urging for transparent examinations, she emphasised:



"The efforts of lakhs of students should not go waste." Describing her preparations for the exam, another student Mariam said: "I had started taking coaching to appear for NEET from class 11 itself since I wanted to appear for the exam along with my class 12th Boards. My (May 3) exam went really well." "But after getting to know that we have to again appear for a re-examination

many students got very stressed, which impacted their health. Many of us are mentally not prepared, last time I was confident enough but now preparing amidst so much of stress is difficult," she added. Meanwhile, Mariam praised the government's measure of bringing in the Air Force for airlifting question papers to exam centres, in view

of time constraints, saying "Hopefully this time the exam will be conducted safely." In Karnataka's Dharwad, an aspirant Brijesh S.H. said: "I had appeared for the NEET examination in 2024-25 but did not achieve the expected marks. After that I decided to join a science college on the advice of my friends and teachers." Mentioning that his teachers guided him well, Brijesh said he had scored 610 in his last NEET attempt. "I was happy for this improvement in my score as before this it was 430," he said. Regarding the struggles of preparing for the NEET re-exam, he said: "Being a doctor is not easy, so our struggles start from here itself. We accepted it as a challenge though the preparation has in itself been a struggle." However, he too admitted that compared to last time, his preparation is not up to the mark for the re-exam. "Still, I hope I will clear the exam," he said.

BJP's Birthday Gift Jab At Rahul, After Shashi Tharoor's Praise For Modi Govt's Diplomacy

New Delhi, 20/6: The Bharatiya Janata Party (BJP) on Saturday took potshots at Rahul Gandhi and the Congress, calling out their propaganda over India's diplomacy in the conflict-ridden West Asia and said that they stand exposed after their own MP Shashi Tharoor's admission of the Indian gov't's clear and unambiguous stance against American 'misadventurism' in the Strait of Hormuz. A BJP spokesperson said that instead of giving gifts to Rahul on his birthday, they chose to 'puncture' his claims. Congress has been training guns on the Modi government over the killing of three Indian sailors in a recent US strike on a merchant vessel in the Gulf of Oman, accusing it of staying silent and not confronting the United States. They also mocked the Prime Minister over his recent meeting with US



President Donald Trump on the sidelines of the G-7 Summit. However, Tharoor's support for PM Modi's plain speaking during a meeting with Trump and also concerns about the safety of Indian sailors gave the BJP fresh ammo to target the Congress. Shashi Tharoor, speaking to IANS on Friday, said that PM Modi was right in raising

the security of Indian sailors with the US President and stating that civilian sailors must not become collateral victims of wartime situations. "Prime Minister Narendra Modi was particularly able to convey a message that we would all agree with, namely that commercial shipping should not be targeted in a war. These are civilian sailors, as you know,

pretty much every ship, whatever country's flag is flying, has Indian crew on board," Tharoor told IANS. He added that PM Modi conveyed a fair message surrounding the safety of seafarers in the shipping lanes of the Persian Gulf. Tharoor also said that even if Americans claim that they have no idea what crew is in the ship, the fact remains that these are civilian ships and civilian crew, and they should find a non-lethal way to deal with it. Citing Tharoor's support for the Indian government, BJP spokesperson Pradeep Bhandari said, "Shashi Tharoor has exposed Rahul Gandhi. Congress leaders are praising the Narendra Modi gov't's diplomacy." Further slamming the Congress MP, he said, "When it comes to protecting India's national interest, PM Modi comes first, when it comes to speaking

against India's national interest, Rahul Gandhi leaves everyone behind." BJP spokesperson Shehzad Poonawalla called it an embarrassment for the LoP Rahul, stating that the Congress leaders didn't give birthday gift to him on his birthday and rather chose to debunk his claims. "Tharoor didn't give birthday gift to Rahul Gandhi yesterday, rather he punctured his propaganda against the Modi government's silence before the US President on the killing of Indian sailors in the Persian Gulf," Poonawalla said. "Tharoor said that PM Modi articulately presented India's position before Donald Trump, stressing India's concern over the closure of the shipping lanes in the Strait of Hormuz and also the targeting of civilian sailors in American attack. This shows that even party leaders are not with him on the issue," the BJP spokesperson added.

Rajasthan Emerges As Hub Of ISI Spy Recruitment Through Family Pressure

New Delhi, 20/6: The Inter-Services Intelligence (ISI) is increasingly exploiting the Pakistan-based relatives of Indian citizens to blackmail and force individuals into its espionage networks, intelligence sources have revealed. The strategy primarily targets residents in the border districts of Rajasthan and Jammu and Kashmir to extract sensitive information about the Indian armed forces. An official said that in several recent cases, Indian nationals recruited by the ISI tried to withdraw from spying activities after facing heightened scrutiny from Indian security agencies. "To counter this, the ISI has reportedly turned to family members of Indian recruits living in Pakistan. These relatives are allegedly coerced into pressuring the recruits to continue their spying activities," the official

said. An Intelligence Bureau official said that the Pakistani agency has specifically identified relatives of Indians residing in Pakistan as a vulnerable group that can be used for recruitment and retention purposes. "The relatives themselves are often under pressure. For their own safety and security in Pakistan, they are forced to cooperate with the ISI and assist in influencing or recruiting their family members in India," the official said. Another senior official said that Pakistan is willing to employ every possible method to strengthen its espionage network in India. "The intention is to gather as much information as possible about the Indian armed forces," the official said, adding, "This explains the emphasis on recruitment efforts in Rajasthan and, to a lesser extent, Jammu and Kashmir."

Centre Bans 16 Fixed Dose Combination Drugs Over Safety And Efficacy Concerns

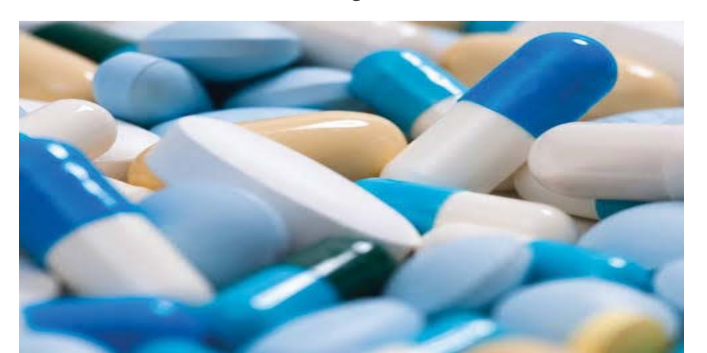
New Delhi, 20/6: In a major move aimed at strengthening patient safety and ensuring the rational use of medicines, the Ministry of Health and Family Welfare on Saturday said that it has prohibited the manufacture, sale and distribution of 16 Fixed Dose Combination (FDC) drugs for human use across the country. The ban has been imposed under Section 26A of the Drugs and Cosmetics Act, 1940, and has come into effect immediately. The decision follows

directions issued by the Supreme Court, which had called for a comprehensive review of Fixed Dose Combinations available in the Indian market. Acting on these directions, the Drugs Technical Advisory Board (DTAB) constituted an Expert Committee to examine various FDCs and assess their safety, efficacy and therapeutic value. After conducting a detailed scientific evaluation, the Expert Committee concluded that 16 FDCs lacked adequate therapeutic justification

and that their continued use could pose potential health risks. Based on these findings, the government decided to prohibit these combinations, stating that the risks associated with their use outweighed any potential benefits. The banned medicines belong to different therapeutic categories, including certain dermatological products, pain-relief and antispasmodic drugs, as well as some antibiotic-based formulations. The Ministry said that these combinations were

found to be irrational and not supported by sufficient scientific evidence. The Health Ministry emphasised that the action is part of the government's ongoing efforts to ensure that only safe, effective and scientifically validated medicines are available to the public. It noted that similar actions have been taken in the past against irrational drug combinations following extensive scientific reviews. With the latest notifications now in force, the manufacture for sale, sale,

distribution and supply of the identified 16 FDCs for human use stand prohibited nationwide with immediate effect. The Ministry has directed all State Drug Controllers, regulatory authorities and enforcement agencies to strictly implement the ban and ensure compliance. Manufacturers, importers, distributors and other stakeholders have also been advised to take necessary steps to align with the provisions of the law and discontinue the affected



products. The government said the move reinforces its commitment to evidence-based

healthcare and patient safety while promoting the rational use of medicines in the country.

Bolivian President Declares State Of Emergency To Restore Road Traffic

La Paz, 20/6: Bolivian President Rodrigo Paz announced early Saturday the implementation of a state of emergency aimed at restoring road traffic across the country after weeks of nationwide blockades related to protests. Since early May, road blockades in several parts of Bolivia have disrupted the transportation of fuel, food and medical supplies, causing shortages in some cities and dealing a heavy blow to economic activity, Xinhua news agency reported. In a message posted on social media, Paz said Bolivians could no longer remain "hostages" to road blockades that prevent people from working, studying, receiving medical care, obtaining essential goods and supporting their families. "This state of emergency is not intended to take away normality, but to restore it," the president said. Paz also stressed that the government's doors would remain open to all those willing to engage in good-faith dialogue. "Meanwhile, Bolivia needs to recover its roads,



guarantee supplies and return to normality," he said. On Thursday, the Bolivian government signed an agreement with the trade union federation Bolivian Workers' Central, a key participant in the protest movement, committing both sides to address pending demands through dialogue. The agreement has been viewed as an important step toward resolving the country's social unrest, which has lasted for about 50 days. However, some farmers and indigenous groups continue to maintain road blockades, and

transportation networks across the country have yet to fully return to normal. The protests were initially launched by the trade union group, farmer organisations, and indigenous groups over issues including fuel shortages and rising living costs. Earlier this month, President Paz enacted a new law regulating states of emergency, as continuous protests and road blockades have led to disruptions in supplies, transport and the economy. Law 1740 allows the president to declare a state of

emergency through a supreme decree in situations involving threats to state security, external threats, internal unrest or natural disasters. The decree must be sent to the Plurinational Legislative Assembly, Bolivia's national legislature, which has 72 hours to rule on it. Speaking at the government headquarters in La Paz, Paz said the law is aimed at protecting the majority of Bolivians, defending the constitutional order and restoring economic normality. The president said dialogue would remain the main tool of his government, but warned groups he described as violent and linked to "narcoterrorism" that the state would act firmly under the law. The 27-article law regulates states of emergency under Bolivia's Constitution, guarantees fundamental rights during their implementation and defines the roles of the police, armed forces and prosecutors. Paz said the measure has institutional backing and was approved by a qualified majority in the Plurinational Legislative Assembly.

Nepal's Central Zoo Closed After Confirmation Of Bird Flu

Kathmandu, 20/6: Nepal's Central Zoo in the Kathmandu Valley has been closed indefinitely since Friday after bird flu was detected in more than a dozen birds and animals. The zoo, home to a wide variety of wildlife, is one of the major attractions for holidaymakers, students, and tourists visiting the Valley. Issuing a notice late Friday, the Central Zoo authorities said the facility has been closed until further notice to protect the health and safety of the general public and visitors following the detection of avian influenza (bird flu) infections among birds and animals inside the zoo premises. The National Trust for Nature Conservation is responsible for operating the Central Zoo. Although human-to-human transmission of bird flu is rare, there are instances where people in daily contact with infected birds have contracted the virus. Ganesh Koirala, an information officer at the Central Zoo, told IANS that the zoo has been closed for disinfection



following the detection of bird flu. "The zoo is expected to remain closed for at least one week, and it may be prolonged depending on the risk," he said. According to him, more than a dozen animals — mostly birds, along with a few mammals such as leopard cats, jungle cats, and civets — have been found infected with the virus. The zoo authorities, however, have not made any plan to carry out wholesale culling of birds, unlike in poultry farms. Animals housed at the zoo were infected as the disease spread

in the Kathmandu Valley in recent days after it was first detected in eastern Morang district of Koshi Province on March 18 this year. Since then, at least 55 poultry farms in 10 districts have been affected, forcing authorities to destroy a total of 479,156 birds and 694,193 eggs, according to the Department of Livestock Services. Likewise, 182,775 kg of animal feed was also destroyed, it said. "The outbreak appears to be contained and remains under control in Koshi Province. However, the increasing number

Iran Says New Meeting With US Being Planned For 'Coming Days'

Tehran, 20/6: Iran's Foreign Ministry spokesman Esmail Baghaei said that a scheduled meeting between Iranian and US delegations in Switzerland has been postponed, and planning is underway for another one in the coming days. Speaking to reporters, Baghaei explained that consultations for the next phase of talks are ongoing through mediators, and a new date will be announced once conditions are set, according to a statement by the Iranian Foreign Ministry. He noted that under the recently signed memorandum of understanding (MoU) between Iran and the United States, the start of negotiations depends on the implementation of those provisions, including an end to the war and military operations on all fronts, including Lebanon, the

removal of US naval blockade, the reopening of the Strait of Hormuz for vessel passage free of charge for 60 days, US issuance of waivers for Iran's exports of crude oil, petroleum products and derivatives, and the release of Iranian frozen assets, Xinhua news agency reported. Baghaei said that Friday's meeting was originally intended for signing the MoU and discussing arrangements for talks on the final agreement. However, it became "non-urgent," he explained, after Iranian President Masoud Pezeshkian and his US counterpart Donald Trump electronically signed the document early Thursday. Baghaei denied reports that Iran had invited the International Atomic Energy Agency (IAEA) to inspect its nuclear facilities,

saying that under the MoU, negotiations on Iran's nuclear program are scheduled to take place within 60 days, provided prerequisites are met. He said that under the MoU, Iran will maintain its current nuclear status quo, limiting IAEA inspections to facilities like the Bushehr Nuclear Power Plant. Access to sites previously denied due to the US and Israeli attacks will hinge on the negotiation process and its outcome, he added. Iran, the United States, and Pakistan early Monday announced the finalisation of the MoU on ending the war in the region on all fronts, including Lebanon, following weeks of negotiations. On February 28, Israel and the United States launched joint attacks on Tehran and other Iranian cities.

Israeli Airstrike Hits Lebanon After Ceasefire Takes Effect

Beirut, 20/6: An Israeli airstrike targeted the Jabal al-Rafee area near the southern Lebanese town of Sajd, shortly after a ceasefire between Lebanon and Israel took effect, according to Lebanon's National News Agency. The ceasefire took effect at 4:00 p.m. on Friday (local time), Xinhua news agency reported. Hezbollah leader Naim Qassem said on Friday that the group would confront Israel with weapons if attacked, stressing that threats of death would not deter its members. "The project to eliminate Hezbollah and entrench the occupation has failed, and the Israelis will withdraw from every last inch of our land," Qassem said in a televised speech on al-Manar local TV channel. He added that Lebanon was facing "the most



dangerous stage" and an "American-Israeli project" targeting the future of the country, accusing Israel of seeking to turn Lebanon's political authority against the resistance movement and of obstructing

reconstruction efforts in areas affected by the conflict. Qassem also said Hezbollah's weapons are directed solely against Israel and called on Israel to respect Lebanon's sovereignty and territorial

integrity. His remarks came as an Israeli airstrike targeted the Jabal al-Rafee area near the southern Lebanese town of Sajd on Friday, shortly after a ceasefire between Lebanon and Israel that took effect at 4:00 p.m. local time, according to Lebanon's National News Agency. Earlier in the day, Ibrahim al-Moussawi, a member of Hezbollah's parliamentary bloc "Loyalty to the Resistance," said that the group would continue to abide by the ceasefire agreement provided that Israel also respects its terms. Meanwhile, Lebanon's Public Health Emergency Operations Center said the cumulative toll from Israeli attacks since March 2 had risen to 3,980 people killed and 12,001 injured.

Trump Expects Iran To Agree To Final Deal Within 60 Days

Washington, 20/6: US President Donald Trump said that he expects Iran to agree to a final deal within 60 days of the signing of the memorandum of understanding (MoU). If no deal is reached within 60 days beginning Thursday, "we will do things that won't make them happy," Trump said at Joint Base Andrews in Maryland on Friday. "But I don't think it's going to get to that." The text of the MoU states that the two sides commit to negotiating and achieving the final deal in maximum 60 days, extendable with mutual consent, Xinhua news agency reported. US-Iran talks scheduled in Switzerland was postponed, with neither side offering an official explanation. Multiple media reports said that Iran withdrew from the talks in response to the latest Israeli strikes in Lebanon. Earlier on Friday, Trump told NBC News that he had spoken with Israeli



leaders and urged them to agree to a ceasefire with Hezbollah. "It's a positive," Trump said in the phone interview. "It's a little icing on the cake." Meanwhile, the US State Department said that a new round of talks between Israel and Lebanon will be held in Washington, DC next week. Earlier, in a statement,

Switzerland's Federal Department of Foreign Affairs stated, "The Planned talks between the US, Iran, Qatar and Pakistan have been postponed. Switzerland remains ready to facilitate these talks. The relevant preparatory work at Burgenstock is continuing. No further information can be provided at

present." The talks between the US and Iran were planned to move from a political framework agreement to detailed negotiations on implementation, verification and compliance. On Thursday night, the White House announced that US Vice President JD Vance's planned departure for technical negotiations with Iran has been postponed. However, it said preparations for the talks continue and both sides remain focused on launching the next phase of discussions aimed at implementing the recently signed memorandum of understanding. "As the Vice President said at his press conference, the plans for the upcoming technical talks have not been finalised, and the US delegation has been prepared to depart at the first available opportunity," a White House spokesperson said late Thursday night.

Trump Calls PM Modi 'Great Leader', Lists Him Among World Leaders He Most Admires

Washington: US President Donald Trump praised Prime Minister Narendra Modi as a "great leader" and a "very tough cookie", placing him among the world leaders he most admires during an interview with Axios in which he reflected on power, diplomacy and global leadership. During the interview, Trump repeatedly highlighted PM Modi while discussing the qualities he believes define effective leadership, pointing to the Indian Prime Minister's longevity in office, political strength and international standing. Reflecting on leaders he encountered at the recent G7 summit, Trump recalled PM Modi's presence among the invited world leaders. "(PM) Modi of India, great guy," Trump said while describing the gathering of heads of government and state leaders. Later, when asked how he defines a great leader, Trump cited PM Modi as an example of political stability in a country that had previously seen frequent changes in leadership. "All my life I've watched India, they just kept changing, changing, changing. Somebody would there, be there for six months and then a year. And then all of a sudden, Prime Minister Modi ends up there. He's been there for more than 12 years, very solid," Trump said. Trump said PM Modi combines calmness with political toughness. "He does it through, like, there's a great calmness and



yet he's not a calm person. He's a very tough guy. I know him very well," he said. The US President later named PM Modi among the global leaders he most respects when asked which figures stand out for their ability to exercise power and leadership. "Well, I think (PM) Modi is — very good. Yeah," Trump said. "(PM) Modi's a great leader." He also referred to India's growing global weight and demographic importance. "He's, uh, 1.5 billion people. He's actually the biggest. India's actually the biggest," Trump said. Trump noted that he described as India's recent economic performance and credited PM Modi's approach to international affairs. "They've had some very good numbers announced," he said. "He stays out of wars, which is smart." The President also offered a more personal assessment of the Indian leader. "I've seen, you know, I

know the, the real PM Modi is a very tough cookie," Trump said. During the wide-ranging conversation, Trump also praised Chinese President Xi Jinping, calling him "great", and cited both Xi and PM Modi as examples of influential leaders who command respect in their respective countries. The interview covered a broad range of topics, including the G7 summit, China, Iran, artificial intelligence and US foreign policy. Throughout the discussion, Trump argued that leaders who rise to the highest offices tend to possess uncommon abilities and resilience. "Look, they're all smart. You can't get to that level without being smart," he said. "To be in these positions, you have to be smart, you have to be tough." PM Modi has served as India's Prime Minister since May 2014 and is among the longest-serving elected leaders of a major democracy.

Yoga Day Draws Large Crowd In Washington

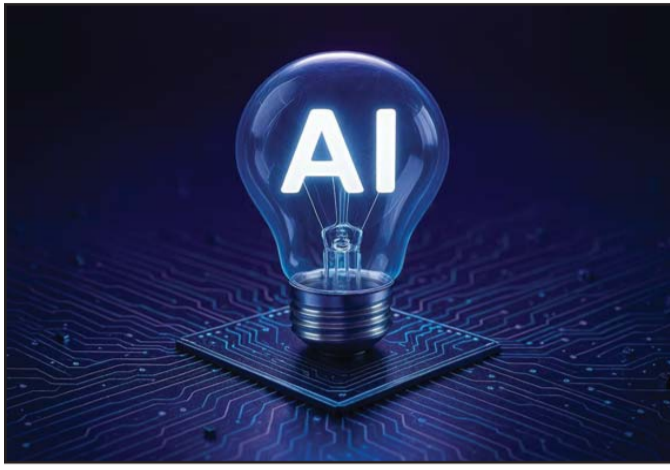
Washington: Hundreds of yoga enthusiasts gathered at the Lincoln Memorial on Friday morning as the Embassy of India marked the 12th International Day of Yoga, turning one of Washington's most iconic landmarks into a sprawling open-air yoga arena overlooking the National Mall. Against the backdrop of the Lincoln Memorial and the Washington Monument, participants spread colourful yoga mats across the memorial plaza and moved through a series of breathing exercises, stretches and meditation sessions. The crowd

included members of the Indian diaspora, local residents, yoga teachers, health enthusiasts and first-time participants, many wearing commemorative T-shirts bearing the theme of this year's observance, "Yoga for Healthy Ageing". Addressing the gathering, India's Ambassador to the United States, Vinay Mohan Kwatra, highlighted yoga's journey from an ancient Indian tradition to a globally embraced practice. "This morning at Lincoln Memorial, we are celebrating the 12th International Day of Yoga," Kwatra said. "The

International Day of Yoga was declared by United Nations in 2014 through a resolution, through a UN resolution, which was supported by about 175 countries all over the world," Kwatra told IANS. Describing yoga as part of India's civilisational heritage, the ambassador said the practice transcends borders, faiths and cultures. "It is a celebration of ancient Indian heritage yoga, which is universally adopted and widely practised across different geographies, different societies, different beliefs, different religions," he said.

India's Data Centre Pipeline Reaches 8.33 GW Driven By AI Adoption, Data Localisation

New Delhi, 20/6: India's data centre development pipeline has surged to 8.33 GW, more than five times the country's current live operational capacity of 1.6 GW, a report said on Saturday. The rapid growth of the data centre development pipeline is due to accelerating artificial intelligence adoption, cloud growth and data localisation requirements, the report from Knight Frank India said. India is emerging as one of the world's most attractive destinations for hyperscale digital infrastructure investments and currently has 0.32 GW of data centre capacity under construction, while another 2.92 GW has reached the committed stage, the report said. Additionally, 5.41 GW of capacity is in the early stages of development. The scale of the pipeline reflects growing confidence among hyperscalers, cloud providers, AI infrastructure



operators and institutional investors, who continue to expand their presence in India to cater to rapidly rising digital demand. The significant share of early-stage developments—representing nearly two-thirds of the total pipeline—demonstrates strong confidence in India's long-term digital economy

prospects. "While Mumbai continues to anchor hyperscale deployments owing to its connectivity advantages, Hyderabad is emerging as a preferred AI infrastructure destination," said Viral Desai, International Partner, Senior Executive Director- Occupier Strategy & Solutions, Industrial

& Logistics, Capital Markets & Retail, Knight Frank India. Mumbai accounted for the largest share of future capacity development with a total pipeline at 3.75 GW. Hyderabad became India's second-largest future data centre market with a total development pipeline of 1.93 GW. Chennai is strengthening its role as a strategic gateway for international data traffic from the east, Desai added. Vizag has rapidly emerged as one of India's most active greenfield data centre markets, attracting gigawatt-scale development proposals backed by government support, availability of sizeable land parcels and planned subsea cable connectivity. The National Capital Region (NCR), Pune and Bengaluru are also witnessing sustained development activity as operators diversify capacity across multiple markets.

India Launches Anti-Dumping Probe Against Chemical Exported By China, Japan

New Delhi, 20/6: India has launched an anti-dumping investigation against imports of a chemical, used in tyre and rubber products, from China and Japan which are allegedly being exported by these countries at prices that are below the fair market value of these goods, according to a notification issued by the Ministry of Commerce on Friday. The investigation follows a complaint lodged by Atul Limited to the Directorate General of Trade Remedies (DGTR) which alleged the flood of cheap imports of 'Resorcinol' are causing significant harm to India's domestic industry. The DGTR's notification said: "On the basis of the duly substantiated application filed by the applicant and having satisfied itself, on the basis of the prima facie evidence submitted by the applicant, regarding dumping of the subject goods... the authority hereby initiates an anti-dumping investigation." The investigation targets dumped shipments of Resorcinol, an intermediate compound used for bonding rubber to tyre cords and in specialised



resins. The World Trade Organisation rules provide for anti-dumping investigations by countries so that they can protect their indigenous industries from the flood of cheap imports by imposing a higher duty on them in order to check the unfair trade practice. The DGTR has previously investigated and monitored finished automotive tyre imports (such as new pneumatic radial tyres from China and Thailand) as well as raw tyre components like synthetic Halobutyl Rubber (HIR) imported from the US and China. The Directorate will examine the existence,

scale and impact of the alleged dumping by exporters from both countries. If the directorate confirms that the imported goods are being sold below fair market value and have caused "material injury" to Indian producers, it will recommend anti-dumping duties on these goods to ensure a level playing field for India's domestic industry. While the DGTR determines the extent of dumping, the Ministry of Finance holds the final authority to officially levy and enforce these duties to check the flood of cheap foreign goods.

Strong Economic Fundamentals Helped India Withstand West Asia Crisis: RBI MPC Minutes

Mumbai, 20/6: The minutes of the Reserve Bank of India's (RBI) Monetary Policy Committee (MPC) meeting, released on Friday, show that India has been able to withstand the disruptions of the West Asia crisis because of the strong fundamentals of the economy. MPC member Nagesh Kumar said: "The Indian economy entered the West Asia crisis with much stronger macroeconomic fundamentals than most previous economic crises (including the global financial crisis, the taper tantrum, or Covid-19). Before the conflict started at the end of February, the Indian economy was enjoying a 'Goldilocks moment' of robust growth and very benign inflation. Healthy foreign exchange reserves of nearly \$700 billion covering about 11 months of imports, and a moderate current account deficit, underpinned by resilient merchandise exports, and buoyant services exports and invisibles. Reservoir levels holding above 20 per cent higher water than the 10-year average could help to mitigate the possible shortfalls in the monsoon. In any case, over time, Indian agriculture has tended to be less affected by monsoon fluctuations with growing resilience." "Emphasis on fiscal consolidation over the past years



has helped in bringing down the fiscal deficit from 6.5 per cent of GDP in 2022-23 steadily to 4.4 per cent by 2025-26. This provides some fiscal space to address the challenges posed by the West Asia crisis, including through supporting economic growth by sustaining and even enhancing public investment to mitigate any weaknesses in private consumption due to rising costs and to absorb rising subsidies for absorbing the high crude prices," he added. The Central bank said the inflation outlook remains vulnerable to prolonged supply-chain disruptions arising from the conflict in West Asia and uncertainty over

the spatial and temporal distribution of the Southwest monsoon. According to the central bank's latest meeting minutes, headline consumer price index (CPI) inflation inched up to 3.4 per cent in March and 3.5 per cent in April, primarily due to higher food inflation. Fuel price inflation had remained subdued as the retail price hike had not yet percolated into the system. The RBI expects inflation to accelerate throughout the quarters, with CPI projections at 4.2 per cent for Q1, 5.2 per cent for Q2, 5.9 per cent for Q3, and then 5.4 per cent in the final quarter. MPC member Ram Singh stated: "RBI's analysis indicates a

Nifty, Sensex Post Nearly 1.7 PC Weekly Gain Over Hopes Of US-Iran Peace Pact

Mumbai, 20/6: The Indian equity benchmarks posted second consecutive week of strong gains, over investor optimism about improved geopolitical situation following the US-Iran peace agreement, and decline in Brent crude prices. Nifty added 1.65 per cent during the week and lost 0.64 per cent on the last trading day to reach 24,013. At close, Sensex was down 607 points or 0.78 per cent at 76,802. It added 1.69 per cent during the week.

Domestic markets witnessed consolidation on the last trading day of the week largely dragged by a sharp sell-off in IT stocks after recent three sessions of benchmark gains. Brent crude, which dipped below the \$80 per barrel level on hopes of a potential US-Iran peace agreement, saw a sudden halt in price decline after abrupt cancellations of peace talks and profit booking toward the close of the week. The rupee strengthened by roughly 79 paise during the week to around 94.35



per dollar. The improved geopolitical backdrop is expected to lend support to market sentiment next week, analysts said. A 14-point US-Iran MoU signed during the week included the reopening of the Strait of Hormuz, removal of the naval blockade and restoration of commercial shipping. On the sectoral front, consumer durables, real estate, pharma and defence were notable gainers. Defence sector rallied 6.6 per cent over the

past week, supported by strong underlying fundamentals, market participants said. IT emerged as the biggest laggard, with the Nifty IT index plunging 6.5 per cent after Accenture lowered its FY26 constant-currency revenue growth guidance and issued a weaker-than-expected outlook. On the monetary policy front, the US Fed maintained a cautious, data-dependent stance with limited forward guidance, reinforcing a higher-for-longer rate

disposition. With the RBI maintaining a cautious stance, declining crude prices and progress in trade deals with the UK and US could support a gradual improvement in the outlook, though clearer policy direction may take one or two more reviews, said analysts. Broad market indices outperformed gains of benchmark indices, as Nifty Midcap100 gained 2.62 per cent, while Nifty Smallcap100 surged 3.23 per cent during the week. Investors remain keen on India's monsoon rainfall, with cumulative June rainfall so far tracking 38 per cent below normal amid ongoing El Nino conditions. Any further delay in monsoon progression could heighten concerns over kharif sowing, food inflation and rural demand, market participants said. Incoming India PMI and credit growth data, alongside US PCE and GDP prints, are other key data for market direction in near term.

Northeast Can Lead India's Growth Story Through Organic Agriculture: Nirmala Sitharaman

Shillong, 20/6: Union Finance Minister Nirmala Sitharaman said on Friday that the Northeast has the potential to emerge as India's next growth powerhouse by leveraging its strengths in organic farming, sustainable agriculture and premium-quality produce, asserting that the region could lead the country's development journey in the years ahead. Addressing a gathering after inaugurating the Northeast's largest organic spice processing plant at Bhoirymbong in Meghalaya's Ri-Bhoi district, Sitharaman said the future of agriculture lies in quality, traceability and consumer trust rather than sheer volume of production. The newly inaugurated facility, established by the Eastern Ri-Bhoi Organic Farmer Producer Company Limited, is expected to significantly boost value addition, processing capacity and market access for farmers cultivating high-value crops such as Lakadong turmeric, ginger and black pepper. "The future belongs not to those who produce the most, but to those who produce the best—cleaner, more traceable, trusted and premium products," the Union finance Minister



added. Highlighting Meghalaya's growing prominence in the organic agriculture sector, Sitharaman said the state enjoys a unique advantage as global consumers increasingly seek environmentally sustainable and ethically produced food products. She noted that trust has become a critical factor in international markets and said Meghalaya's traditional farming practices, community-driven agriculture and ecological heritage position it favourably in the emerging global economy. "The world is entering an age where trust commands a premium, and Meghalaya possesses that trust rooted in nature and generations of ecological wisdom," she said. Emphasising the need for environmentally responsible

growth, Sitharaman added that economic development and conservation must go hand in hand. "We have to live and cohabit with nature," she remarked. Referring to India's vision of becoming a developed nation by 2047, the Union Minister said the goal of a "Viksit Bharat" can only be achieved through the participation of every region, with the Northeast playing a pivotal role. She also stressed the importance of empowering farmers, particularly women, through value addition, stronger producer cooperatives and access to global markets, enabling them to build internationally recognised brands around the region's organic products.

New Delhi, 20/6: Virat Kohli is set to undergo a fitness assessment at the BCCI's Centre of Excellence ahead of the Ajit Agarkar-led selection committee convening to select India's squad for the upcoming ODI series in England, to be played from July 14-19 in Birmingham, Cardiff and Lord's. It is understood that the selectors will meet in the coming week to decide the squad. Chief selector Agarkar was seen in Sri Lanka keeping an eye on India 'A' team playing the 50-over tri-series. Kohli missed the ongoing ODI series against Afghanistan due to a hamstring injury sustained in the IPL 2026 final in Ahmedabad, where he hit a match-winning 75 not out for Royal Challengers Bengaluru. Since then, Kohli has been doing rehab while being in London. "It has emerged that Kohli is expected to report to the BCCI CoE for his fitness assessment and clearance very soon. It can happen anytime after his One8 brand does its first-ever Global Premiere event in Yashobhoomi, New Delhi, on Sunday. If all goes well, then Kohli can be included for ODIs against England," said a source



tracking the development to IANS on Saturday. Seam-bowling all-rounder Hardik Pandya, meanwhile, has resumed light training at the CoE facility in Bengaluru as he works his way back to full fitness after a late leg niggle kept him out of ODIs against Afghanistan. Pandya was at the CoE since June 2 to get

fitness clearance after a back niggle saw him miss a couple of games for Mumbai Indians in IPL 2026. It is understood that Pandya has resumed light training at the CoE 4-5 days back, after taking a week's break. "The intensity of his training will increase slowly in the next two days. His medical report will be submitted to the BCCI through

the CoE medical team and on that basis, the selectors will probably take a call on his availability for ODIs in England. "Basically, it's upto the selectors and team management to decide - like will they wait for him to be fully match fit or not take him to England so that he builds up full fitness needed to play an ODI game," added the source.

3rd ODI: Prasidh, Harsh, Nitish Return For India As Afghanistan Elect To Bat First

Chennai: India have included Prasidh Krishna, Harsh Dubey and Nitish Kumar Reddy in their playing eleven as Afghanistan won the toss and elected to bat first in the third and final ODI at the MA Chidambaram Stadium on Saturday. India have already taken a 2-0 lead in the three-game series after a massive 170-run win in Lucknow. Another win in Chennai will hand them a 3-0 series sweep. Afghanistan captain Hashmatullah Shahidi said they have four changes, with Mohammad Nabi, Azmatullah Omarzai, Zia Ur Rahman Sharifi and Faeed Ahmad Malik coming



in. "We want to bat first today. It's always hot in India in this month. Wicket also looks good.

It's dry and hard. Hopefully we have a good start in the batting. In last two games we missed some

areas and didn't play the way we have played in the past. Hopefully we recover today and have good partnerships and bowl in the right areas," he said. For India, with Prasidh, Harsh and Nitish returning, Arshdeep Singh, Kuldeep Yadav and KL Rahul sit out of the match. Nitish had missed the clash in Lucknow due to soreness in left thigh and now returns in Chennai, with Ishan Kishan set to take up keeping duties. "Looks like a very good wicket. Would've batted first as well. Was pretty hot in the last match and it's going to be no different here.

Grammy Adds New Categories To Its Awards Line-Up



Los Angeles: The Grammy Awards have added 5 new categories after deliberation with its members. The organising committee updates rules and adds to their categories in response to proposals from the members every year. The next show, taking place on February 7, 2027, will see 5 new categories, including in the Latin, Asian Pop and R&B genres, and several key updates, including the Best New Artist and Best album categories, reports 'Variety'. The latter two moves are the most far-reaching, as they see the maximum number of times an artist may be submitted increased from three to four; and the "threshold of new recordings required on an eligible album is lowered from 75% to

66% to reduce the exclusion of entries that are widely recognized throughout the music industry as new albums". As per 'Variety', Best new artist is traditionally the most controversial award, inevitably, as the concept of who considers the artist to be new is always a judgement call, and this year will see multiple artists getting an unexpected fourth shot at being nominated, including Ella Langley, who was reportedly submitted in three past years, but whose Hot 100 No. 1 single "Choosin' Texas" and the album "Dandelion" have led her star to rise dramatically. Likewise, as the concept of what constitutes a new album has changed, some that featured, say, four new songs but included

remixes or live versions of previously released songs inspired the 75% threshold, but apparently that was determined to be excessively high. In a related move that extends recognition for songwriters, contributors to winning albums in most genre album categories will now receive Grammy statuettes and Achievement Certificates, which producers and engineers already receive. Songwriters and Composers of new material on the winning albums in most genre album Categories will now receive Grammy statuettes and Achievement Certificates in parity with the recognition currently afforded to Producers and Engineers in those categories.
