Supreme Court stays Delhi High Court order on release of 1993 Kolkata Bowbazar blast case

New Delhi: The Supreme Court today stayed the Delhi High Court order directing the premature release of a life-term convict in the 1993 Kolkata Bowbazar blast case. A bench comprising Justices PK Mishra and Sanjeev Sachdeva gave the interim relief on a plea filed by the West Bengal government, challenging the 5th June order of the high court directing the immediate release of the 77-year-old convict Md. Rashid Khan.

The top court also issued notice to Khan, who was convicted under stringent provisions of TADA, on the plea of the state government.

Appearing for the state government, additional solicitor general SV Raju said the high court made a mistake in its

finding and questioned relying on reformatory theory for granting relief to Khan in a case where more than 70 people died and hundreds got injured in the bomb blasts.

Senior advocate MR Shamshad, appearing for Khan, submitted that he had spent over 33 years in prison and highlighted that a co-accused, Pannalal Jaiswara, was granted remission in March 2014.

The bench, however, said the roles attributed to them were completely different while pointing out that Khan was the "mastermind" of the incident.

The reformatory theory of punishment, also known as the rehabilitative approach, views crime as a social or psychological pathology rather than a simple moral failing.

Narayanan was awarded the Padma Vibhushan in the category of Literature and Education and former judge KT Tomas was given the Padma Vibhushan in social work. Former tennis player Vijay Amritraj, actor Mammooty, and playback singer Alka Yagnik received the Padma Bhushan award.

Delhi extends slum rehabilitation eligibility cut-off to Jan 1, 2025; 20 lakh to benefit

New Delhi: The Delhi government on Tuesday approved rehabilitation benefits for all eligible families living in settlements established till January 1, 2025, in a decision expected to benefit nearly 20 lakh people and facilitate permanent housing for an estimated 4-5 lakh families.

The decision was taken at the 36th board meeting of the Delhi Urban Shelter Improvement Board (DUSIB), chaired by Chief Minister Rekha Gupta at the Delhi Secretariat, according to a statement released here. Urban Development Minister Ashish Sood, Chief Secretary Rajiv Verma and senior officials attended the meeting.

The move removes a key hurdle that had prevented many families from qualifying for rehabilitation benefits under earlier eligibility norms and expands the scope of the recently approved Delhi Slum and JJ Cluster Rehabilitation and Relocation Policy, 2026, the statement said.

MEA confirms ten Indian-flagged vessels remain in Persian Gulf region

New Delhi: The Ministry of External Affairs today informed that ten Indian flagged vessels are still in the Persian Gulf region. Addressing media in New Delhi this afternoon, Ministry spokesperson Randhir Jaiswal said that since the signing of MoU between the US and Iran on the 17th of June, eleven India bound vessels have transited through the Strait of Hormuz. The vessels include 3 Indian-flagged Crude Oil Tankers, each carrying over 2 lakh 85 thousand MT crude oil, one foreign flagged LPG carrier, one foreign flagged Crude Oil Tanker and six foreign-flagged Bulk Carriers, carrying fertilizer cargo. He hoped that the remaining India flagged vessels would also be able to cross the Strait of Hormuz soon.

On Qatar's explosion, Mr Jaiswal said that 12 Indian citizens were killed in the explosion. He said that a total of 66 people were injured in the incident and are currently receiving medical treatment. Mr Jaiswal said, India is coordinating closely with the government of Qatar to expedite procedures

related to the repatriation of the mortal remains of the deceased.

Responding to the comments made by Pakistani Defence Minister Khawaja Asif on the situation in Pakistan-occupied Kashmir, the spokesperson said such remarks are desperate attempts by the neighbouring country to cover-up its own failings and deflect attention away from its human rights abuses. He said New Delhi categorically rejects these fabricated claims with the contempt they deserve. He stressed that the ongoing protests in PoK are a direct consequence of Pakistan's decades-long policy of systemic economic exploitation, denial of fundamental rights, and administrative oppression in areas under its illegal and forcible occupation. He pointed out that the Pakistani state has responded with extreme police brutality, blocking of essential supplies and medicines, internet blackouts, and use of lethal force against unarmed civilians. He expressed hope that the international community will hold Pakistan

accountable for its misdeeds and abuses.

On BRICS National Security Advisor's meeting, Mr Jaiswal informed that NSA Ajit Doval held bilateral meetings yesterday with his counterparts from Iran, Ethiopia, China, Brasil, and South Africa. He said, during the meeting the discussions were focused on enhancing cooperation among member countries in addressing non traditional security challenges and strengthening collective response to emerging global threats.

On India-UAE defence partnership, the spokesperson said India's relationship with UAE in recent several years has seen a major upswing, in which the defence partnership also plays an important role.

Responding to another query, Mr Jaiswal said there are reports from Bangladesh regarding acts of desecration involving deities and their images, which have sparked protests. He said India expects the Bangladeshi government to curb the extremists there and guarantee the safety of the minority community.

Delhi CM approves rehabilitation benefits for slum residents, sets Jan 2025 cut-off

New Delhi: Residents of any slum settlement in Delhi established by January 1, 2025, will be granted rehabilitation benefits, said the Chief Minister's Office on Tuesday.

The decision was taken at the 36th board meeting of the Delhi Urban Shelter Improvement Board (DUSIB), chaired by Chief Minister Rekha Gupta.

Earlier on June 16, Union Home Minister and Minister of Cooperation Amit Shah chaired a review meeting on the rehabilitation of slums in New Delhi.

The meeting was attended by Union Minister of Housing and Urban Affairs Manohar Lal, Lieutenant Governor of Delhi Taranjit Singh Sandhu, Chief Minister of Delhi Rekha Gupta, Delhi's Urban Development Minister, Union Home Secretary, Delhi Chief Secretary, and other senior officials from the Central and Delhi governments.

In the meeting, Union Home Minister Amit Shah said that the Delhi Slum and JJ Cluster Rehabilitation and Relocation Policy, 2026, had been finalised and that the Government of Delhi should notify it at the earliest. He directed that the Delhi Development Authority (DDA) and the Delhi Urban Shelter Improvement Board (DUSIB) should issue tenders for five clusters within 45 days.

He further instructed that project documents and tender forms should also be prepared for an additional 50 JJ clusters.

Amit Shah said that the Delhi Government should issue tenders for at least five PPP-based rehabilitation projects every month.

The Home Minister said that in the construction of rehabilitation colonies, adequate provision should be made for community facilities such as Anganwadi centres, educational facilities, health centres, and playgrounds. He added that the decisions taken in the meeting would benefit around four lakh families living in Delhi's JJ clusters. He also stated that the eligibility cut-off date for JJ clusters should be fixed as 01.01.2025.

Delhi-NCR hit by dust storm, showers bring respite from scorching heat

New Delhi: An intense dust storm swept through several parts of Delhi-NCR on Tuesday afternoon, bringing a sudden change in weather conditions across the region, followed by spells of rain and thunderstorms.

The dust storm was witnessed in parts of Chhatrapur, RK Puram, Kartavya Path, RML hospital, Gurdwara Bangla Sahib, Maulana Azad Road, Barakhamba Road, and around India Gate in Delhi, while adjoining areas of Noida Sector 49 in Uttar Pradesh also experienced similar conditions.

The weather disturbance affected multiple areas across the national capital, including parts of Delhi and adjoining regions of Noida, leading to a temporary disruption in normal conditions.

Flight operations at Indira Gandhi International Airport were also impacted due to the inclement weather.

The airport authorities said, "Due to inclement weather conditions in Delhi, flight operations are impacted at Delhi Airport. Our on-ground teams are diligently working with all stakeholders to ensure a seamless and efficient passenger experience. Passengers are advised to consider alternative modes of transport, including the Delhi Metro,



to reach the airport and avoid potential delays. For the latest flight information, passengers are advised to contact their respective airlines."

According to the India Meteorological Department (IMD), the humidity levels stood at around 73 per cent, while temperatures were recorded at a maximum of 40 degrees Celsius and a minimum of 27 degrees Celsius in the national capital.

Meanwhile, in West Bengal, Kolkata city received heavy rainfall as parts of the metropolis were lashed by intense showers. The heavy showers were witnessed in and around Mayo Road in the city.

Furthermore, the Brihanmumbai Municipal Corporation (BMC) issued an update on rainfall activity recorded in the city between 0800 hrs and 1500 hrs.

According to the civic body, the average rainfall in the city stood at 26 mm, while the eastern suburbs recorded 4 mm and the western

suburbs 13 mm during the said period.

In the hour between 1400 hrs and 1500 hrs, rainfall was recorded at several locations across the city. Siwree Koliwada Municipal School recorded 17 mm, B Nadkarni Municipal School in Wadala recorded 16 mm, while the F/N ward and SWD Workshop recorded 10 mm of rainfall.

The civic body said that light rain was witnessed in both the eastern and western suburbs during the period.

It further stated that subways remained normal and railway traffic was also reported to be operating without disruption despite the rainfall activity.

The rain brought much-needed relief to the public amid intensified heatwave conditions prevailing in several states, offering respite from the soaring temperatures and humid weather that had gripped the region in recent days.

NHAI signs MoU with National Council of Applied Economic Research

New Delhi: National Highways Authority of India (NHAI) has signed a Memorandum of Understanding (MoU) with the National Council of Applied Economic Research (NCAER) to establish the NHAI Centre for Economics of Transportation, Mobility and Logistics at NCAER.

The Ministry of Road Transport and Highways said that the centre will serve as a dedicated platform for undertaking applied economic research on transportation, mobility and logistics. The focus of the centre will be on generating actionable insights to support long-term planning, investment and policy formulation in the road and transport sector. The Ministry said that beyond research, the Centre will serve as a knowledge hub for the transportation sector by disseminating findings through policy briefs, working papers and flagship reports.

The Centre will be anchored by an Advisory Committee comprising leading economists, transportation specialists, public policy experts and eminent academicians, along with NHAI's Member (Finance) and the Director General of NCAER.

Telegram operational for some existing users, remains delisted on app stores

New Delhi: Instant messaging app Telegram became operational for some existing users on Tuesday morning but remained delisted on application stores of Google and Apple. The government had temporarily imposed a blanket ban on Telegram until June 22 and sources indicated that there is no change or extension of timelines in the order. Email queries to Google and Apple did not elicit an immediate response in this regard.

Rain and thunderstorms bring relief from heat in Delhi, IMD forecasts more showers

New Delhi: Rain lashed through several parts of the national capital on Tuesday afternoon, leading to significant temperature drops across the city, with the weather department forecasting thunderstorm and rain to continue through the evening hours.

Amidst a red alert issued by the India Meteorological department (IMD) for most parts of the city, strong winds and dust storms swept through the city, bringing respite from the rising heat. According to the latest data from IMD, Safdarjung, representative of the city's weather, recorded a wind speed of 52 kmph at 2.30 pm.

Forest department issues notice to OMC on illegal felling of trees.

Narsh Chandra Pattanayak Keonjhar : The Forest Department has taken action regarding illegal tree cutting for road work at Kadabandh Sahi near Uparjagar village under the Bhuyana Juanga Pirha range in Keonjhar.

"Notice has been issued to the Regional Manager of Odisha Mining Corporation in Suakati, for felling of trees without taking permission. "Action will be taken according to the laws after receiving a reply," said Nayan Kanta Sahu, Range officer, Bhuyana Juanga Pirha Range. Locals demanded the seizure of machines used for cutting trees and forest resources and the arrest of the guilty persons.

Sources said that a road is being constructed in Kadabandh Sahi with the Corporate Social Responsibility (CSR) funds



of the Odisha Mining Corporation. The contractor allegedly cut the trees and bushes without permission from the Forest Department and buried them using a JCB machine.

After the allegations, the Forest Department acted promptly. On Monday, a team led by

Forester Suakati Jyotirmayi Patnaik rushed to the spot, inspected the site, questioned the locals, counted the roots of the cut trees and submitted a report to the range officer. Based on the investigation report, the range officer today served a notice to the RM, OMC and asked him to stop the work. According to

sources, the road is being constructed as part of the corporate social responsibility program of the Odisha Mining Corporation at the cost of about 1 crore. Since this work was done without engineers of OMC present, questions have been raised about how the contractor failed to obtain

permission from the Forest Department. In this regard, OMC Regional Manager Pankaj Mahanta said that there were actually no trees there. We did not cut any trees either. We will take action if we receive the notice".

Mining activities at the Gandhamardan Iron Ore mines owned by OMC are causing severe degradation and pollution to the forest and environment. It is worth noting here that while the Odisha Mining Corporation spends crores of rupees every year on CSR funds for environmental protection, it is simultaneously damaging the environment. Locals urged the OMC Managing Director Sudhansu Mohan Samal to take action to be taken in this direction through investigation.

Corruption allegations of more than two crores : Wildlife DFO Office under suspicion

NUAPADA/KHARIAR ROAD, June 23 : The allegations of corruption worth over two crore rupees at the Wildlife Sunabeda DFO Office Nuapada have now become a topic of discussion. A major government financial scandal has come to light in this office.

According to information, a complaint has been filed against a clerk Bablu Suna, who is working in the said office, for embezzling government funds. As per the information, this corruption is said to have taken place in the last financial years 2023-24 and 24-25.

Preliminary investigation revealed that the then DDO of the said office had entrusted all the responsibilities to Bablu Suna.

The said clerk is said to have withdrawn Rs 2.87 crores from the government treasury through about 36 fake bills in the name of 6



employees.

There is no document in the office for all 36 bills nor is there any file in which the said withdrawal of money has been approved. Bills have only been sent to the Treasury online. While the officer's name and account number are correct in the bill sent from the office to the Treasury, the officer's name is still there in the bill sent from the Treasury to the bank, but the account

number has been changed. Similarly, while the bills sent from the office have the digital signature of the concerned DDO, the bills sent from the treasury to the bank do not have the signature.

When contacted to DFO Wildlife Sameer Kumar Sahu said, after this incident came to light we have suspended the said clerk and we have informed to higher authorities about the incident and requested them to conduct a special audit.

Now, the clerk is not coming to the office.

In this transaction, not only the DFO office but also the district treasury is under investigation. Because How did one bill come out of the office and another bill from the treasury.

There is growing speculation that further information will come to light if a proper investigation is conducted. Investigation is underway process in this connection.

Bomb Attack on Paradip Municipal Chairperson's House Shrouded in Mystery



Paradip (DMS):- Four weeks have passed since the bomb attack on the residence of Paradip Municipality Chairperson Basant Biswal on May 30, but the main conspirators and accused persons are yet to be arrested, raising serious questions about the efficiency of the police administration.

The failure of the police to crack the case involving an attack on the residence of Paradip's first citizen has created suspicion and surprise among the public. The prolonged delay in identifying and apprehending those responsible has led to growing concern among local residents and political circles.

A few days ago, representatives and leaders of

various political parties jointly met Paradip Additional Superintendent of Police Ajinkya Baburao Mane and demanded a thorough investigation into the incident. Ajodhya Misappropriation

Disturbing allegations of misappropriation of donations, including cash and valuables, at the Ram Mandir in Ayodhya are being probed by a Special Investigation Team (SIT) set up by the Uttar Pradesh government. At stake is not only the integrity of a prestigious religious institution, the Shri Ram Janmabhoomi Teerth Kshetra Trust, but also the faith of crores of devotees who have contributed generously to the landmark temple. It is alleged that cash



donations amounting to several crore rupees were siphoned off and precious ornaments replaced with fake items. The reported disappearance of 60 kg of silver bars donated during the consecration ceremony has further raised doubts about the mechanism for safeguarding offerings.

As expected, the controversy has triggered a political storm months before the 2027 UP Assembly elections. Opposition leaders have accused the ruling establishment of shielding wrongdoers, while the BJP has dismissed the accusations as attempts to defame Ayodhya and hurt religious sentiments. Chief Minister Yogi Adityanath has appealed for patience, saying that devotees who waited 500 years for the temple need to wait another 15 days for the SIT to complete its investigation. Indeed, a transparent and time-bound inquiry is a must to get to the bottom of the sordid matter.

The demand for the public disclosure of records and an independent audit cannot be brushed aside. In matters involving public donations and religious devotion, accountability must not be compromised. The row also exposes a malaise afflicting major religious institutions across India. Temples that receive enormous donations require modern systems of auditing, inventory management, digital tracking and autonomous oversight. The Ram Mandir represents the collective aspirations of India's majority community. Precisely because of its immense symbolic importance, every allegation must be investigated impartially and every doubt addressed transparently. Protecting the sanctity of the temple ultimately means preserving the trust of the faithful themselves.

Pharma Ban

THE government's decision to ban 16 fixed-dose combination (FDC) drugs is in line with its efforts to clean up India's pharmaceutical ecosystem. The move reflects a simple but often neglected principle in medicine: more is not always better. Fixed-dose combinations — drugs that mix two or more active ingredients in a single pill or formulation — are widely



used across the country. However, many of them have proliferated without adequate scientific validation, driven more by market incentives than medical necessity. The government's conclusion that the banned FDCs "lack therapeutic justification" lays bare a stark reality: not all easily available medicines are necessarily rational or safe.

The strict measure follows Supreme Court-directed reviews and expert committee assessments under the Drugs Technical Advisory Board. India has previously banned hundreds of irrational FDCs, yet their continued circulation — often when enforcement is fragmented — has exposed persistent gaps between regulation and implementation. The inclusion of antibiotic-based combinations on the ban list is particularly important. In the era of rising antimicrobial resistance, irrational antibiotic use is not just a regulatory concern but also a public health threat with global consequences. Similarly, banning dermatological and analgesic combinations that lack evidence-based justification signals a shift towards evidence-based prescribing norms. Whether this approach percolates down to prescribing doctors and pharmacies is the real test.

The tightening of rules on cough syrups and over-the-counter liquid medicines further indicates a wider regulatory recalibration. Together, these measures are aimed at reducing unsupervised access and enforcing prescription discipline. If the ban is implemented rigorously, it can strengthen rational drug use in India. If not, it would be added to the list of well-intentioned but unevenly enforced pharma reforms.

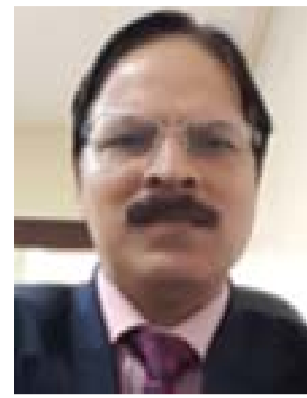
The Art and Economics of Bargaining

W e feel happy if we can reduce the price even by a small amount by bargaining with the shopkeeper. But most people feel comfortable if the shop displays a Fixed Price board as they feel that they have not been cheated. But some people prefer to go to the market where bargaining is practiced as they feel that they have mastered the art of bargaining. Bargaining is very common in market places in Africa, Asia and Middle East. Fixed price is followed in most of the markets in Europe, North America and Japan. Fixed price is the price either fixed by the seller or the authorities and there is no scope for bargaining to reduce the price. Today the biggest bargaining platform in the world is the middle east where US is engaged in a bargaining process with Iran for several weeks with the mediation of Pakistan to settle the terms for ending the war.

Bargaining is not a bad thing nor it is uncommon. In financial markets quite a number of transactions are done over bargaining. In forex transactions involving millions of dollars and rupees there is a bargaining process between the buyer and seller. In international bond markets there is a bargaining process between the buyer and the seller and many a times the buyer and the seller ask each other over the trading screen to improve the price and finally a deal is done. Even in placement of fixed deposits with foreign banks a bargaining process takes place on the interest rate at which the deposit will be placed. The much talked about tariff negotiations of countries with USA was a huge negotiation process which went on for days involving trade in several commodities and the rate of tariff by both

the negotiating sides.

One of the important factors in the bargaining process is the bargaining power. The bargaining power is a party's relative ability to influence the opposite side during negotiations, allowing them to secure more favorable terms or leverage. It dictates who holds the upper hand and is primarily driven by available alternatives, information advantages, market dominance, and resource strength. Bargaining power can be dynamic and depends on information flow and the

alternatives available to the bargaining sides as the side with more and better alternatives will have an upper hand in the bargaining process. In business and in market place, it is influenced by supply, demand, USP, the price of the product and the urgency for delivery of the product. One of the common theories to determine the bargaining power of the parties is known as BATNA (Best Alternative to a Negotiated Agreement) which says that the party who has a better alternative to the terms of negotiations will have more bargaining power in the negotiating table. The bargaining process may have a duration of a few seconds like

Fixed pricing has several advantages as it helps the seller and buyer to know the cash flow in advance, prepare budgets and it is less complex to understand. It is easier to market, predict customer demand and it enhances customer comfort and creates customer loyalty. In contrast, the dynamic pricing creates

a sense of uncertainty but helps in beating competition by adjusting price upwards or downwards depending on demand and supply. Banks also sell credit products on fixed price or floating price basis. In financial markets, it is regular feature to swap fixed price products in to floating price products depending on the need of the parties to hedge their cash flows.

A fixed price may not be beneficial or fair always. It depends on whether the seller is a monopoly or in a competition. In a monopoly situation, the seller may reduce the quantum of production and increase the price to get exorbitant profit while in a competitive situation, since there are many sellers one seller can not determine the price. But in some competitive markets the sellers form a cartel and fix the base price below which none of the cartel members will sell. They may also agree together to raise the price or fix the maximum discount to be offered on some products and thus influence the price. In 2018 the major bread makers in Canada decided together to raise the price of bread by a fixed amount over a fixed period.

The negotiation process during a war or in a post war period can drag on for weeks or months. The Iran-USA war negotiation is going on for months and several rounds of discussions are taking place through a mediator to arrive at mutually agreed points for a permanent ceasefire. In a political or war negotiation, the negotiating sides, while keeping in view their military striking power and advantage have to take care of the aspirations of the domestic constituency which does not like to see the government surrendering or giving a long leeway to a foreign power. Bargaining is a part of life whether in purchasing a commodity or negotiating for a ceasefire between nations.

Lucknow Fire Tragedy: SIT Team Begins Probe, Visits Spot Where Deadly Blaze Killed 18

New Delhi, 23/6: The two-member Special Investigation Team (SIT) set up to investigate the devastating fire at a commercial building in Lucknow's Aliganj area, reached the spot on Tuesday and began its investigation into the incident that claimed the lives of 18 young people. The SIT, formed on the instructions of Uttar Pradesh Chief Minister Yogi Adityanath, comprises Additional Chief Secretary Amrit Abhijit and Additional Director General of Police (ADG), Lucknow Zone Praveen Kumar. Both the senior officials, accompanied by several policemen scanned the badly charred building and searched for gaps and violations that turned the building into a 'death trap' for students. Hours before the SIT team, a group of forensic experts also arrived at the mishap site to inspect and examine the building's premises for possible forensic evidence. The FSL team carried

out detailed inspection of the site for getting insights into the cause of the deadly blaze, ascertaining the possible reasons at the three-storey building in Lucknow's Aliganj area. The inferno claimed at least 18 lives, and left many others grievously injured. The fire, that broke out on Monday at around 3 P.M., ripped through the residential building, illegally modified as a commercial centre, in North Lucknow. The building housed an animation centre and saw many students trapped on the second floor of the complex. As the fire engulfed the building, this prevented them from escaping the deadly inferno. Two youths, who tried to jump out of the building suffered serious injuries and are currently receiving treatment at a trauma centre. According to preliminary reports, the fire broke out in the building AC's duct and the billowing smoke led to suffocation of many as there was no exit route in the building.

From Rajagopal To Kurian, BJP's Kerala Formula Faces Another Test

New Delhi/Kochi, 23/6: With Union Minister George Kurian resigning after the BJP decided not to renew his Rajya Sabha term, attention has shifted to whether Kerala will get a new representative in the PM Narendra Modi-led Union Council of Ministers. Kurian submitted his resignation on Tuesday after completing his term in the Upper House, and President Droupadi Murmu accepted it. Sources said Kurian is likely to return to organisational responsibilities, with the BJP leader having expressed his interest in working in Kerala.

However, the party is yet to clarify whether he will be given a role at the national level or in the state. Kurian, a long-time BJP leader who joined the party when it was formed in 1980, was inducted into the third Narendra Modi government in June 2024 as Minister of State for Fisheries, Animal Husbandry and Dairying,

and Minority Affairs. His entry into the Cabinet had surprised many as he was not then a member of either House of Parliament. In August 2024, Kurian was nominated to the Rajya Sabha from Madhya Pradesh after the seat fell vacant following the resignation of Union Minister Jyotiraditya Scindia, who moved to the Lok Sabha after winning the general election. With the BJP not extending his Rajya Sabha term, Kurian becomes the fourth BJP leader from Kerala to exit the Union Cabinet without securing a second stint. The BJP has in the past followed a similar route of bringing Kerala leaders into the Rajya Sabha and inducting them into the Union Cabinet. Former Union Ministers O. Rajagopal, K. J. Alphons, and V. Muraleedharan had entered Parliament through the Upper House before holding ministerial positions. Kurian, a lawyer who had practised in the Supreme

Court, had served in several organisational roles, including BJP state Vice President, National Executive member, Core Committee member, and party spokesperson. He had also worked as an Officer on Special Duty when Rajagopal was a Union Minister. His electoral journey in Kerala, however, remained challenging. He had contested Assembly elections several times, including from Kanjirappally in the recent state polls, but could not secure a victory. At present, the lone BJP representative from Kerala in the Union Cabinet is actor-turned-politician Suresh Gopi, who scripted a historic victory from the Thrissur Lok Sabha constituency. Now, all eyes are on whether BJP's Rajya Sabha nominee from Kerala, C. Sadanandan Master, will be considered for a ministerial berth, or whether Kerala's representation in the Modi Cabinet will remain limited to one.

CUET UG 2026 Results Announced For Over 11.6 Lakh Students

New Delhi: The National Testing Agency (NTA) on Tuesday declared the results of the Common University Entrance Test (CUET-UG) 2026, bringing relief to lakhs of students awaiting admission to undergraduate programmes across the country. Candidates who appeared for the examination can now access their scorecards through the official CUET portal. NTA took to social media 'X' and said, "The wait is over. CUET (UG) 2026 results are now available. Students can access their scorecard by logging in through the official CUET website using their credentials."

According to official data, a total of 15,68,867 candidates registered for the examination, while 11,64,098 students ultimately appeared. The examination witnessed significant participation from across the country, with candidates having the option of choosing up to five subjects. This resulted in nearly 67.56 lakh test attempts and 12,906 unique combinations of



subjects. Among those who appeared for the examination, approximately 5.78 lakh were male candidates, 5.85 lakh were female candidates, while two candidates identified as transgender. Following the declaration of the CUET UG 2026 results, NTA advised candidates to download their scorecards from the official website. To access the results, students need to visit the CUET portal and click on the result link available on the homepage.

Candidates must then log in using their application number and date of birth or password. Once logged in, they can view their scorecard, check their subject-wise scores and percentile, and download a copy for future admission-related processes. Students are advised to carefully verify all information mentioned on the scorecard, including their name, roll number, subject-wise scores, percentile, and other personal and examination-related details. Any

discrepancy should be reported to the authorities concerned without delay for necessary correction. On Monday, the NTA published the final answer key after reviewing objections raised by candidates against the provisional version. During the review process, the agency identified technical issues in seven questions and subsequently removed them from the final answer key. These revisions have been incorporated into the final evaluation process. The CUET UG 2026 examination was conducted between May 11 and May 31, with a few papers held on June 6 and June 7. Following the completion of the examination, the NTA released a provisional answer key, invited objections from candidates, and then finalised the answers before announcing the results. Last year, the CUET Undergraduate results were declared on July 4, for the exams held from May 13 to June 4. In the previous examination cycle, the final answer key PDF was released on July 1.

Zubeen Garg Death Case: SC Asks Assam Govt To Reply To Shyamkanu Mahanta's Bail Plea

New Delhi, 23/6: The Supreme Court on Tuesday issued notice to the Assam government on a bail plea filed by Shyamkanu Mahanta, one of the accused in the high-profile case relating to the death of singer Zubeen Garg in Singapore last year. A Bench of Justices B.V. Nagarathna and Joyimalya Bagchi passed the order while hearing a special leave petition (SLP) filed by Mahanta challenging the Gauhati High Court's refusal to grant him bail in the case. The apex court sought a response from the Assam government, and according to the computerised case status available on the official website, the matter is likely to be listed on August 10. Last month, the Gauhati High Court rejected Mahanta's bail plea, observing that the allegations against him were serious and that the investigation had collected material indicating his active involvement in the alleged conspiracy. Rejecting the bail application, a single judge Bench of Justice Mitali Thakuria said that despite being aware of the health condition of the deceased singer, there were allegedly no proper safety arrangements or



medical facilities provided for him. "Prima facie it is seen that there was a conspiracy of the petitioner along with other co-accused persons," the Gauhati High Court had observed, adding that the materials collected during the investigation indicated that the yacht party was organised with Mahanta's consultation and that he had played "an active part in the said conspiracy". The order further recorded that the prosecution case suggested that

the singer was allegedly supplied alcohol throughout the night and taken for the yacht trip without medical assistance despite restrictions on alcohol consumption and exposure to water-related activities because of his medical condition. It also expressed concern over the possibility of Mahanta absconding if released on bail, stating that he had travelled to Malaysia after the incident and was later arrested at the Delhi

airport after lookout notices were issued. "It cannot be out-rightly rejected that there is a flight risk of the petitioner, if he is released on bail," the Gauhati High Court said. Referring to the large number of witnesses cited by the prosecution, Justice Thakuria also observed that the possibility of witness tampering could not be ruled out at the present stage. The Gauhati High Court held that the period of detention could not be treated as prolonged

incarceration and that a designated special court had already been constituted to conduct the trial on a day-to-day basis. Mahanta, known as the organiser of the popular Northeast festival, has been lodged in jail for the past several months after being named as one of the accused in the case linked to the death investigation concerning Zubeen Garg. The case pertains to the death of Zubeen Garg, who died on September 19 last year while swimming near Lazarus Island in Singapore, a day before he was scheduled to perform at an event organised under the Northeast International Festival (NEIF) banner. Following the incident, a Special Investigation Team (SIT) constituted by the Assam Police's CID conducted an extensive probe and filed a chargesheet in December. The chargesheet named seven accused people, including Mahanta. Four of them have been booked on charges of murder. Earlier, Assam Chief Minister Himanta Biswa Sarma had described the case as a "plain and simple murder" during a discussion in the state Assembly.

India-UK FTA To Benefit Farmers, Fishermen, MSMEs: Piyush Goyal

New Delhi, 23/6: Commerce and Industry Minister Piyush Goyal said on Tuesday that the India-UK Comprehensive Economic and Trade Agreement (CETA) is a truly people-centric pact that will benefit Indian farmers, businesses, artisans, and people across the country. "By unlocking the premium UK market, it creates attractive global opportunities for women entrepreneurs, youth, startups and MSMEs, while empowering the underprivileged without compromising India's core interests," the minister said in a post on X. He further stated that the landmark agreement will help Indian farmers, fishermen, artisans and small businesses prosper globally and accelerate job creation, while enabling the common man to access high-quality goods at competitive prices. The transformational win-win agreement, which comes into force on July 15, will ensure comprehensive market access for Indian goods in the UK across sectors, particularly labour-intensive ones. It will immediately eliminate tariffs on about 99 per cent of tariff lines, covering almost 100 per cent of trade value, creating enormous opportunities for Indian exports,

Goyal said in a detailed article. The CETA was signed last year in the presence of PM Narendra Modi and British Prime Minister Keir Starmer. It delivers benefits across society. Farmers gain access to premium export markets without compromising their domestic interests. Fishermen benefit from enhanced seafood exports to the vast UK market. Workers gain new employment opportunities in labour-intensive sectors. Women entrepreneurs, youth, startups and MSMEs receive improved access to global value chains. Professionals benefit from enhanced mobility and recognition opportunities, the minister observed. He further stated that the agreement unlocks benefits in the UK market for Indian farmers that match or exceed the benefits enjoyed by other European nations. Turmeric, pepper, cardamom and processed goods such as mango pulp, pickles, and pulses will receive duty-free access. Higher agricultural exports will boost farm incomes and create greater incentives for quality, packaging and certification. It will also generate numerous jobs across the agricultural value chain.

Security Agencies Flag Hamas Attempt To Expand South Asian Network Through Regional Tie-Ups

New Delhi, 23/6: Indian security agencies are closely monitoring what they describe as a growing pattern in Hamas's efforts to expand its influence in South Asia. Intelligence inputs suggest that the Palestinian militant group is seeking to strengthen ties with extremist organisations across the region, particularly in Pakistan, Bangladesh, and Sri Lanka. Pakistan has, on several occasions, hosted senior Hamas leaders, who have reportedly been seen interacting with members of terror outfits such as Lashkar-e-Taiba (LeT) and Jaish-e-Mohammad (JeM). Security officials also point to similarities between the Pahalgam attack and the tactics used during Hamas's October 7 attack on Israel. While Hamas's links with Pakistan-based terror groups have long been viewed as an open secret by intelligence agencies, officials now say the outfit is attempting to widen its reach beyond Pakistan into Bangladesh and Sri Lanka. According to intelligence inputs, Hamas is seeking to establish a broader footprint in South Asia by forging connections with multiple extremist



organisations. Traditionally focused on Palestine and its conflict with Israel, the group is now believed to be pursuing a wider regional presence following its engagement with Pakistan-based networks. An Intelligence Bureau official said Hamas is unlikely to operate directly under its own banner in these countries. "It would work along with outfits such as the Lashkar-e-Taiba, Al-Qaeda in Bangladesh, Jamaat-ul-Mujahideen Bangladesh (JMB) and pro-Hamas groups in Sri Lanka," the official said. The broader objective,

officials believe, is to move beyond Gaza and create a support network across South Asia. By cultivating multiple partnerships, Hamas could significantly increase its regional reach and influence. Another official noted that Hamas may not necessarily participate directly in operational activities alongside these groups. Instead, the value of such alliances lies in expanding the organisation's influence, visibility and support infrastructure. The official added that these partnerships could also provide logistical advantages while helping Hamas raise funds

through networks established across South Asia. Security agencies assessed that such efforts could eventually extend into Nepal, Myanmar and the Maldives. "Hamas would not find it difficult to undertake these operations," another official said. According to the intelligence agencies, Pakistan's Inter-Services Intelligence (ISI) played a key role in facilitating Hamas' engagement with networks in the region. Officials allege that the Pakistani spy agency has encouraged Hamas leaders to visit various South Asian countries and cultivate alliances with local organisations. Such arrangements, officials believe, serve the ISI's interests by expanding its influence and strengthening connections among extremist groups operating across the region. An official said that the immediate concern is not necessarily the launch of coordinated terror operations. Rather, agencies are worried that a Hamas-linked network could significantly enhance recruitment efforts for multiple extremist organisations. "All these terror groups would also benefit from the Hamas branding. The alliance

partners of Hamas all have a common enemy in Israel, and hence this combination would work out best for all of them," the official said. Officials fear that recruitment could increase substantially if such alliances deepen. Security officials also warn that Hamas could contribute to radicalisation efforts through ideological outreach and support networks, further strengthening extremist groups in the region. Recently, Israeli Ambassador to India Reuven Azar, in an interview, said that Hamas-linked activities had been taking place in Pakistan and Bangladesh. He expressed concern that the organisation's influence could spread beyond the Middle East. Azar further stated that Hamas has been active in Pakistan and Bangladesh since the October 7 attacks on Israel. From India's perspective, officials say Hamas' efforts to build relationships with extremist groups in neighbouring countries remain a significant security concern. They warn that such networks could eventually seek to radicalise and recruit Indian youth, creating long-term challenges for regional security.

EAM Jaishankar Expresses Grief Over Qatar Explosion, Assures

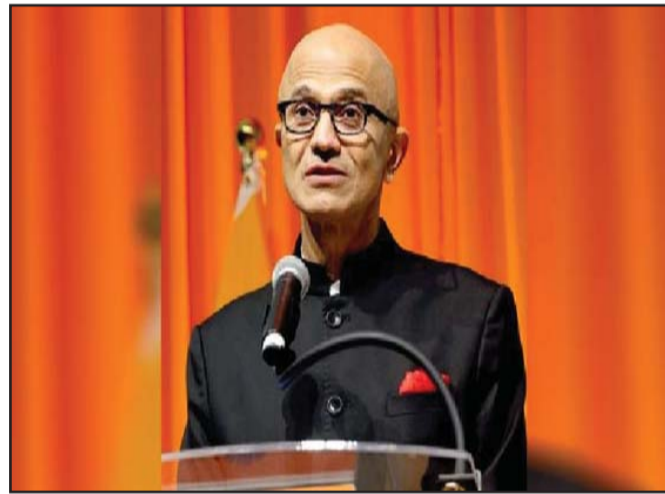
New Delhi, 23/6: External Affairs Minister S. Jaishankar on Tuesday expressed deep sorrow over the deaths and injuries caused by the explosion at Qatar's Ras Laffan Industrial City, including those involving Indian nationals. He assured that the Indian Embassy in Doha is in constant touch with Qatari authorities and is providing all necessary assistance to the families of affected Indian citizens. "Deeply saddened by the loss of lives and injuries, including of Indian nationals, in the explosion at Qatar's Ras Laffan Industrial City. As further details emerge, our embassy continues to be in touch with Qatari authorities, and is reaching out to render assistance to the families of Indian nationals affected by this tragedy. Our thoughts and prayers are with the victims and their families," EAM Jaishankar posted on X. Qatari authorities on Monday confirmed that 12 Indian nationals have died in the Ras Laffan incident on Sunday night, the Embassy of India in Qatar stated. "We extend our deepest condolences to the bereaved families and prayers for the departed souls. Qatari authorities have also confirmed that all those who got injured in the incident are in stable condition and are receiving appropriate medical treatment," the Indian Embassy posted on X. "Our embassy is working in close contact with the Qatari authorities to extend all possible help to the Indian nationals and their families affected by this incident, including ensuring that mortal remains of the deceased are sent to India at the earliest," it added. According to a statement by the Qatari Ministry of Interior, 13 people died, and 66 others were injured due to a technical malfunction during an operation at a factory in Ras Laffan Industrial City. The statement also noted that authorities are continuing their procedure to verify the circumstances of the incident to accurately determine its technical causes and take the necessary measures in accordance with the applicable legal and technical frameworks. It also highlighted that no leaks were detected resulting from the incident that would pose a threat to the safety of individuals or the surrounding environment. The Ministry also extended its condolences to the families of the deceased. In a statement on X, QatarEnergy said there was an operational incident during the startup of operations at Ras Laffan Industrial City, which resulted in an explosion and fire at the Barzan local gas supply facility in the evening hours of Sunday, June 21, 2026. Emergency response teams were deployed immediately to contain the fire, which is now under control.

Iran Talks Could Transform Middle East: Vance

Burgenstock, 23/6: US Vice President JD Vance said on Monday that negotiations with Iran had produced agreements on maritime security, regional ceasefire enforcement and nuclear inspections, describing the talks as the foundation for what could become a "truly transformed Middle East." Speaking to reporters before departing Emmen Air Base in Switzerland, Vance said the latest round of diplomacy had delivered tangible progress, even as both sides prepared for further technical negotiations in the days ahead. He stressed that the Trump administration would continue to judge Tehran by its actions rather than its promises. "This is laying a foundation for what could be a truly transformed Middle East," Vance said. "We haven't built the house yet, we're gonna have to keep on building." The Vice President said one of the most significant outcomes was the creation of a mechanism designed to keep shipping lanes open and ensure continued energy flows through the region. "The fundamental thing we got is number one, we set up the mechanism to ensure not only the straight support moves are open, but will stay open," he said. "We saw, we think, about 15 million barrels of oil come out. That's one of the reasons why oil is so low right now. Obviously, that means lower gas prices, and gas prices are going to keep coming down." Vance also highlighted what he described as a breakthrough on regional security. "We actually set up the right mechanism to ensure the regional ceasefire to manage the inevitable conflicts that will come up," he said. "We're working with our allies, from the Israelis to the Gulf Arabs, to make sure that sticks, and we feel very, very good about where that is." On the nuclear issue, Vance pointed to Iran's agreement to allow inspectors into the country. "We have the Iranians allowing weapons inspectors, nuclear inspectors into the country for the first time in a long time," he said. "We're obviously going to bolster those inspections, that inspection regime, to make sure they could never have a nuclear weapon." However, he cautioned that verification remained essential. "Whether good faith or bad faith, you can't trust anybody's worries; you have to trust what they actually do," Vance said.

Microsoft CEO Satya Nadella Warns Against AI Concentration

Washington, 23/6: Microsoft Chief Executive Satya Nadella has issued a sharp warning against the growing concentration of power in the artificial intelligence industry, arguing that a handful of companies should not dictate the future of a technology that is reshaping economies, workplaces and societies. In an exclusive interview with The Wall Street Journal, Nadella outlined a vision for the next phase of the AI boom that centres on lower-cost models, greater user control and broader access to the technology. "You can't say, hey, all white-collar jobs are gone and this could even be a weapon and we will use all the power to build data centres," Nadella said. He argued that the public would not accept a future in which only a small number of companies controlled the learning, deployment and benefits of AI. Instead, he called for an approach that wins public trust and earns



what he described as the industry's "social permission". The remarks place Nadella at the forefront of a growing debate over the direction of the AI race. While not naming specific rivals, he criticised a model in which a small group of firms capture most of the value from AI while simultaneously warning about safety risks, job

losses and the need for vast resources to continue scaling their systems. One of the most closely watched decisions facing Microsoft is whether to host DeepSeek, a Chinese AI company whose low-cost models have attracted global attention. Such a move could significantly expand the reach of the Chinese firm

while increasing pressure on major AI developers already facing the prospect of intensifying competition and lower prices. Nadella said the future of AI should be more democratic and less dependent on a small number of frontier model developers. He maintained that technological progress should focus on reorganising work rather than eliminating jobs. "No, how about we think about reorganizing the jobs?" he said when discussing the impact of AI on employment. He acknowledged that the transition would involve disruption but argued that businesses must develop practical pathways for workers to adapt. "Yes, it's a lot of change management, it's a lot of displacement, but there is a path," he said. Nadella described AI as a knowledge engine that helps organisations make better use of workers, data and technology. He envisioned

companies drawing from a range of models with different capabilities and price points rather than relying on a single provider. He also stressed that restoring public confidence would require more than messaging. "No amount of just narrative is going to do it because where we are now, we have to sort of walk the walk," he said. "We now have to do the hard work in earning the social permission." The comments come at a time when debate over AI's impact on employment, economic power and national competitiveness is intensifying across the United States and other major economies. Technology companies are investing hundreds of billions of dollars in AI infrastructure, data centres and advanced computing systems. Microsoft remains one of the most influential players in the sector through its partnerships and investments in leading AI companies.

California Wildfire Threat Intensifies As Crews Brace For Hotter, Drier Months

Los Angeles, 23/6: Even before California's traditional fire season reaches its peak, firefighters across the state have already responded to over 2,580 wildfires this year, as rising temperatures and increasingly dry vegetation heighten concerns over what officials now describe as a year-round fire threat. Several wildfires remained active on Monday, including blazes in Riverside, Kern and San Diego, while fire officials warned that hotter and drier conditions are likely to bring above-average fire activity in the months ahead. Xinhua news agency reported. The changing pattern has prompted California fire authorities to move away from the term "fire season," arguing that wildfire risk is no longer confined to late summer and autumn. "It does back up the need for us to utilize the term peak 'fire year' rather than the antiquated 'fire season' that we used to use," said David Acuna, a battalion chief of the California Department of



Forestry and Fire Protection (CAL FIRE). According to CAL FIRE, 2,584 wildfires have burned over 79,690 acres statewide so far this year, destroying 25 structures. No fatalities have been confirmed. Officials said a combination of prolonged drought, rising temperatures and increasingly dry vegetation has made the state more vulnerable to fast-moving fires. Heavy

vegetation growth from previous wet periods has also become fuel as plants dry out under hotter conditions. "We're looking at all the predictive models and they're saying it's going to be an above-average peak fire season," said Brent Pascua, another CAL FIRE battalion chief. Scientists say climate change is altering the timing and intensity of California wildfires. A study led by

researchers at the University of California, Los Angeles found that human-caused climate change advanced the start of the state's fire season by six to 46 days between 1992 and 2020. The study identified fuel aridity — the dryness of typical fire fuels like grasses and trees — as the strongest influence on when the fire season begins. "Climate change is fueling more extreme weather

and the kind of dangerous conditions that can turn a single spark into a catastrophe," California Governor Gavin Newsom said in a recent proclamation marking Wildfire Preparedness Week. He warned that there is "no off-season for wildfire." Newsom's office said California has nearly doubled CAL FIRE's budget since 2019, expanded firefighting personnel and built what it described as the "world's largest aerial firefighting fleet." Fire officials are urging residents to prepare before conditions worsen. Recommendations include creating defensible space around homes, strengthening structures with fire-resistant materials, assembling emergency kits and signing up for local emergency alerts. "Drier than average conditions across the state mean more fuel for potential wildfires," CAL FIRE Director Joe Tyler said. "CAL FIRE and our emergency response partners across California are ready for wildfire — now it's your turn."

Indian Americans Take Priorities To Capitol Hill

Washington, 23/6: Nearly 200 Indian American delegates from 25 states are set to meet lawmakers and Congressional staff across the Capitol Hill on Tuesday as part of a major advocacy effort focused on strengthening the US-India partnership, advancing immigration reform and bolstering Indo-Pacific security. The initiative, organised by the Foundation for India and Indian Diaspora Studies (FIIDS), is expected to bring delegates to more than 125 elected offices during its fourth annual Capitol Hill Day. The meetings will focus on issues ranging from trade and security cooperation with India to critical minerals supply chains and the role of Indian Americans in the United States' economy, it said. "This is a moment to translate influence into policy impact," said Khanderao Kand, FIIDS Chief of Policy and Strategy. "Indian Americans contribute across technology, research, academia, hospitality, health care, small business, and agriculture, and our community is engaged in ensuring that Congress understands the issues that matter most to America's future," he added. FIIDS said delegates will advocate on five major policy areas: Indo-Pacific trade and security, the US-India strategic partnership, Indian American contributions and concerns, immigration reform for US innovation, and critical minerals supply-chain security. According to the organisation, the agenda reflects both the growing influence of Indian Americans in public life and broader concerns about US competitiveness, national security and democratic resilience. The advocacy meetings will be followed by the US-India Partnership Summit later on Tuesday. The event is expected to bring together diplomats, elected officials and policy leaders to discuss the future of bilateral cooperation. FIIDS said speakers are scheduled to include Deputy Assistant Secretary of State Bethany Morrison, Deputy Chief of Mission Ambassador Mangya Khampa and other diplomats, elected officials and leaders focused on strengthening US-India ties. The organisation's policy platform calls for greater Indo-Pacific resilience, stronger defence and technology cooperation between Washington and New Delhi, recognition of Indian American contributions, reforms to high-skilled immigration programmes and a long-term strategy for securing critical minerals supply chains.

India Needs Quantum Jump Into Manufacturing High-Value Pharma Products: Economists

New Delhi, 23/6: India, which is one of the world's largest suppliers of generic medicines and a major provider of vaccines and essential drugs, needs to make a quantum jump into manufacturing high-value pharmaceuticals and Active Pharmaceutical Ingredients (API), and there has to be strong Production Linked Incentive (PLI) schemes to achieve this, economists said on Tuesday. Commenting on the NITI Aayog report on pharmaceutical trade that came out on Tuesday, economist Ved Jain told IANS that the time is ripe to make a jump into exporting high-value pharmaceutical products. "We should invest in research innovation on basic drugs and facilities and for that, and I believe there has to be a strong PLI scheme for valued products, like high basic drugs and API products," he mentioned. According to the NITI



Aayog report, India's comparative advantage remains concentrated in formulations, particularly retail medicaments and generic drugs, where it remains highly competitive even in regulated markets such as the

United States and Europe. Jain said that we need to further remove regulatory barriers, ramp up production and, at the same time, increase the production of high-value pharmaceutical products which can be

exported. Various free trade agreements (FTAs) India has signed would definitely help in this direction once certain regulatory restrictions are addressed, he noted. The PLI Scheme for pharmaceuticals

supports the manufacturing of high-value products like biopharmaceuticals, complex generics, patented/off-patent drugs, orphan, and autoimmune drugs. It generated a total sale of Rs 3,08,408.60 crore, including Rs 1,98,509.49 crore in exports, since inception till September 2025. Further, investment worth Rs 40,294 crore has also been made under the scheme till September 2025. The amount significantly exceeded the targeted investment of Rs 17,275 crore. The PLI scheme for the promotion of domestic manufacturing also helped reduce the import dependence for bulk drugs. Meanwhile, the global pharmaceutical landscape has increasingly shifted towards high-value segments such as biologics, vaccines, immunologicals, and advanced therapeutics, where India's export presence remains limited.

Sensex, Nifty Open Subdued Amid Easing West Asia Tensions

Mumbai: Indian equity markets opened on a flat note on Tuesday after a multi-session rally driven by easing tensions in West Asia. Sensex opened at 77,086.05, down 8 points or 0.01 per cent, while Nifty started the session at 24,071.30, lower by 31.60 points or 0.13 per cent.

Sector-wise, Nifty Pharma was top gainer, rising 0.41 per cent, followed by Nifty MidSmall Healthcare (up 0.40 per cent), Nifty 500 Healthcare and Nifty Media, both gaining 0.29 per cent. While Nifty Cement and Nifty Oil & Gas also advanced 0.27 per cent and 0.18 per cent, respectively. In contrast, Nifty Metal was the worst-performing sector, declining 0.8 per cent, followed by Nifty IT, which fell 0.77 per cent. Among Nifty 50 constituents, Infosys, Hindalco Industries, TCS, HCLTech, Tech Mahindra, Tata Steel and Wipro were the top losers in early trade. The broader market remained resilient, with smallcap and midcap indices outperforming the benchmarks. Nifty Smallcap 50 rose 0.34 per cent, while Nifty Smallcap 250 and Nifty Smallcap 500 gained 0.33 per cent and 0.28 per cent, respectively. Meanwhile, India VIX — the market's fear gauge — declined 0.7 per cent to 12.75. According to market experts, easing tensions in West Asia and the sharp correction in Brent crude prices below \$80 per barrel have improved the outlook for India's GDP growth and corporate earnings in FY27. They noted that stability in the rupee and a moderation in foreign portfolio investor (FPI) selling remain key positives for equities.

Markets Tumble Over 1 PC As Metal, IT Stocks Trigger Broad Sell-Off

Mumbai, 23/6: Domestic equity benchmarks ended sharply lower on Tuesday, dragged down by heavy selling in metal, information technology and public sector banking stocks amid weak global market cues. The Sensex declined 893.39 points, or 1.16 per cent, to settle at 76,200.68, while the Nifty fell 278.80 points, or 1.16 per cent, to close at 23,824.10. Investor sentiment remained subdued as weakness in global equity markets weighed on domestic equities, prompting broad-based selling across key sectors. Market participants largely remained cautious amid concerns over global growth and persistent uncertainty in international markets. Among the major laggards on the Nifty index were Infosys, JSW Steel and Tata Consultancy Services, which witnessed significant selling pressure during the session. The weakness extended to the broader market as well. The



Nifty MidCap index ended 1.05 per cent lower, while the Nifty SmallCap index slipped 0.48 per cent. Sectorally, metal stocks emerged as the biggest losers, with the Nifty Metal index plunging more than 3 per cent. The Nifty IT and PSU Bank indices also underperformed amid continued weakness in technology and banking shares. Moreover, the technology index declined more than 2 per cent amid a global sell-off,

with all constituents ending in the red, declining up to 3 per cent. However, defensive sectors offered some support to the market. The Nifty Pharma and Nifty Healthcare indices outperformed the broader market, attracting investor interest amid heightened volatility. According to experts, market sentiment weakened as early gains proved unsustainable amid negative global cues and prevailing caution.

India Needs 7-8 PC Growth To Become Viksit Bharat By 2047: EAC-PM Chairman

New Delhi, 23/6: India needs 7 to 8 per cent growth to become Viksit Bharat by 2047, which needs more investment from the private sector as well as strong export growth, Mahendra Dev, Chairman of the Economic Advisory Council to the Prime Minister (EAC-PM), said on Tuesday. Speaking to reporters on the sidelines of a FICCI India event here, he said that "private sector investment is equally important and also export growth important. Prime Minister Narendra Modi has mentioned about 'Atmanirbhar Bharat', that is equally important". Dev further said that structural reforms implemented over the last few years laid the groundwork for this trajectory. India's GDP growth was estimated at a robust 7.8 per cent in the January-March quarter (Q4) of 2025-26, as result of which the growth rate for the full



financial year works out to 7.7 per cent on the back of a strong performance of the agriculture, construction, and services sectors, according to latest data released by the Ministry of Statistics. The secondary sector recorded a strong 8.8 per cent growth while the tertiary sector grew by 9.9 per

cent, according to the official statement. The primary sector recorded a 3.2 per cent growth, mainly driven by the performance of the agriculture and fisheries sectors. Manufacturing, trade, repair, hotels, transport, communications and services related to broadcasting, storage,

financial, real estate, and professional services sectors have attained double-digit growth during 2025-26, the official statement said. This reflects the massive investments by the government in big-ticket infrastructure projects, such as highways, railways, ports and airports, which have helped to drive up the growth rate as India continues to be the fastest-growing economy amid the global slowdown. Dev said he is glad that FICCI is organising this important innovative crop nutrition conclave, and inviting all the stakeholders, including the farmers, on a common platform. "I'm also happy to know that they have a task force on innovative crop nutrition. As you know, the future of plant nutrition will be a collaborative effort between farmers, industry, and the government," he mentioned.

RBI Injects Rs 1.41 Lakh Crore Into Banking System

Mumbai, 23/6: The Reserve Bank of India (RBI) on Tuesday pumped in over Rs 1.41 lakh crore transient liquidity into the banking system through a seven-day variable rate repo (VRR) auction. The funds were injected into the system at a cut-off rate and weighted average rate of 5.26 per cent, according to figures released by the RBI. This was done after the liquidity in the banking system turned into a deficit of Rs 19,971.89 crore as on June 22, from a surplus of Rs 30,685.11 crore as on June 21. Analysts said that the outflow of money from banks due to goods and services tax (GST) payments had led to the tightening of liquidity in the system. The decline in liquidity had brought overnight money market rates under pressure, with the weighted average call money rate trading at 5.43 per cent, which is 0.18 per cent above the RBI's repo rate. If banking liquidity tightens excessively due to events like Goods and Services Tax (GST) outflows, short-term money market rates (such as the weighted average call money rate) can push above the RBI's standard repo rate. By



stepping in with liquidity injections, the RBI ensures that short-term funding pressures ease and credit continues to flow smoothly across the financial system without triggering economic slowdowns. The RBI routinely injects transient and durable liquidity into the banking system to manage short-term deficits caused by tax outflows, advance tax payments, or seasonal credit demand. The central bank achieves this through various

monetary tools and market operations. The apex bank frequently conducts VRR auctions, including 3-day or 7-day tenors, to infuse substantial transient liquidity into the banking system. Banks pledge eligible government securities to borrow funds directly from the central bank, providing immediate relief when liquidity slips into deficit. To inject durable liquidity into the system, the RBI purchases government securities from the secondary

market. This permanently adds cash into the banking system, allowing banks to easily meet their Cash Reserve Ratio (CRR) requirements. The central bank can execute USD-INR swap auctions. For example, the RBI might temporarily buy US dollars from commercial banks in exchange for rupees, directly increasing the rupee supply in the money market and preventing overnight interest rates from spiking.

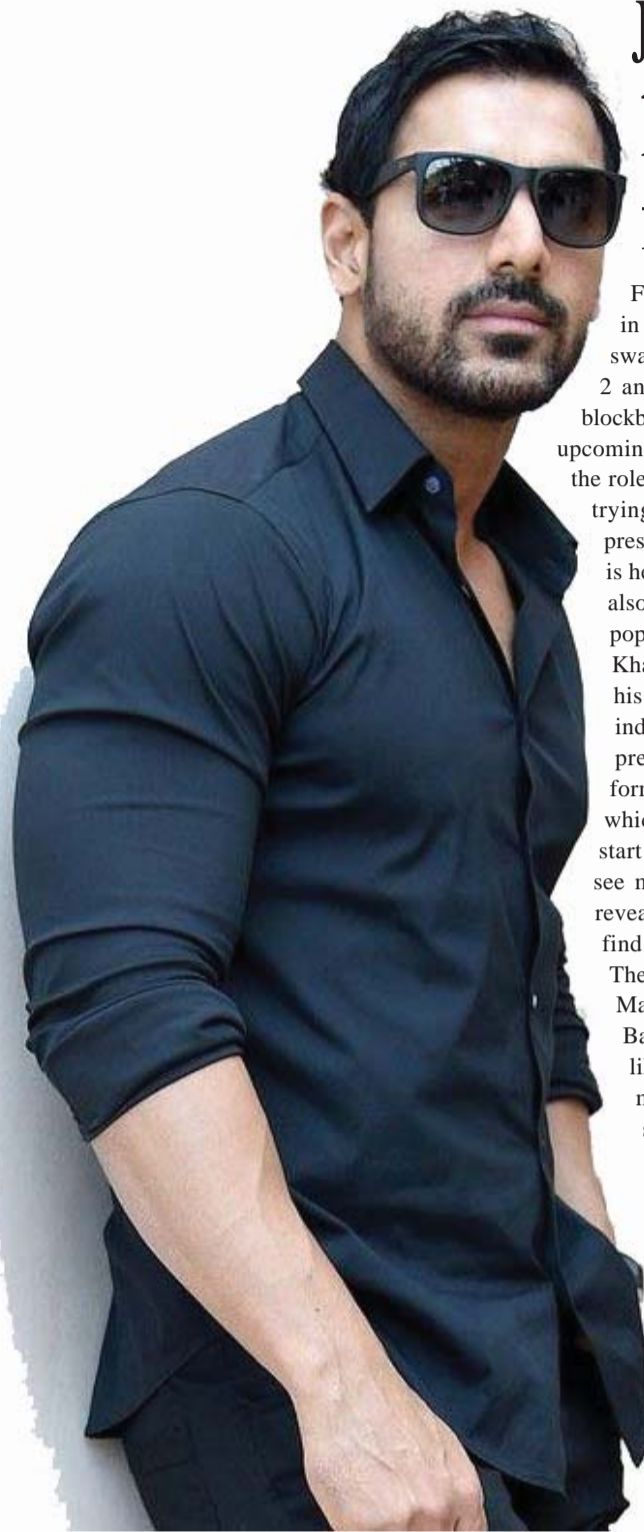

Women's T20 WC: Devine, Tahuu Back As NZ Elect To Bowl Against Scotland In Must-Win Clash

Bristol, 23/6: New Zealand won the toss and elected to field against Scotland in what is a virtual knockout group game of the ICC Women's T20 World Cup here at the County Ground. The pressure could hardly be greater as the two sides lock horns in a contest that has all the makings of an early exit. With both sides needing a victory to keep their Women's T20 World Cup dreams alive, there is little room for error from here on. A defeat would spell the end of the road for either team, adding extra significance to every passage of play. While New Zealand entered the tournament as defending champions and one of the favourites, their campaign has never truly gathered momentum. Consecutive defeats after posting competitive totals left them with plenty of ground to make up, and even their first win of the tournament came only after surviving a late scare against Ireland. Questions remain over both departments: the batting has lacked a defining innings, while the bowling unit has struggled



to make regular breakthroughs, leaving them with the fewest wickets among all teams in the competition. Scotland, meanwhile, have shown enough to suggest they are capable of causing problems. After opening their account against Ireland, they pushed the West Indies deep before falling narrowly short and were tested by England in their last outing. Their top-order has consistently offered resistance, though sharper work in the field will be essential if they are to challenge a side desperate to stay in contention. Interestingly, these teams have never faced each other in this format before. Rankings may favour New Zealand, but with survival at stake,

reputations count for little in what promises to be a high-pressure encounter. Winning the toss, New Zealand skipper Amelia Kerr said, "We don't really have a reason to bowl, but apart from, yeah, it being a morning game, sometimes in England it does a little bit more earlier and also we know that run rate's gonna potentially play a part in our campaign, and I think the best way to do that is try keep them to a low total and then try chase it down quickly. I think we were better and it was nice to get a win and it was pleasing, I guess, how we turned it around in the field. There were some crucial moments there in the field that I think also won us the game.

But I think with this group, I think someone's got to step up with the bat and click on and if you get a start, make it a big one. Yeah, fresh start, change of venue. I think one is we work really hard on our fielding. Craig McMillan leads us so well in the fielding front and he really challenges us as well. So you see us in trainings and we're taking catches and doing some pretty spectacular things. And unfortunately, we just had a couple of bad days. Soph (Sophie Devine) comes back into the side and Georgia Plimmer misses out and Rocco's (Mair) got a minor rib injury, so Lea Tahuu comes in." Meanwhile, Scotland captain Kathryn Bryce said, "I think we've been really good at setting totals in the recent period, so yeah, looking forward to getting in there and having a bat. Yeah, absolutely. I think we've played some really good cricket against some good opposition in the last couple of games and just a couple of periods that have probably let us down a little bit. So I think we're trending in a really good direction and playing cricket that I think is good enough to win games.

2026 FIFA WC: Record-Breaking Messi Helps Argentina Reach Knockouts With 2-0 Win Over Austria

Dallas: Lionel Messi produced another magical display and nailed a few records, scoring a brace to help defending champions Argentina beat Austria 2-0 in a Group J match and advance to the knock-out stages of the FIFA World Cup 2026 at the Dallas Stadium in Dallas on Monday. Messi made

it to the record books by scoring his 17th and 18th goals in World Cups, setting the record for most individual goals in the history of the tournament. Two days before his 39th birthday, the Argentine talisman brushed aside missing a penalty early in the first half, to give his team the lead in the 38th minute and then doubled it seconds before

the end of the match to seal a memorable victory for the defending champions. With their second Group J win, Argentina secured their progress to the last 32. If Jordan fail to beat Algeria later in the day, they will be confirmed as group winners. The day belonged to Messi as he scored his first goal of the day in the 38th minute, setting the record for most individual

goals by any player in the tournament's history. This was Messi's 17th goal in the FIFA World Cup and also his fourth in the 2026 edition. Messi not only broke the tournament's scoring record, but he also joined Just Fontaine of France and Jairzinho of Brazil as the third man to score in six successive World Cup games.
